BANK DEBITS

Debits to individual accounts as reported to the Federal Reserve Board by banks in leading cities totaled \$9,630,000,000 or 6.4 per cent under the total of \$10,294,000,000 reported for the preceding week. All the more important centers report decreases. New York City reports a decrease of \$210,000,000, Chicago - a decrease of \$57,000,000, Philadelphia - a decrease of \$51,000,000 and San Francisco and Los Angeles - decreases of \$33,000,000 each.

As compared with the corresponding week in 1923, debits for the week under review show an increase of \$828,000,000 or 9.6 per cent. New York City reports an increase of \$666,000,000, Boston - of \$63,000,000, Chicago - of \$28,000,000, and Minneapolis - of \$20,000,000.

Aggregate debits for 141 centers for which figures have been published weekly since January, 1919, were \$9,090,307,000 as compared with \$9,696,249,000 for the preceding week and \$8,270,807,000 for the week ending September 26, 1923.

Debits to individual accounts were report to the Federal Reserve Board for banks in 251 centers, of which 243 are included in the summary by Federal reserve districts.
