For your information in connection with your consideration of the preliminary plans submitted by the Architect for the proposed Addition on the north side of "C" Street there is attached a folder containing photographs, on greatly reduced scale, of these drawings. I have in my office sets of the large drawings from which these photographs were made.

I wish to call your attention particularly to the fact that the last three drawings in this folder are alternate plans for the first, the fifth and the sixth floors, which the Architect has submitted as substitutes for the plans for these floors in the earlier part of the folder. The alternate plans for the first and sixth floors contain only minor changes which are incidental to the major change that would be involved in the fifth floor plan.

The alternate plan for the fifth floor was submitted by the Architect as the result of suggestions made by Mr. McKee at the meeting at which the earlier plans were laid before the Board. Special consideration should be given to the question what should be done with the fifth floor plan if the work is to be continued.
