Dear Mr. Caldwell:

I wish it were possible for me, as you request in your letter of December 13, to be of assistance to Mr. and Mrs. Mehornay in getting an apartment at the Shoreham Hotel. However, there is not a thing I can do and in view of the circumstances, as I understand them, I am not at all surprised that they have been unable to get an apartment there.

I have lived at the Shoreham for over five years and I have been attempting, without success, for several months to get a larger apartment than the one I now have. Mr. Moore, the manager of the hotel, has done everything he can to get me relocated, but as the hotel is completely occupied with no prospect of any vacancies, he has been unable to do anything for me. He advised me that they have a long waiting list, among which is Secretary of the Navy Knox, who has been trying to get an apartment at the Shoreham ever since coming to Washington last summer.
