JOINT RESOLUTION [S.J. Res. 55]

To print the monthly publication entitled "Economic Indicators"

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the Joint Economic Committee be authorized to issue a monthly publication entitled "Economic Indicators," and that a sufficient quantity be printed to furnish one copy to each Member of Congress; the Secretary and the Sergeant at Arms of the Senate; the Clerk, Sergeant at Arms, and Doorkeeper of the House of Representatives; two copies to the libraries of the Senate and House, and the Congressional Library; seven hundred copies to the Joint Economic Committee; and the required numbers of copies to the Superintendent of Documents for distribution to depository libraries; and that the Superintendent of Documents be authorized to have copies printed for sale to the public.

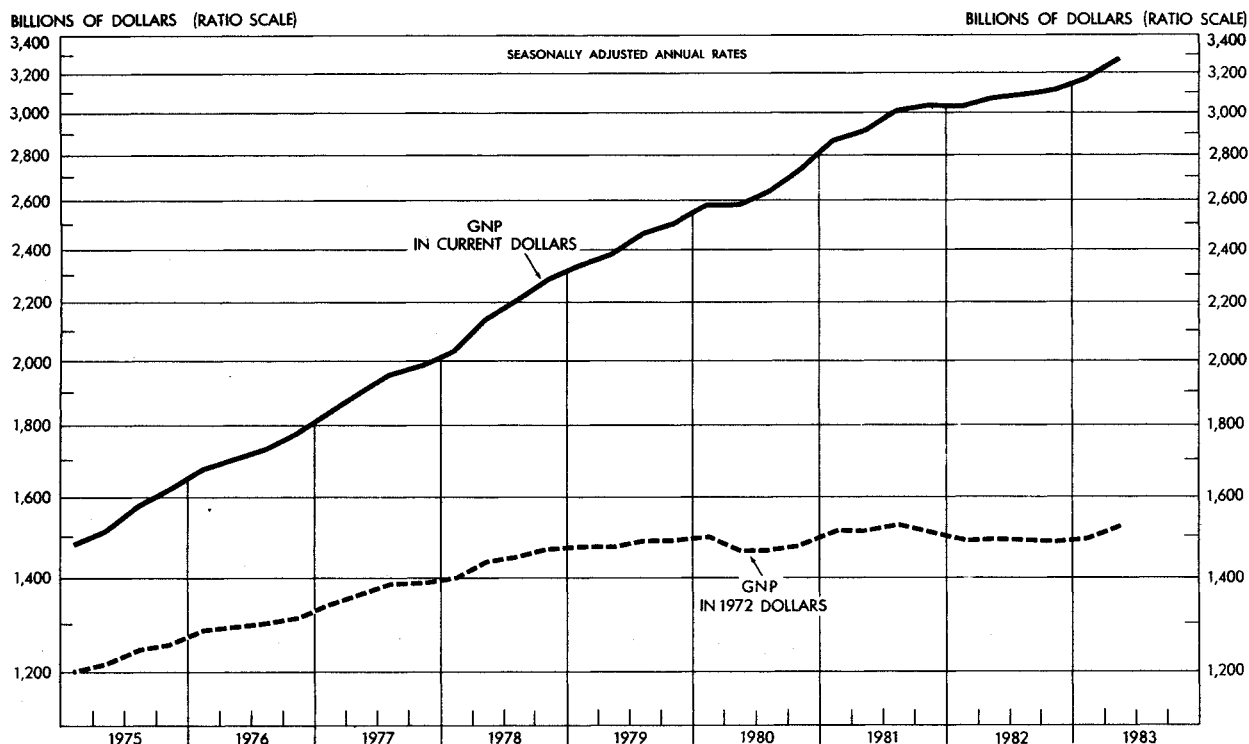

TOTAL OUTPUT, INCOME, AND SPENDING

GROSS NATIONAL PRODUCT

According to revised estimates for the second quarter of 1983, gross national product rose \$100.5 billion or 13.3 percent, both at annual rates. Real output (GNP adjusted for price changes) rose 9.7 percent (annual rate) and the implicit price deflator rose at a 3.3 percent annual rate.

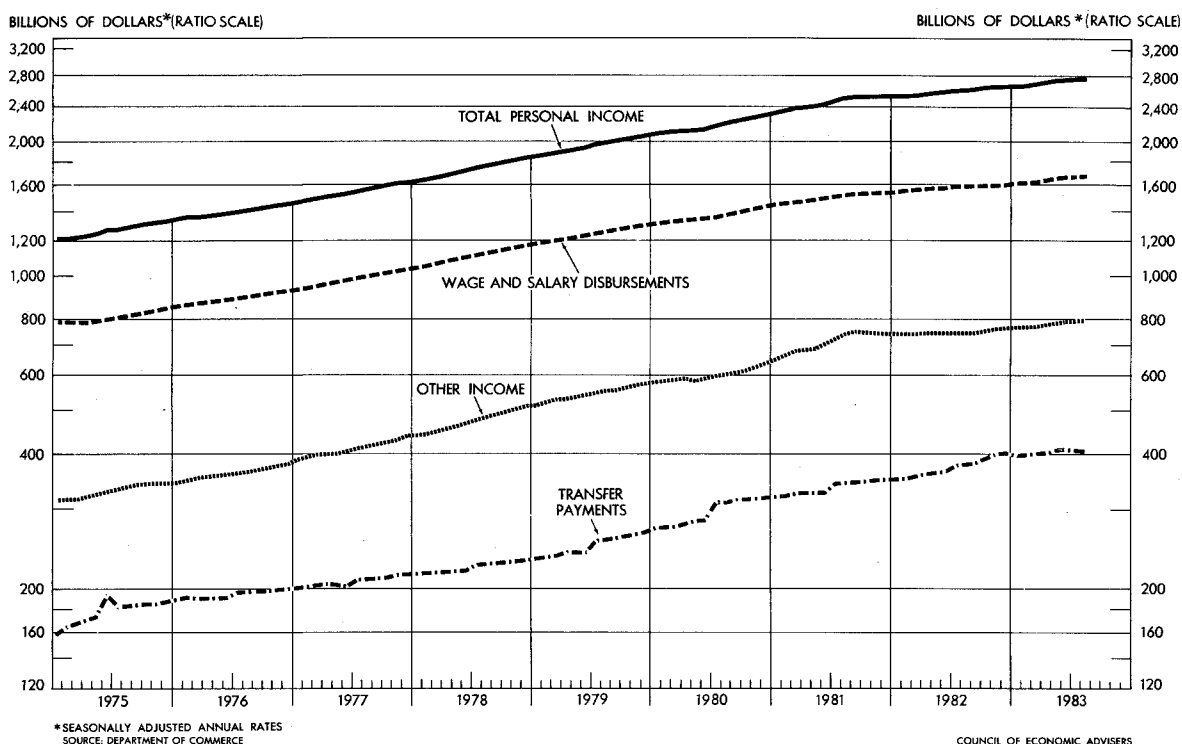

SOURCES OF PERSONAL INCOME

Personal income increased \$6.5 billion (annual rate) in August following a rise of \$16.0 billion in July. Personal income in August was affected by three special factors—the telephone strike, special payments to Postal Service employees, and hurricane damage. Without these special factors, personal income would have increased by about \$14 billion in August.

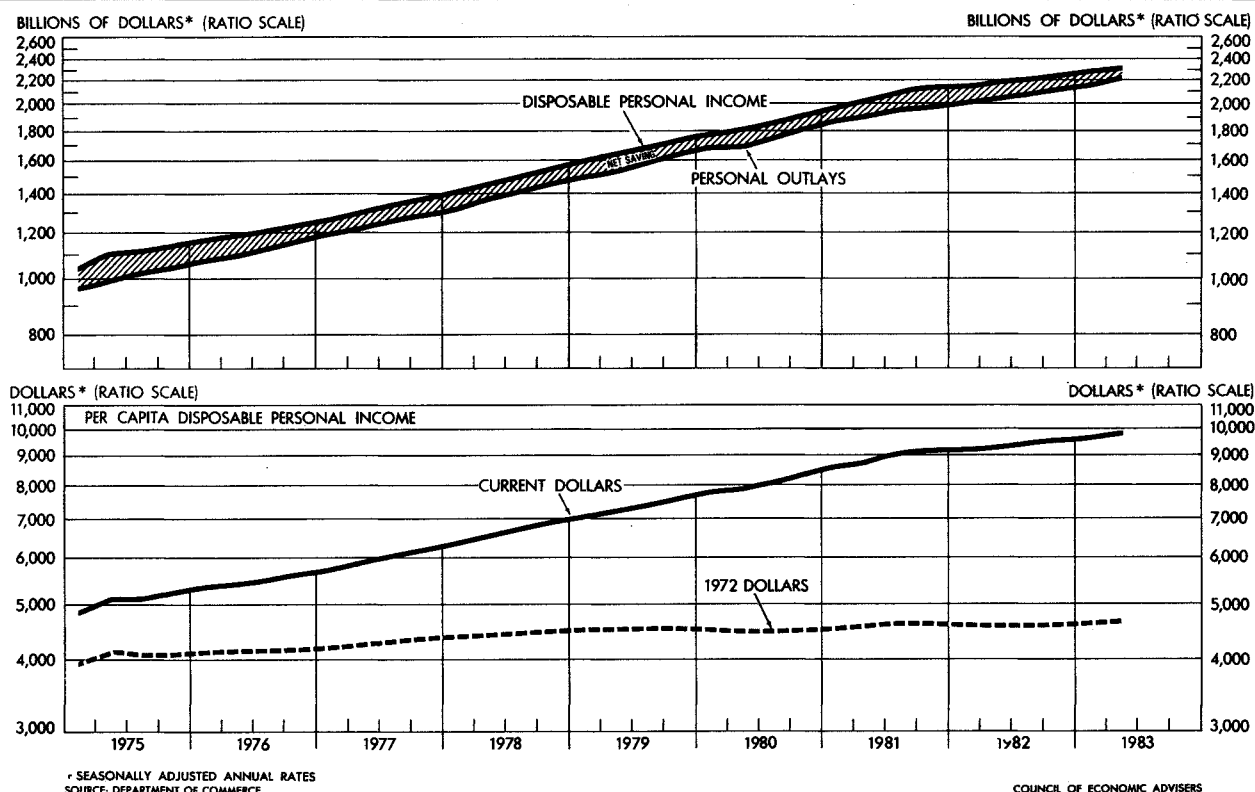

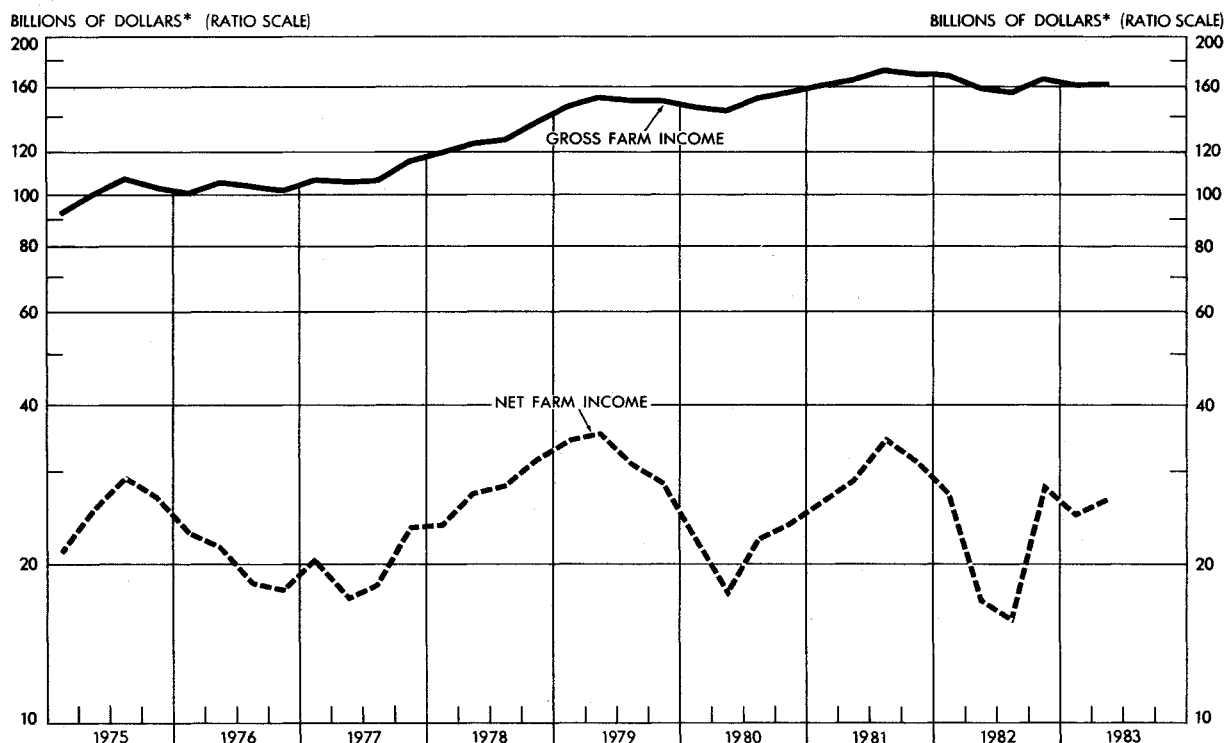

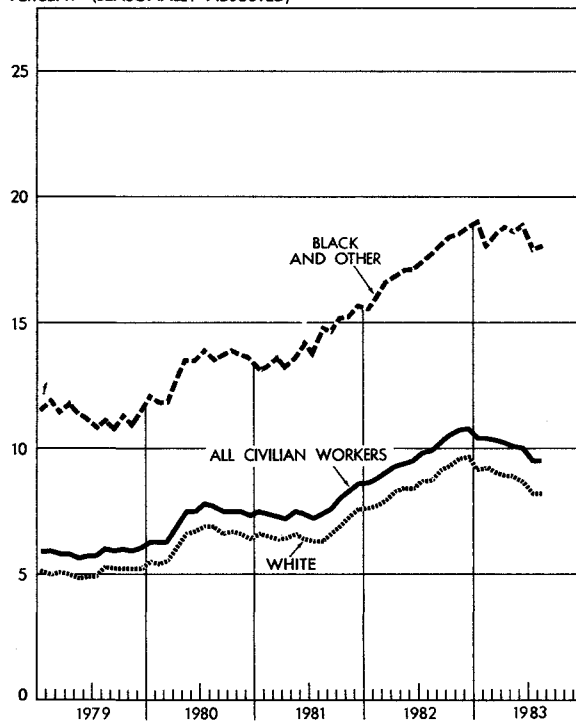

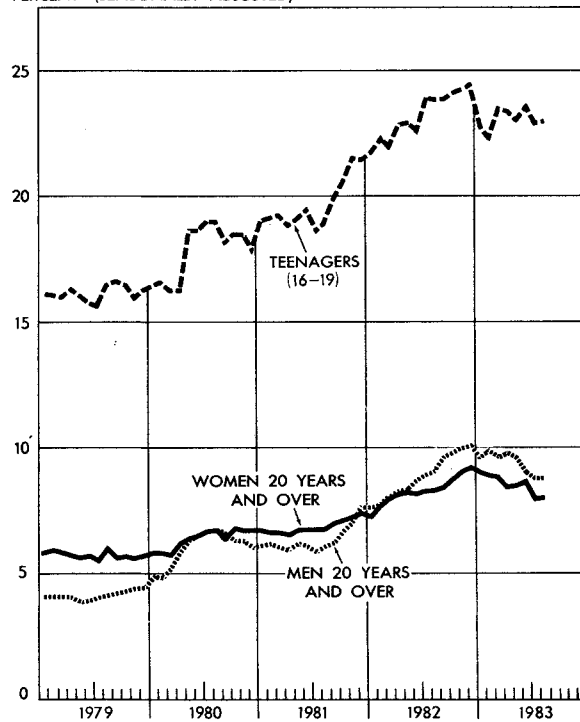

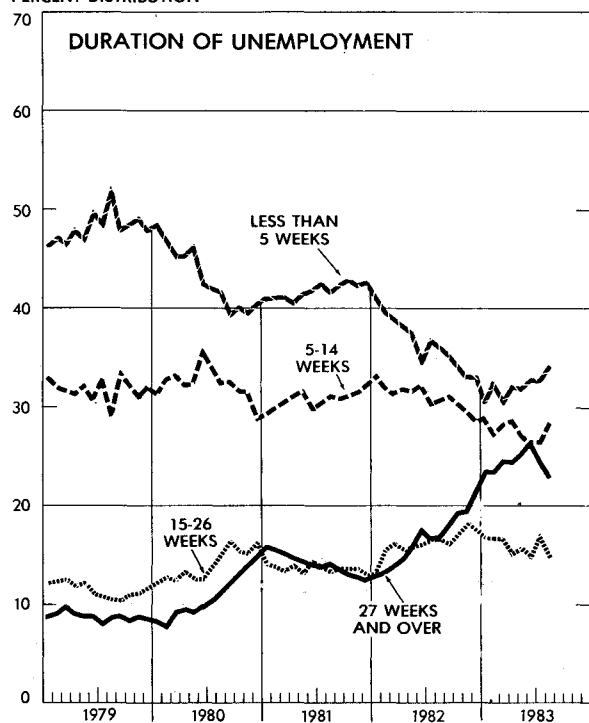

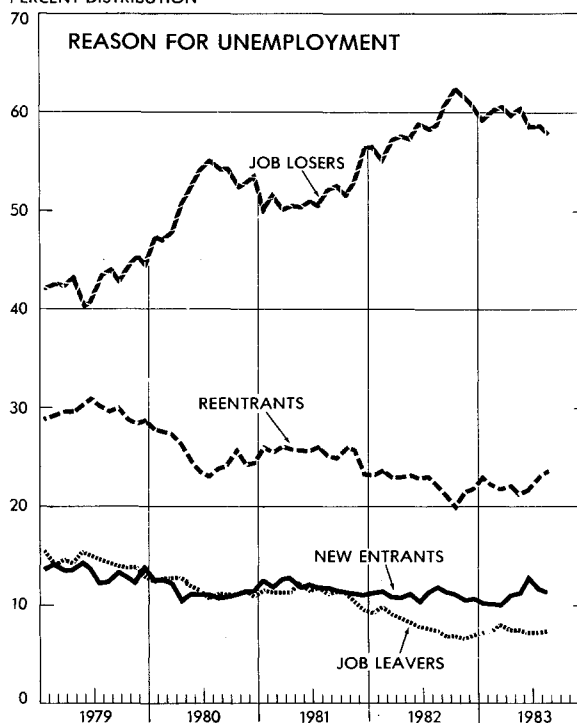

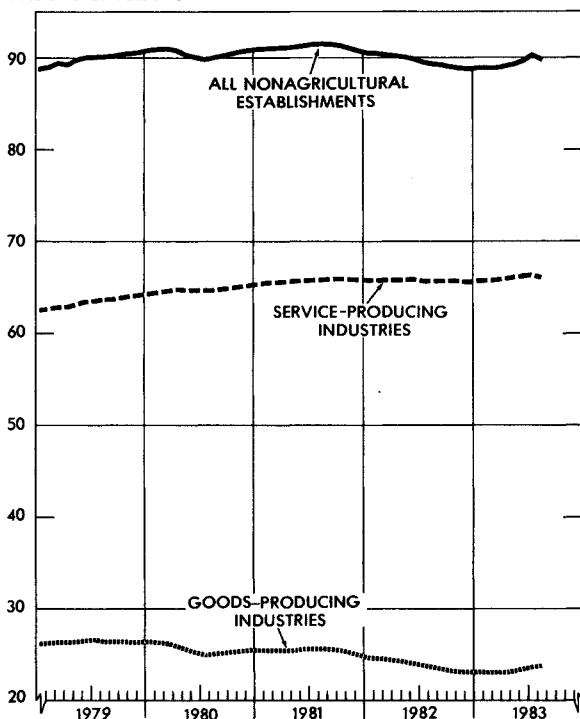

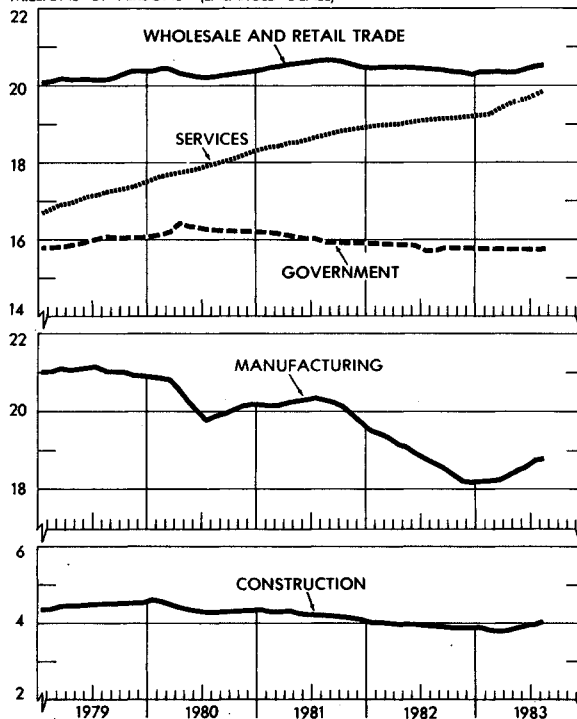

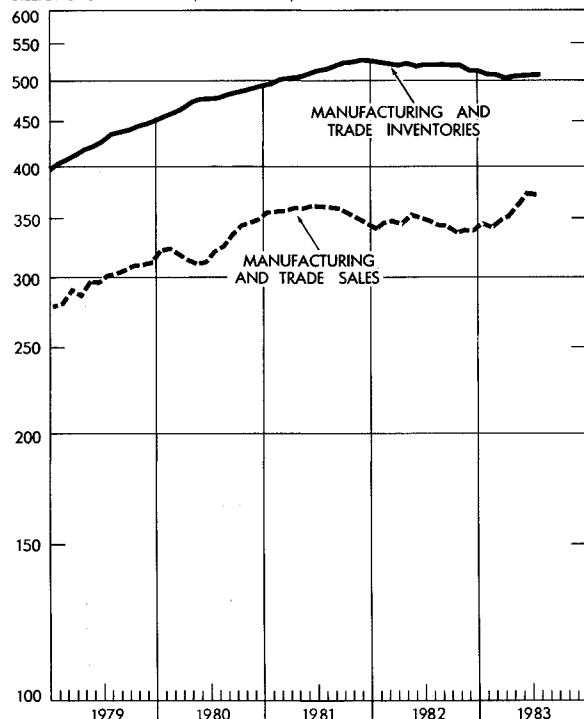

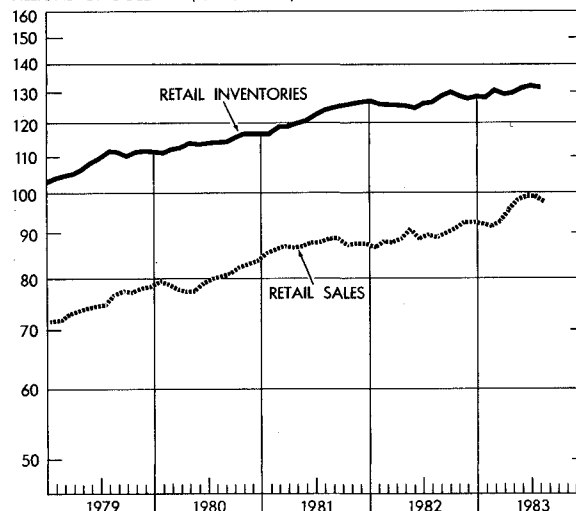

BILLIONS OF DOLLARS* (RATIO SCALE)

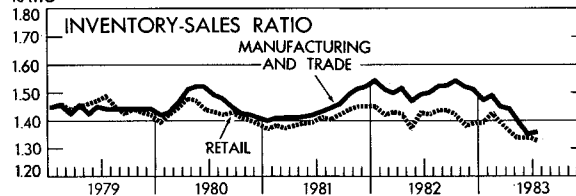

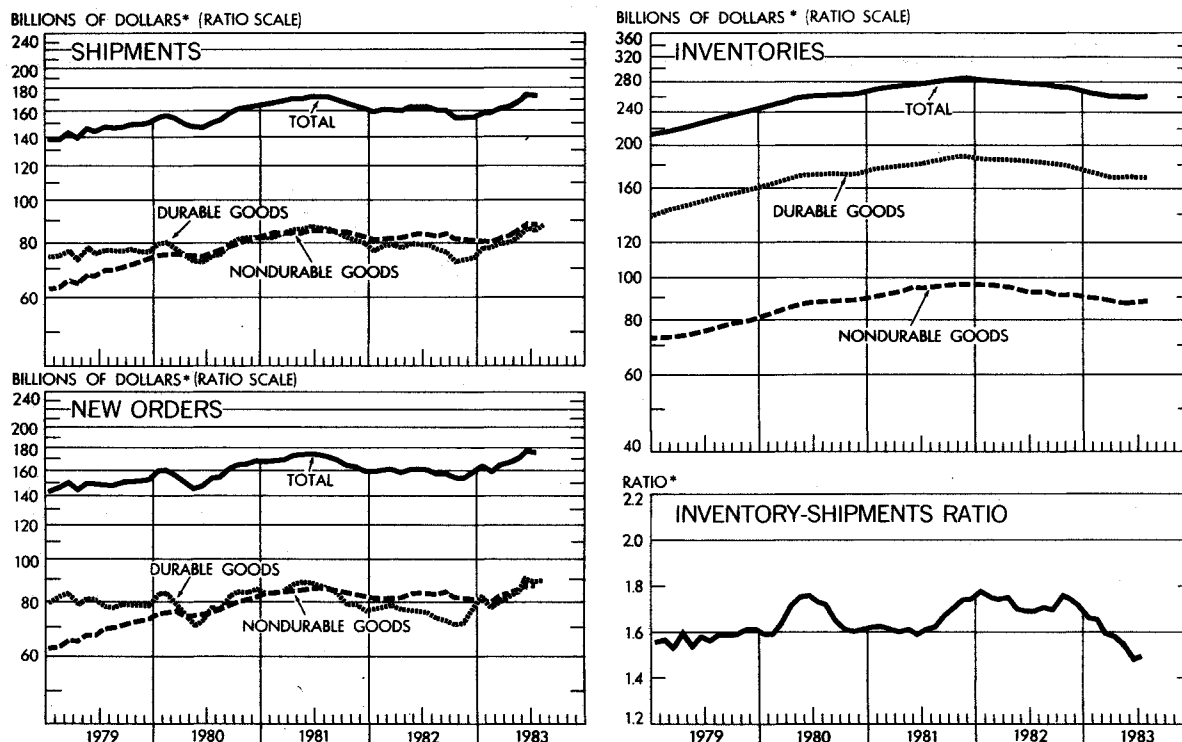

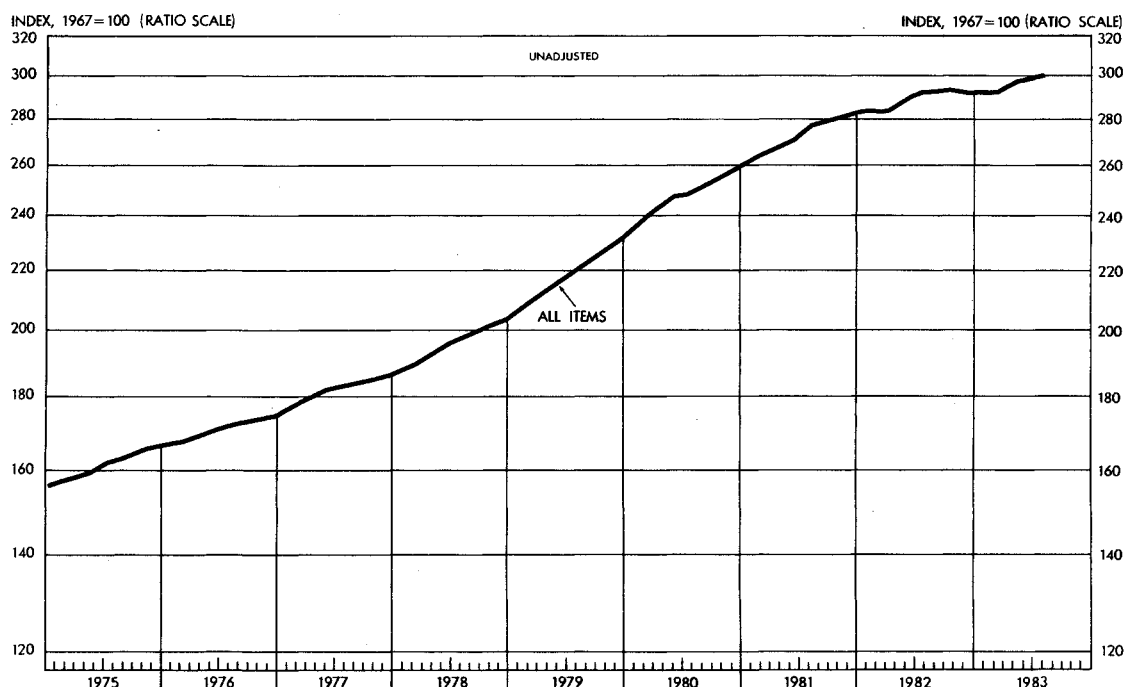

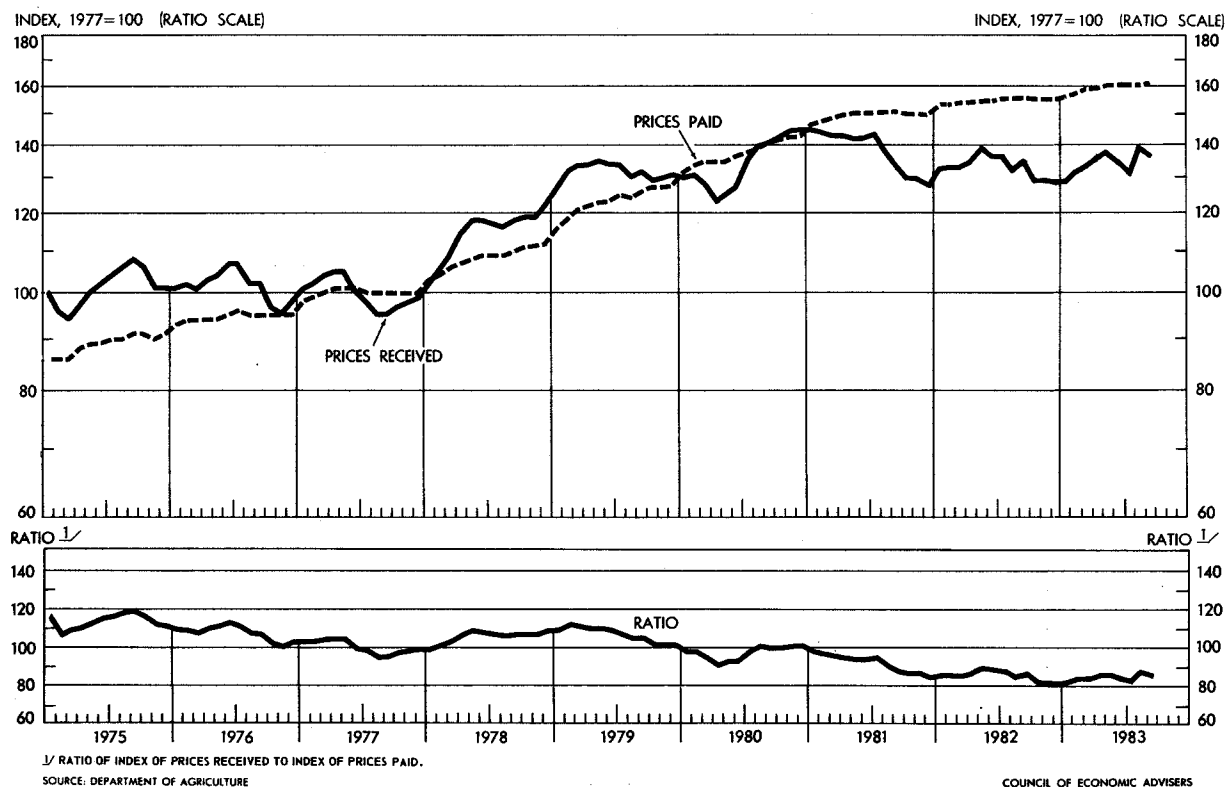

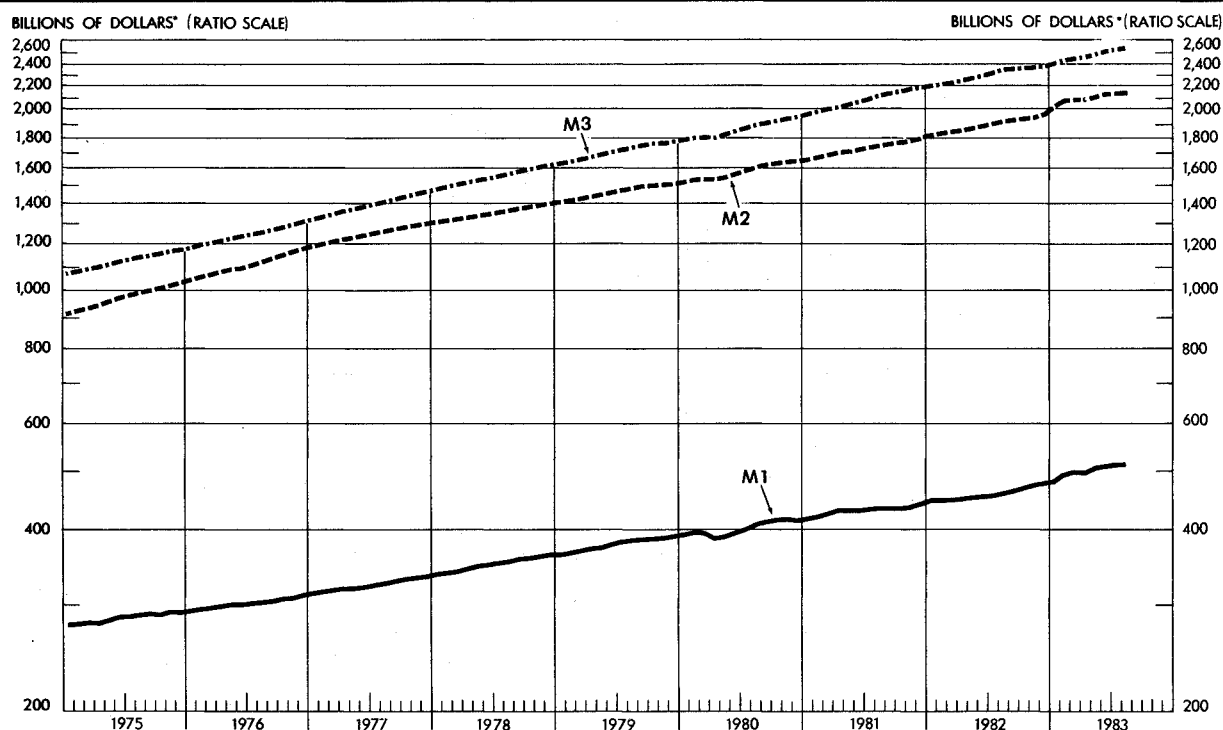

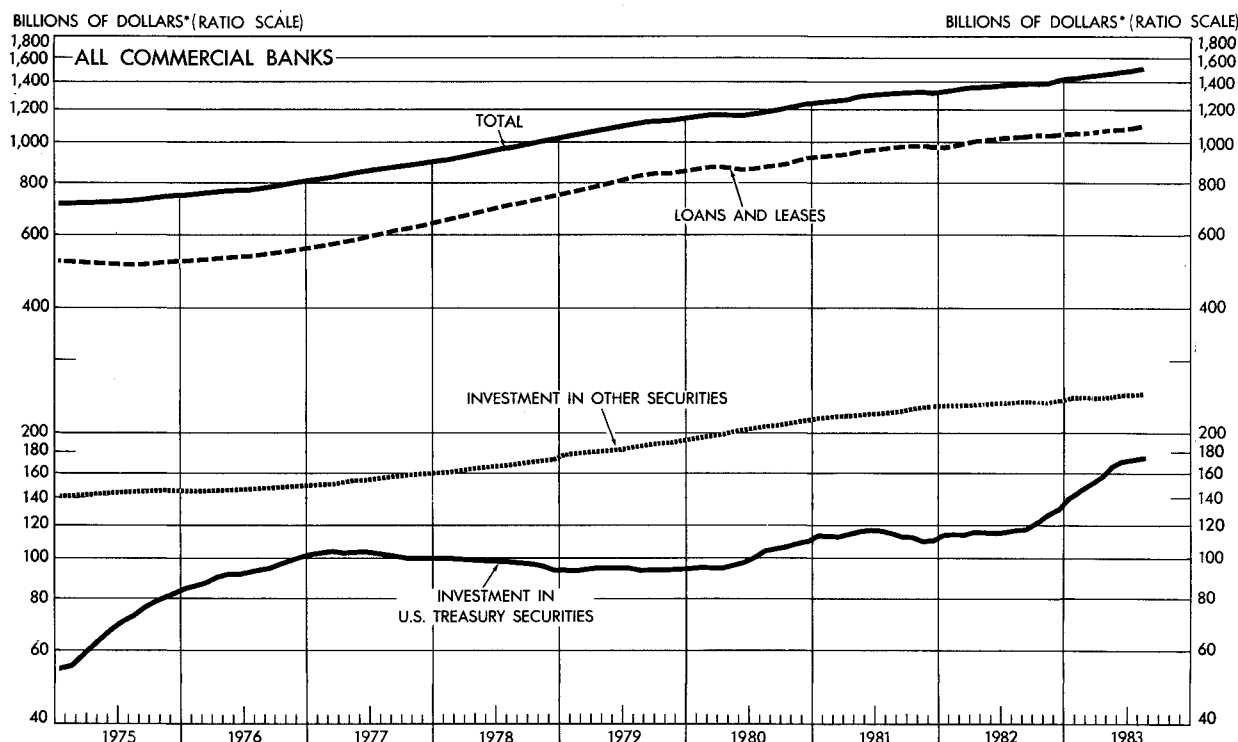

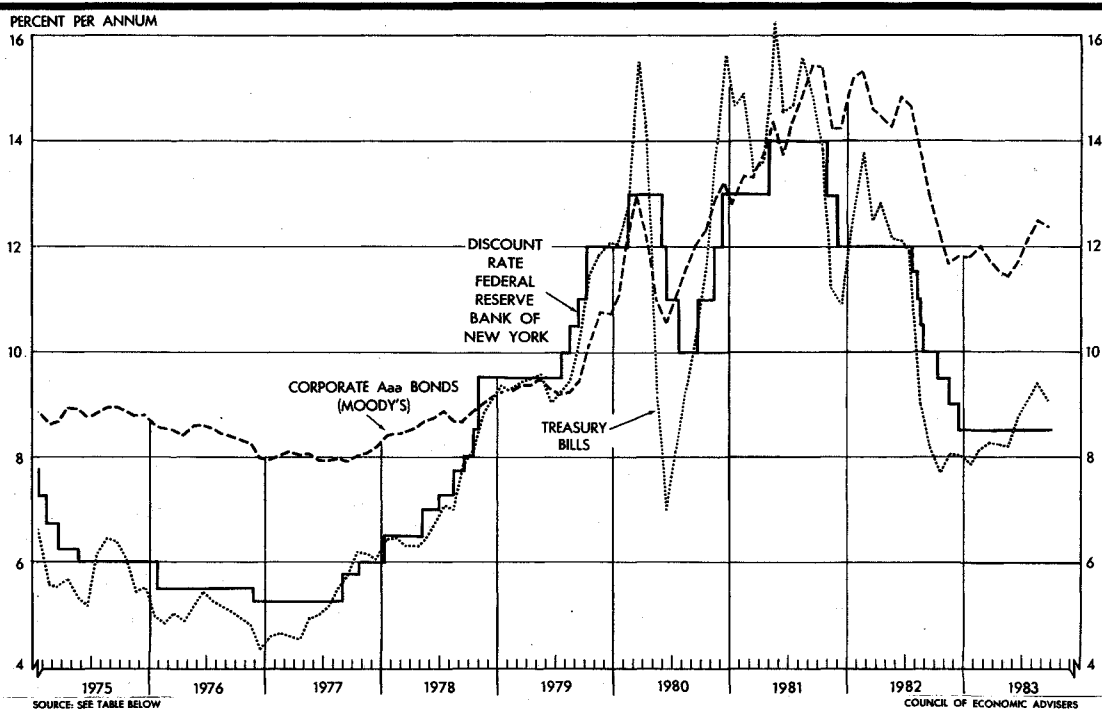

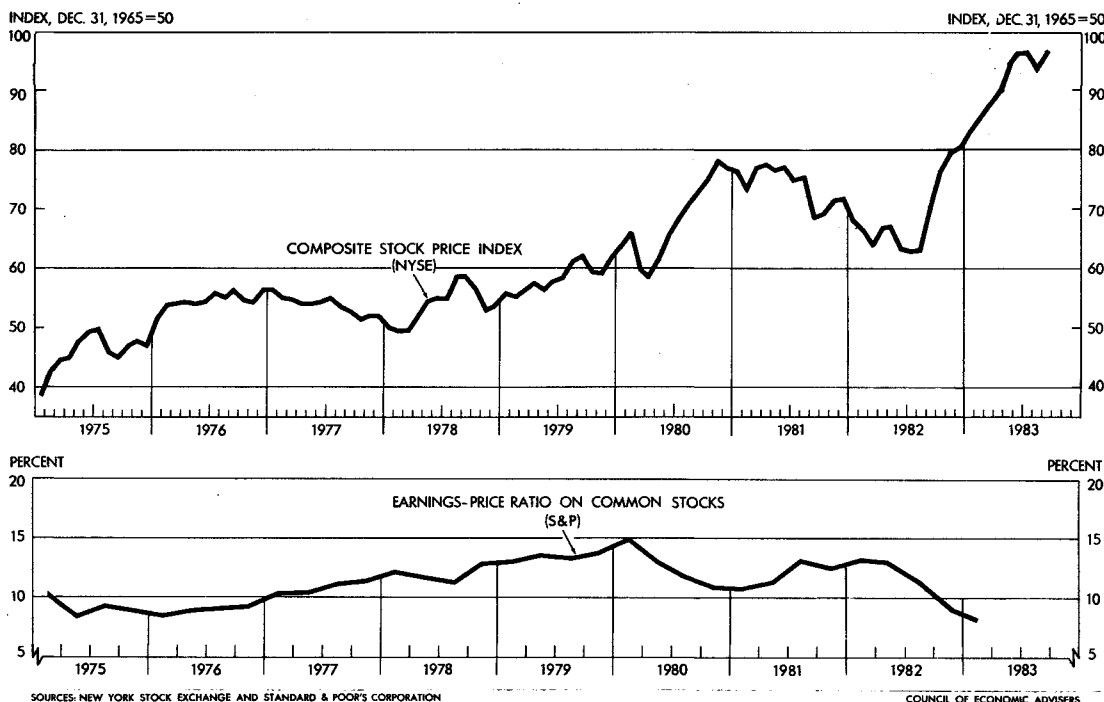

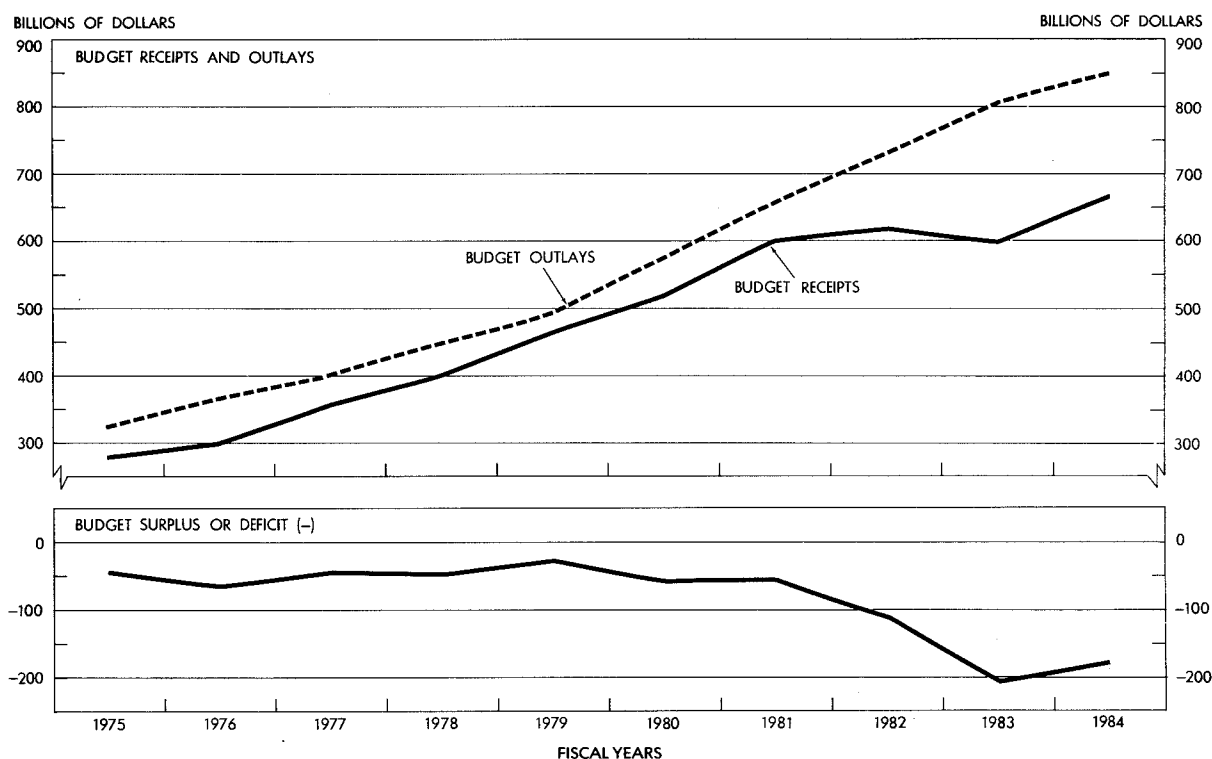

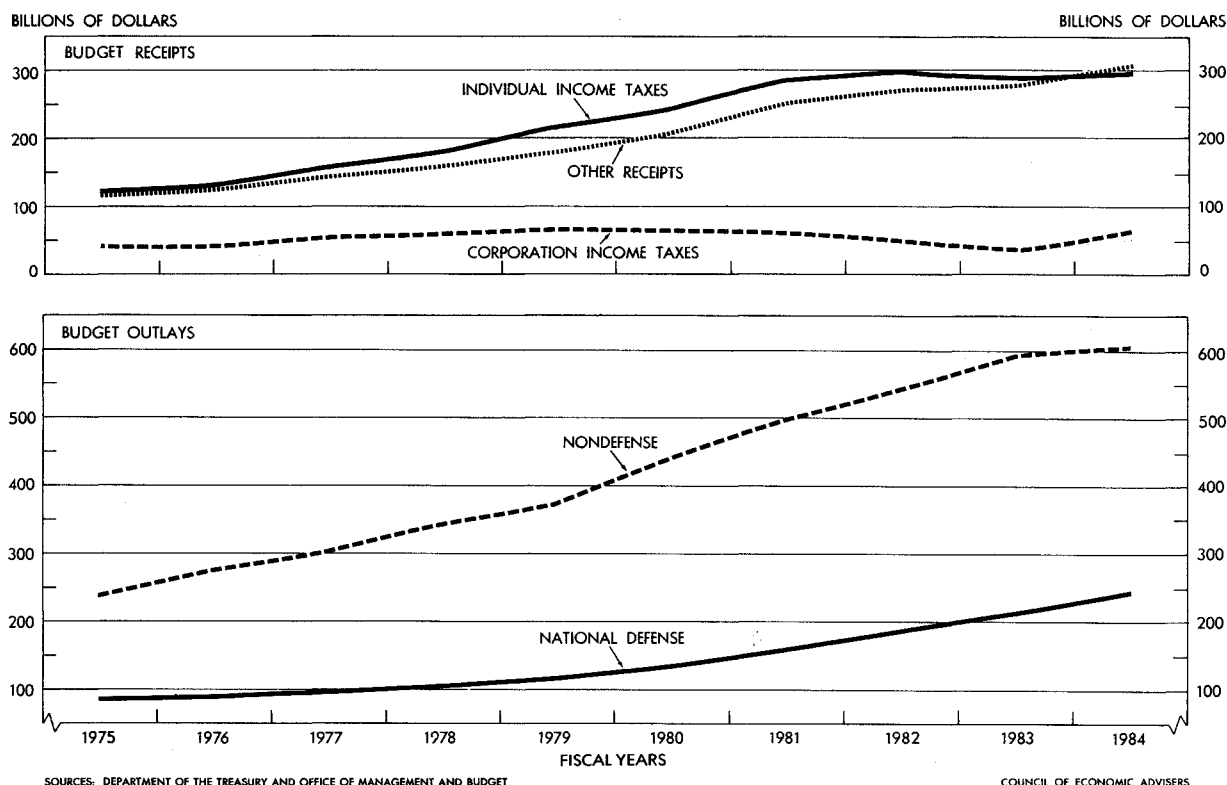

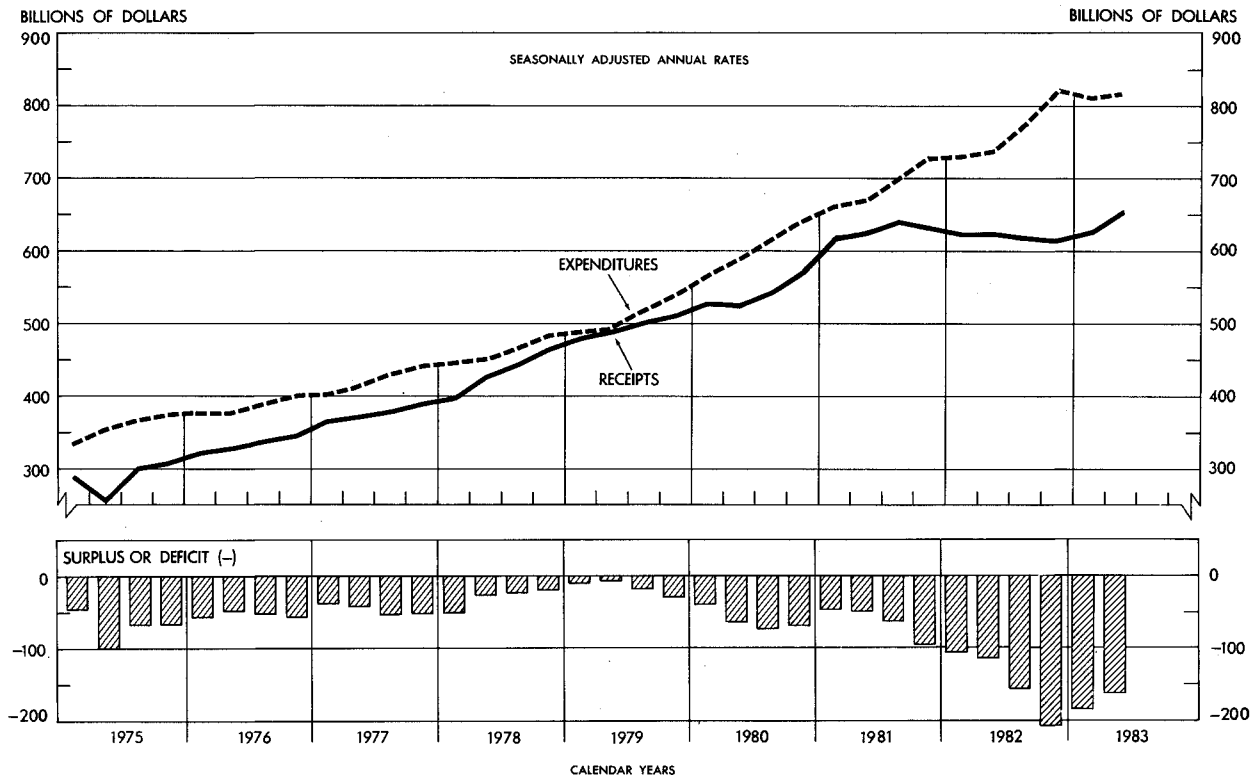

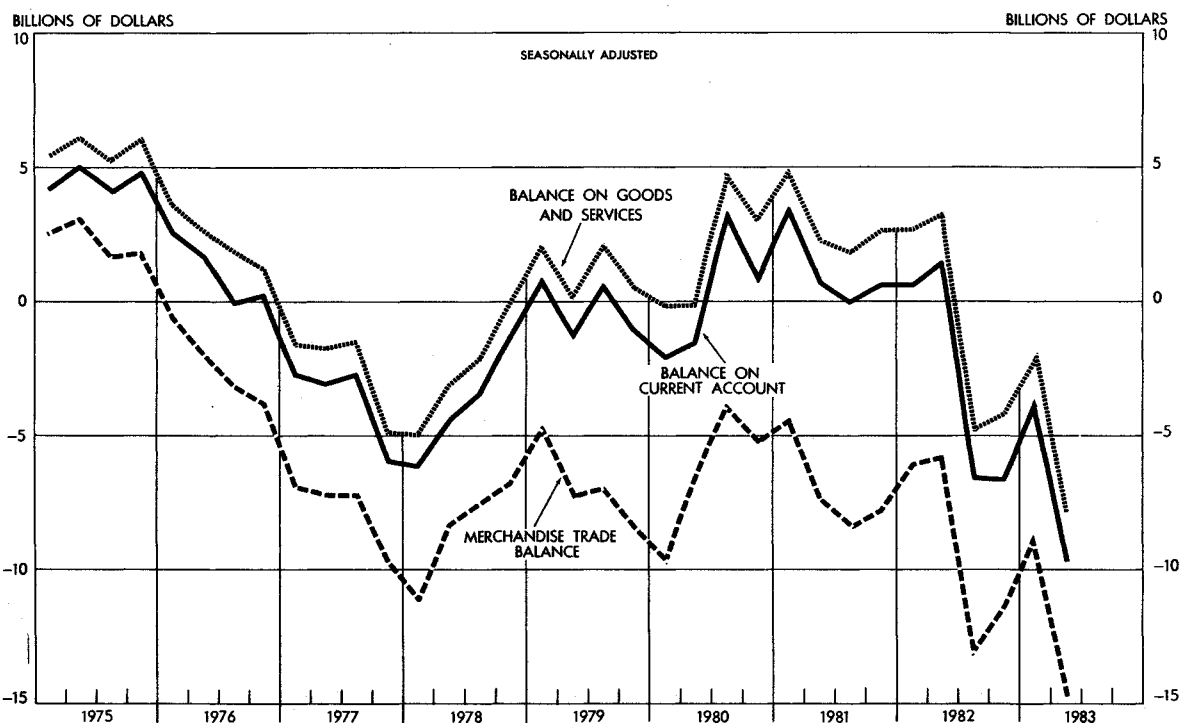

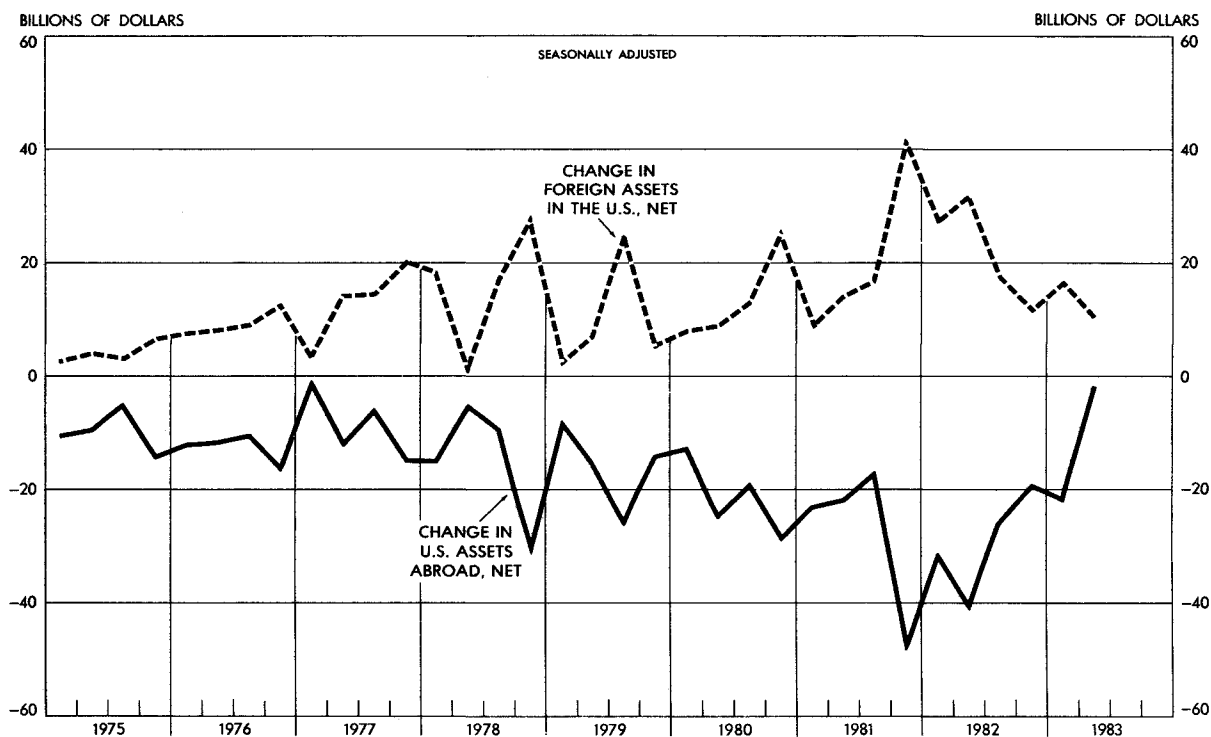

In the capital accounts, claims on foreigners reported by U.S. banks decreased \$3.5 billion in the second quarter compared to an increase of \$15.9 billion in the first quarter. Liabilities to foreigners and international financial institutions reported by U.S. banks increased \$4.1 billion in the second quarter, compared with a \$13.5 billion increase in the first quarter.
