JOINT RESOLUTION [S.J. Res. 55]

To print the monthly publication entitled "Economic Indicators"

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the Joint Economic Committee be authorized to issue a monthly publication entitled "Economic Indicators," and that a sufficient quantity be printed to furnish one copy to each Member of Congress; the Secretary and the Sergeant at Arms of the Senate; the Clerk, Sergeant at Arms, and Doorkeeper of the House of Representatives; two copies to the libraries of the Senate and House, and the Congressional Library; seven hundred copies to the Joint Economic Committee; and the required numbers of copies to the Superintendent of Documents for distribution to depository libraries; and that the Superintendent of Documents be authorized to have copies printed for sale to the public.

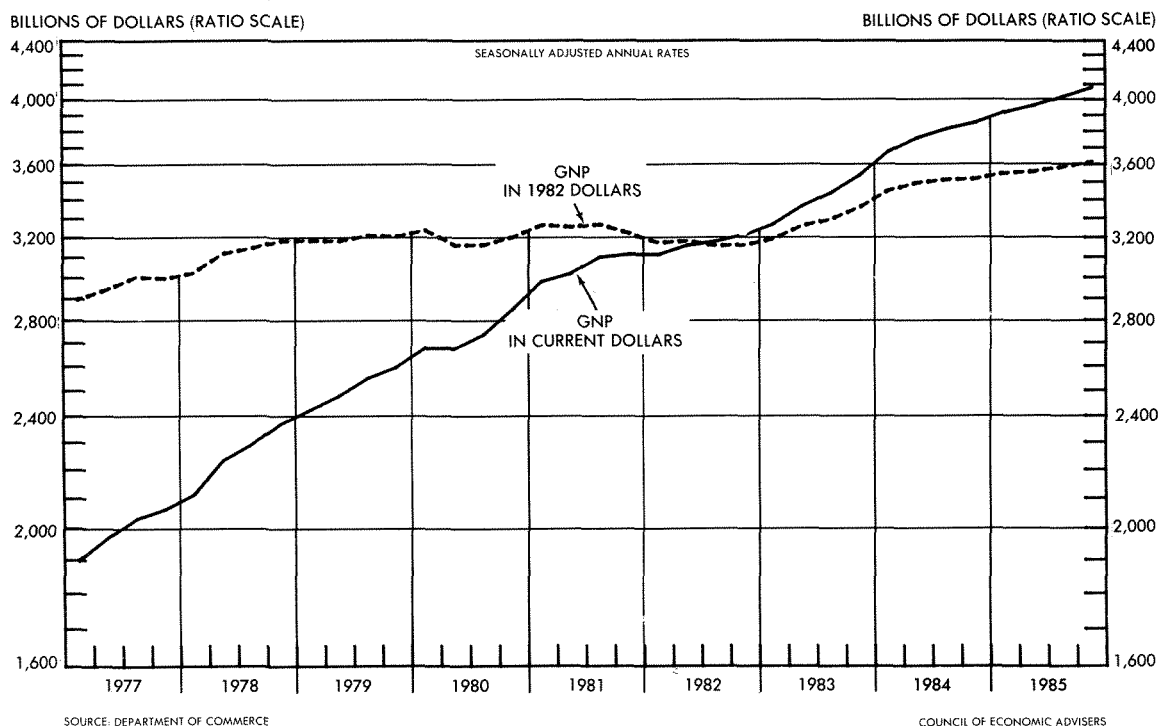

TOTAL OUTPUT, INCOME, AND SPENDING

GROSS NATIONAL PRODUCT

According to very preliminary ("flash") estimates current-dollar gross national product (GNP) is expected to rise 6.0 percent (annual rate) or \$58.6 billion in the fourth quarter of 1985. Real GNP (GNP adjusted for price changes) is expected to rise 3.2 percent and the implicit price deflator, 2.5 percent. In the third quarter, revised data show, GNP rose 5.8 percent, real GNP rose 3.0 percent, and the deflator rose 2.9 percent. (Data reflect the recent comprehensive revision of the national income and product accounts.)

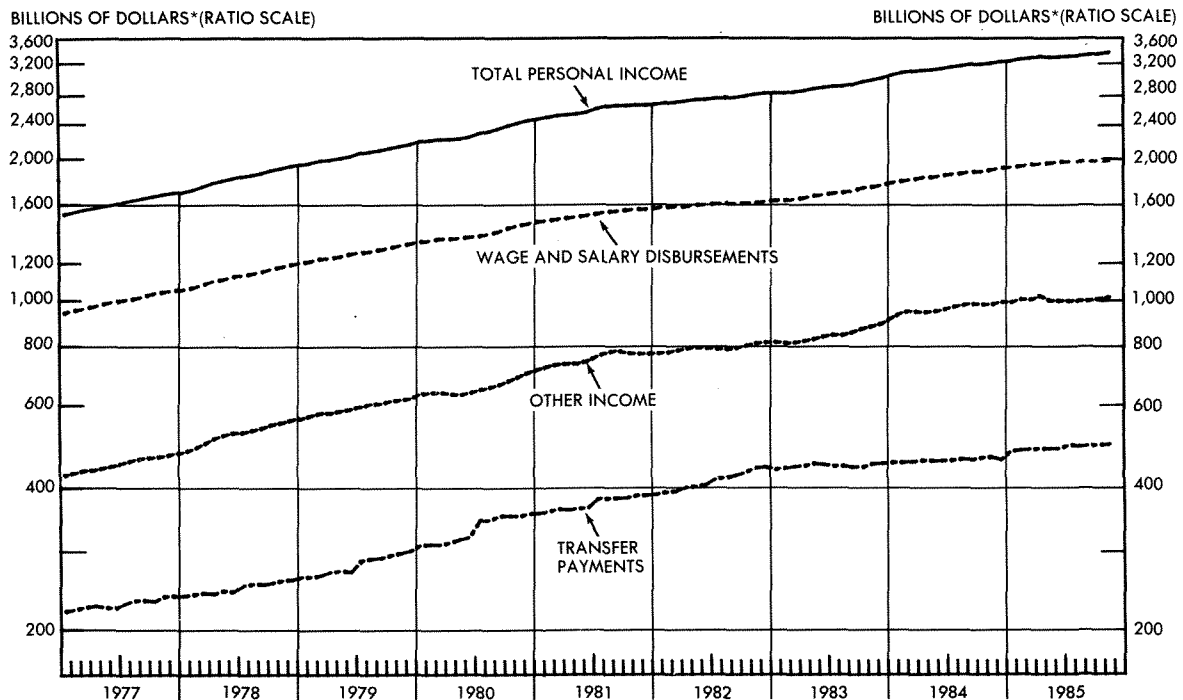

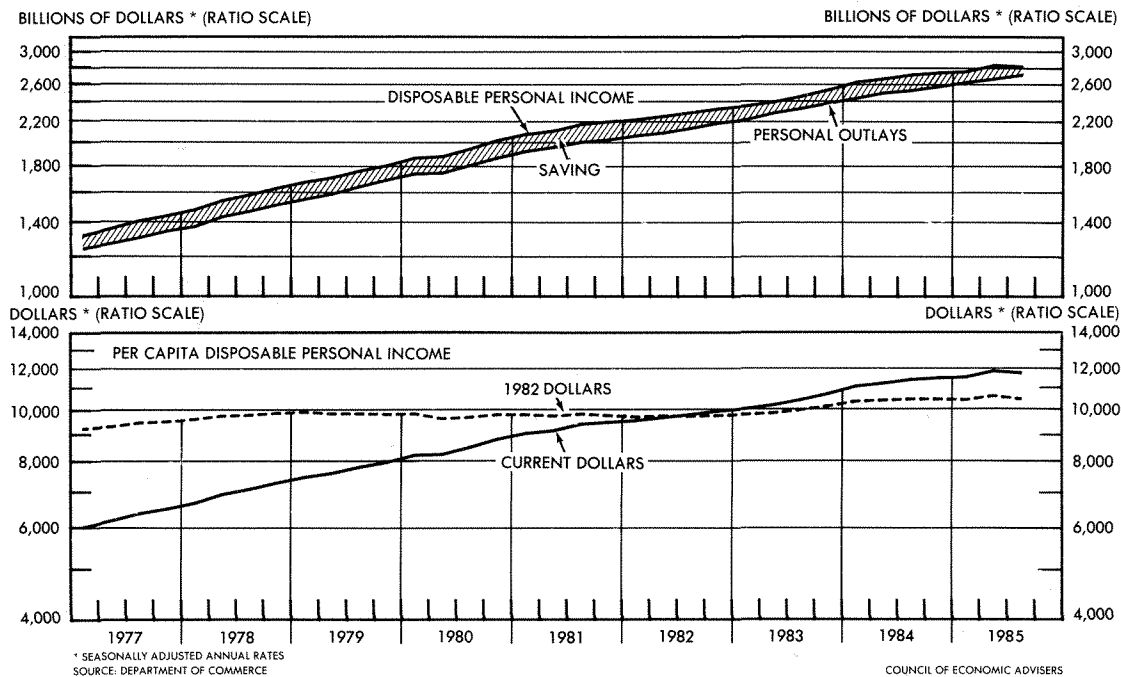

According to revised estimates, disposable personal income fell \$17.5 billion (annual rate) in the third quarter of 1985, compared with a rise of \$78.5 billion in the second quarter. If there had been no delay in the payment of Federal income tax refunds from the first quarter to the second quarter, disposable personal income would have increased \$10.0 billion in the third quarter and \$23.5 billion in the second quarter. 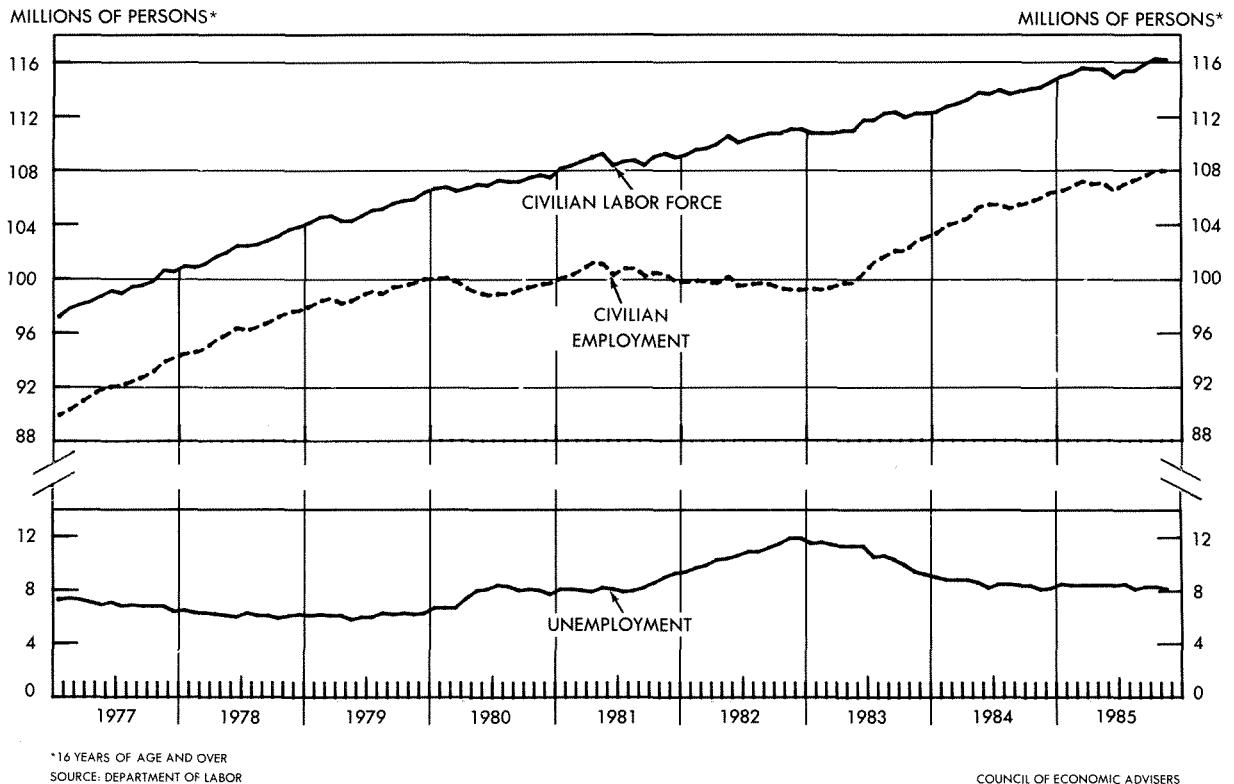

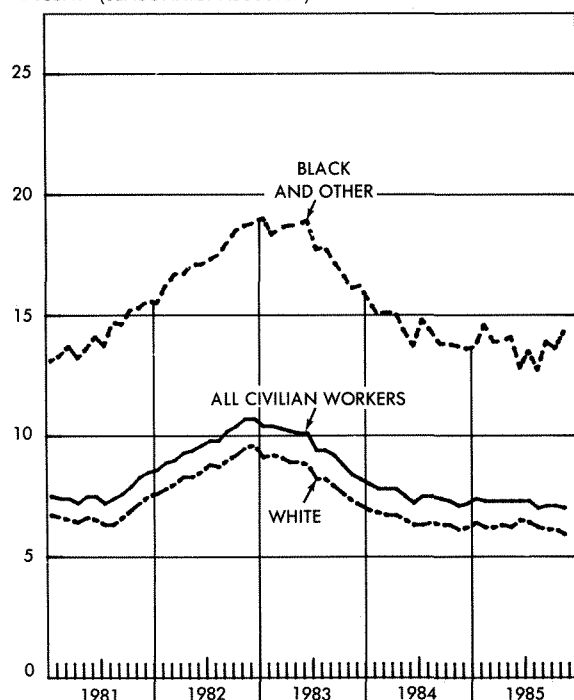

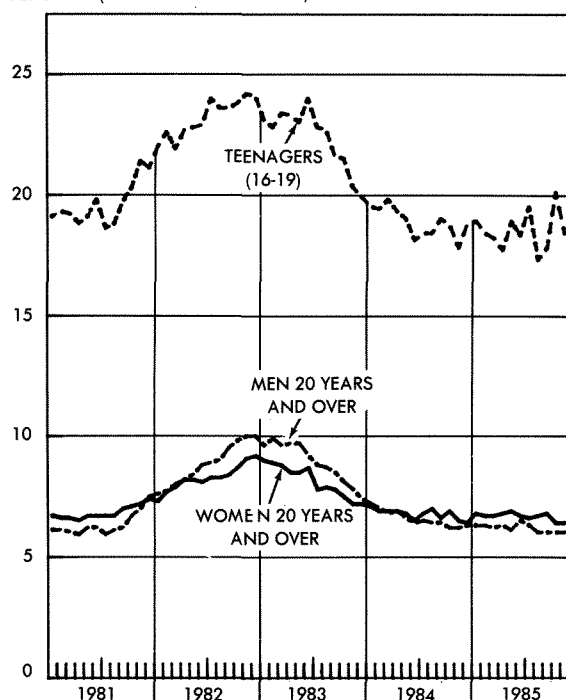
SELECTED UNEMPLOYMENT RATES

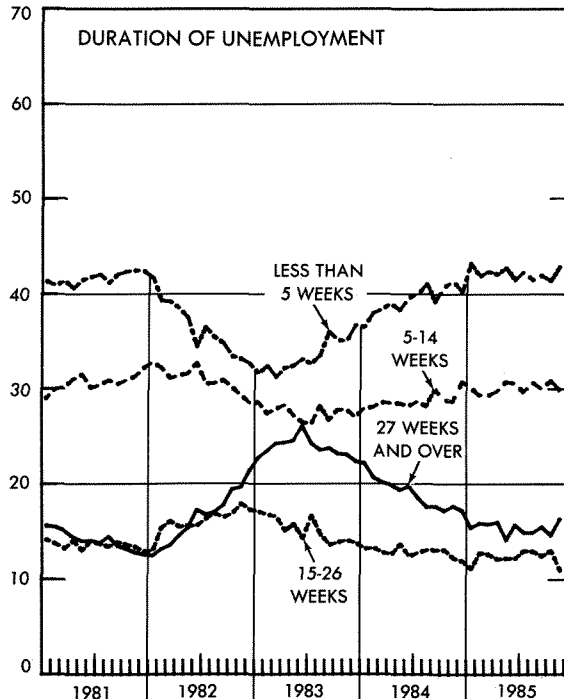

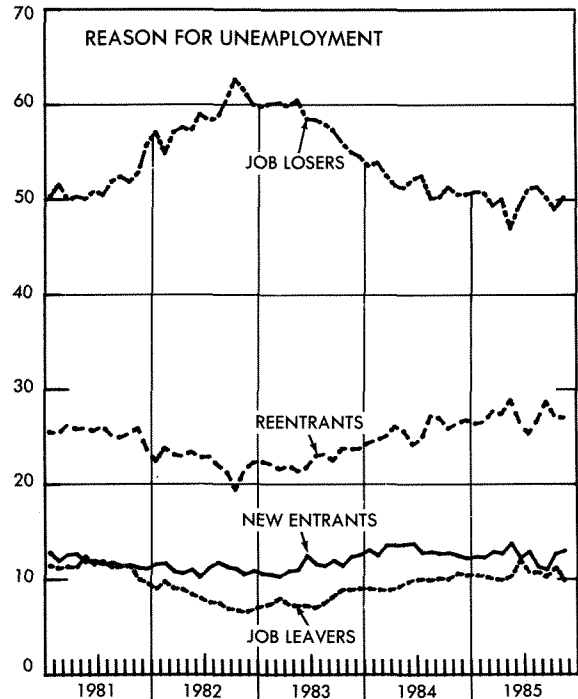

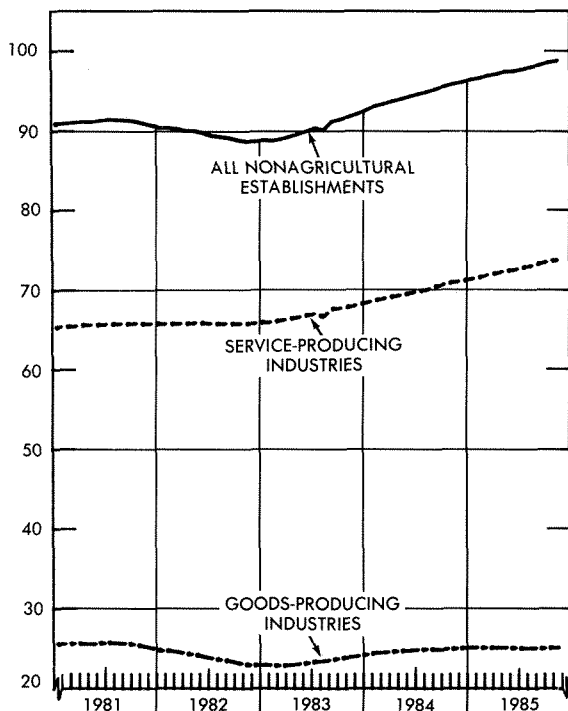

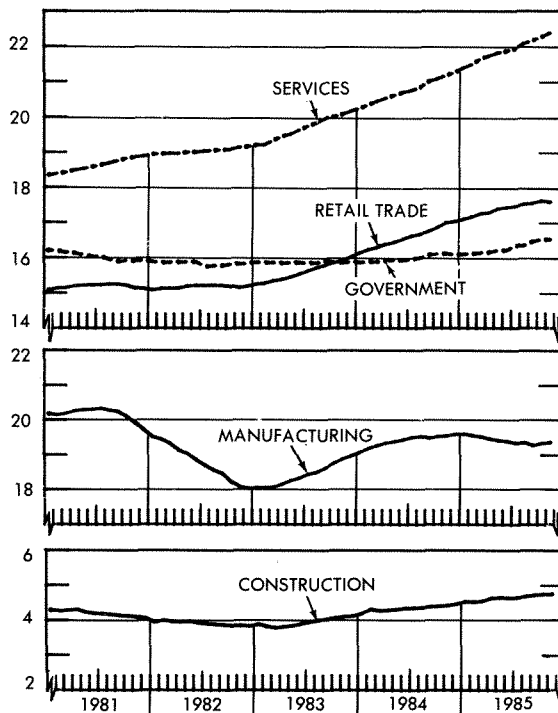

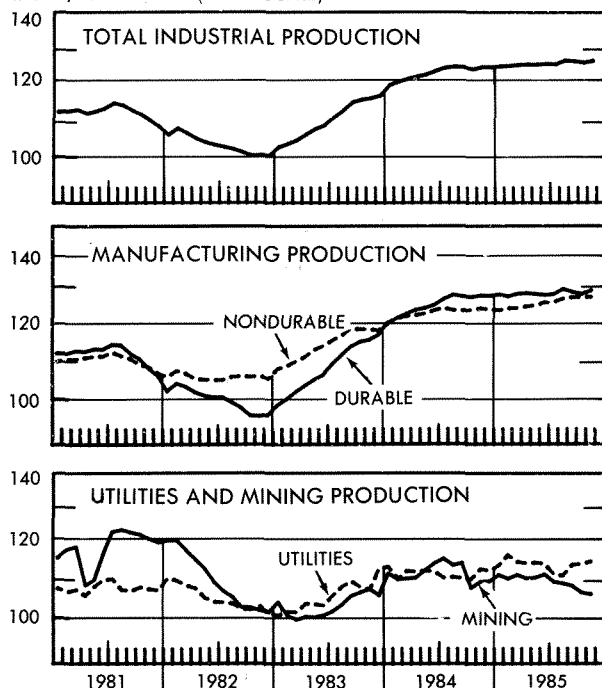

INDUSTRIAL PRODUCTION AND CAPACITY UTILIZATION

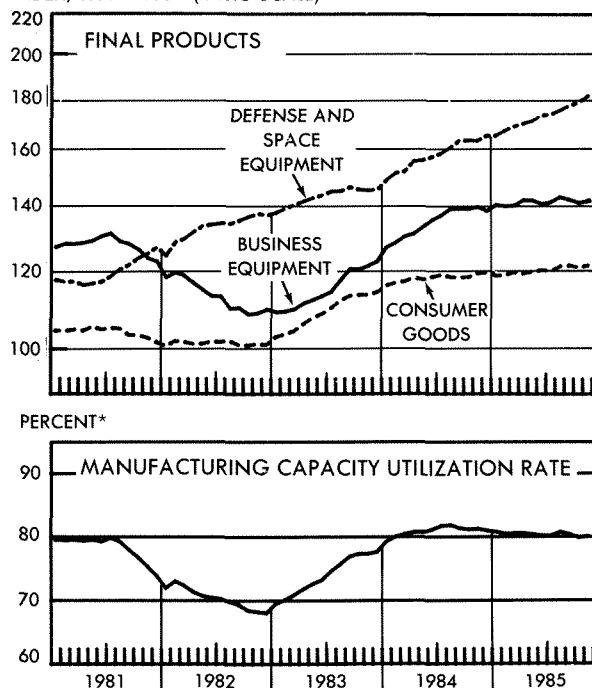
Industrial production rose 0.4 percent in November, following a decline of 0.4 percent in October. The index for November was 1.4 percent above its year earlier level.

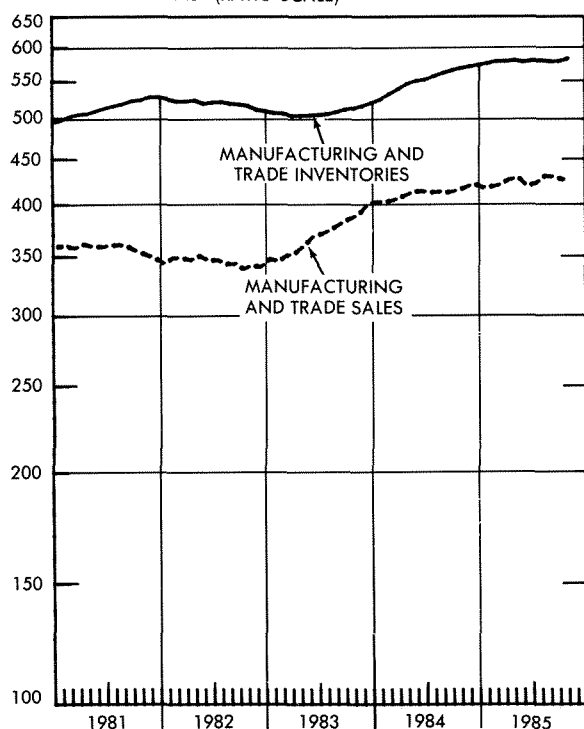

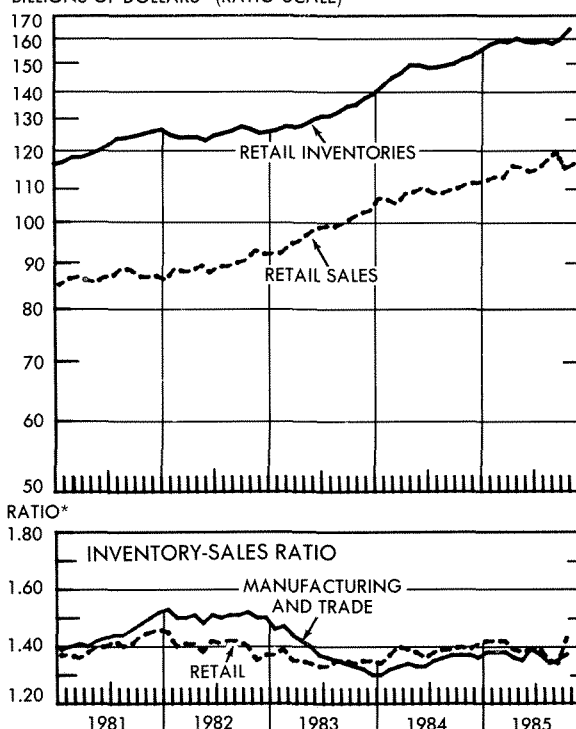

BILLIONS OF DOLLARS* (RATIO SCALE)

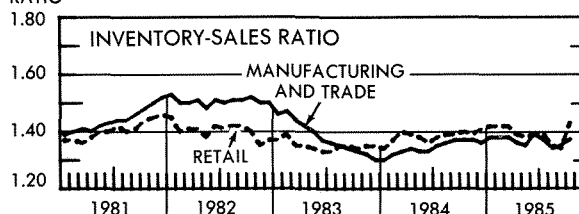

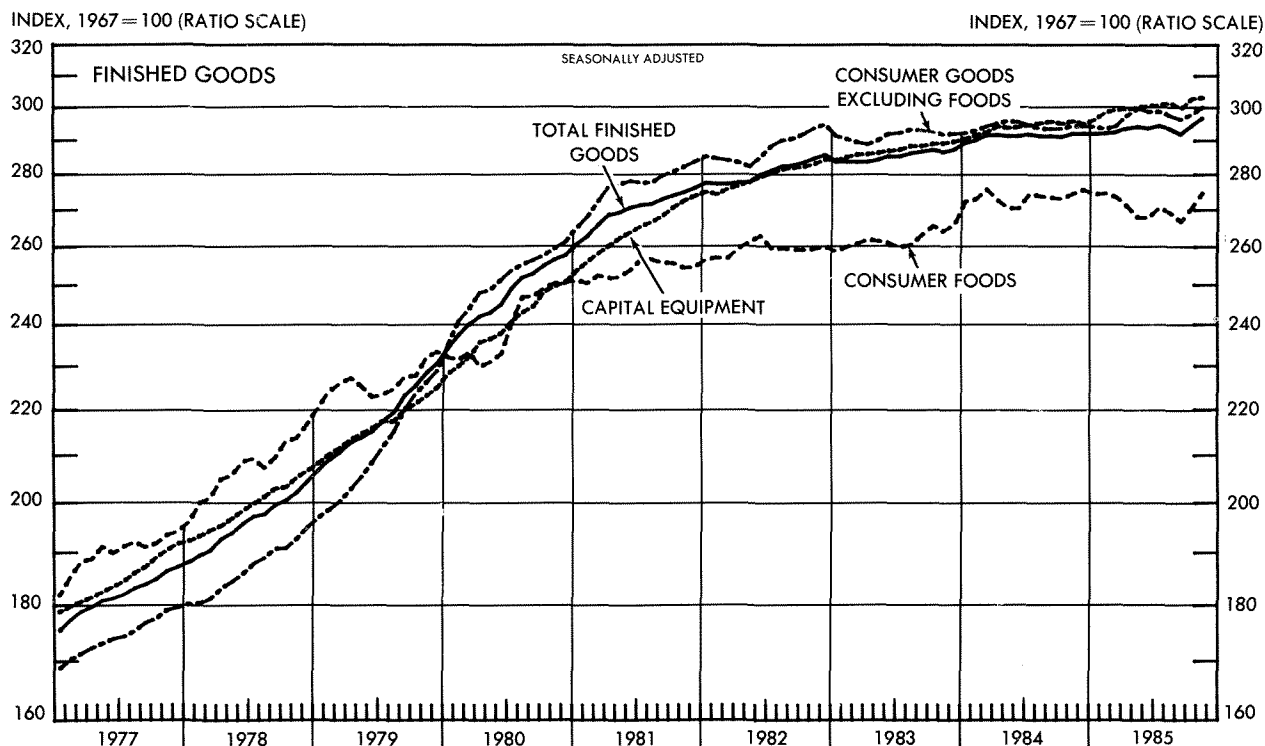

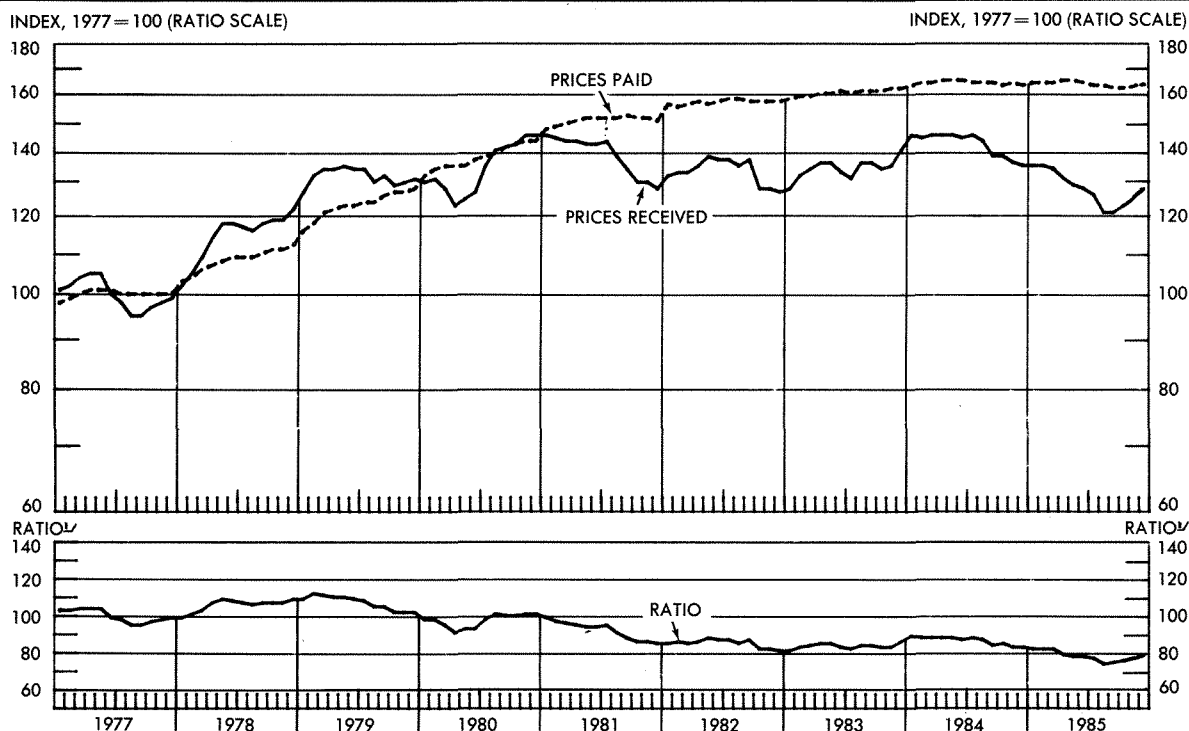

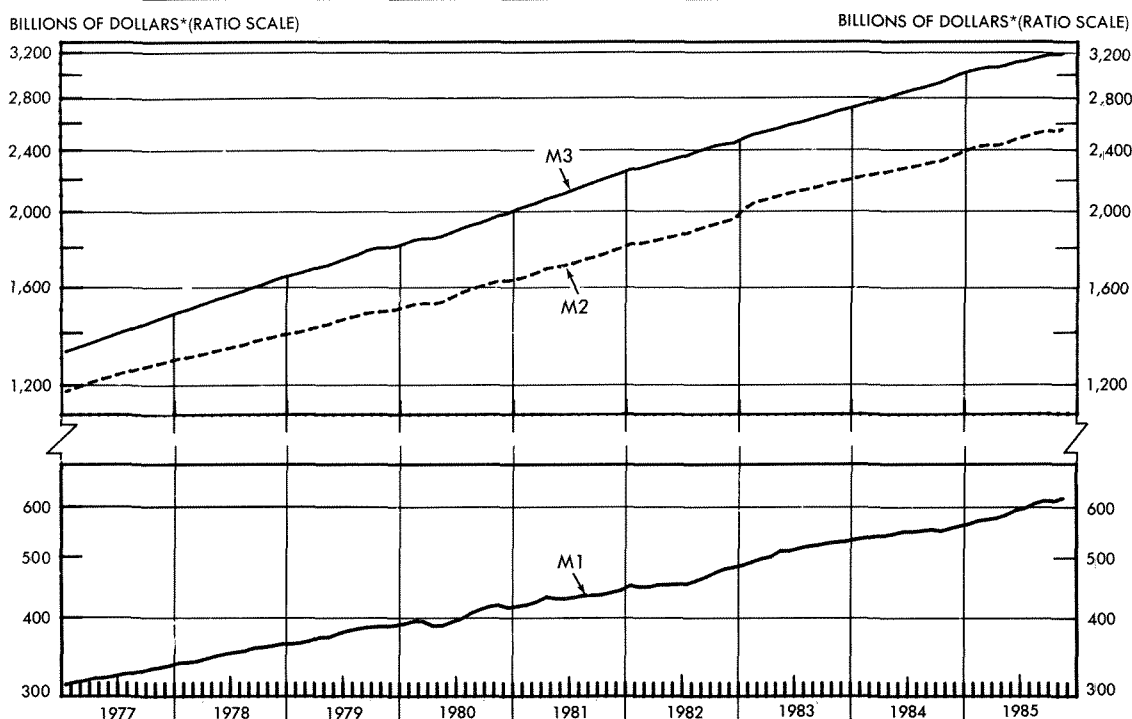

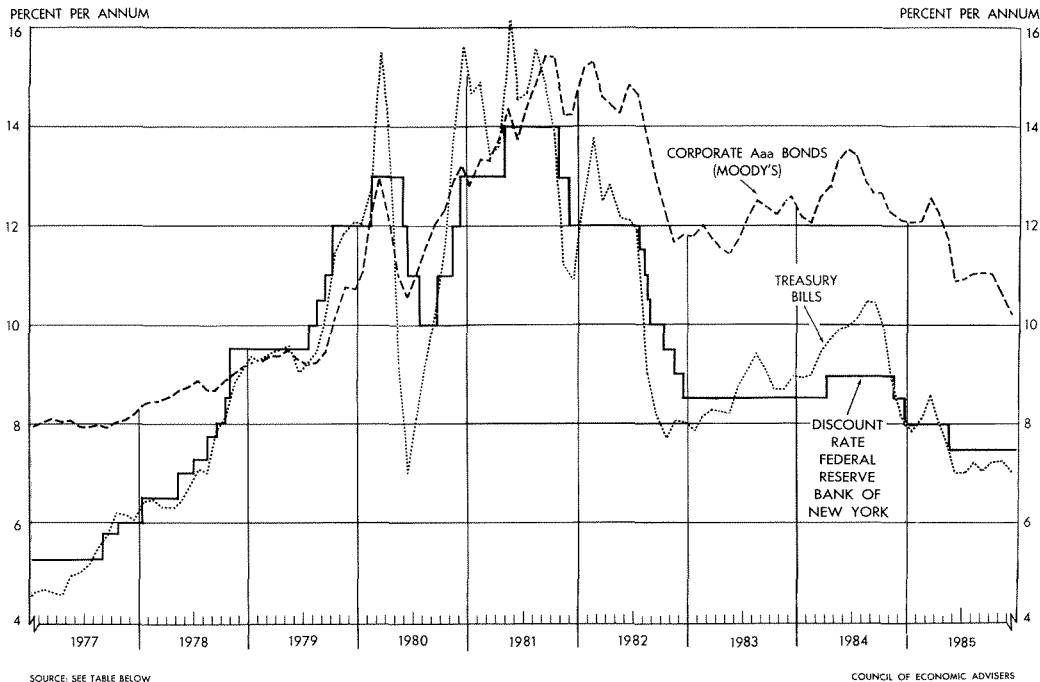

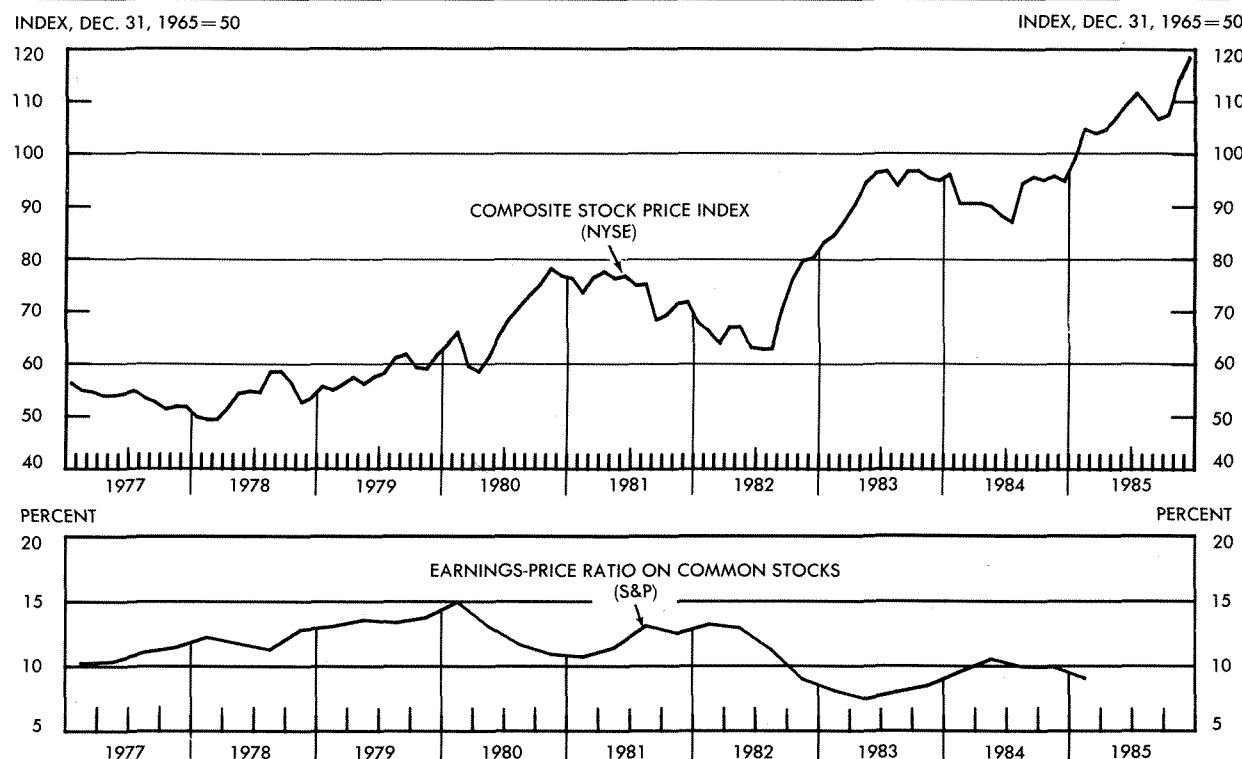

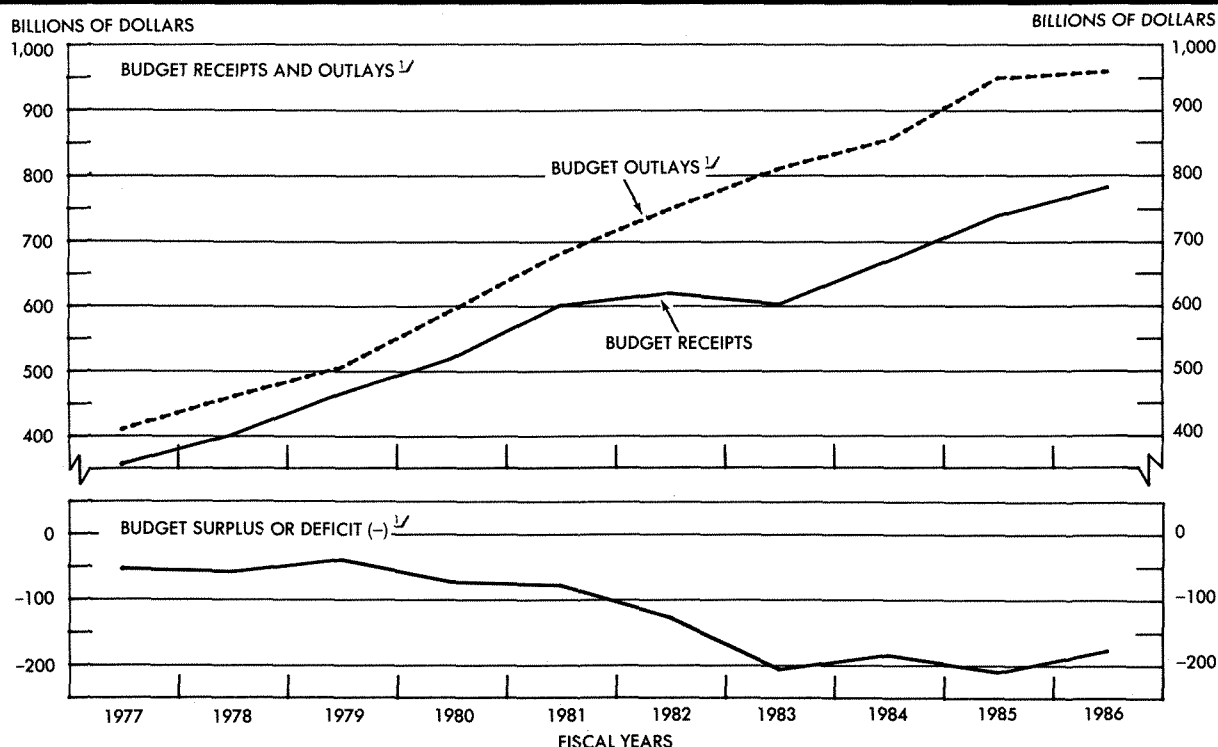

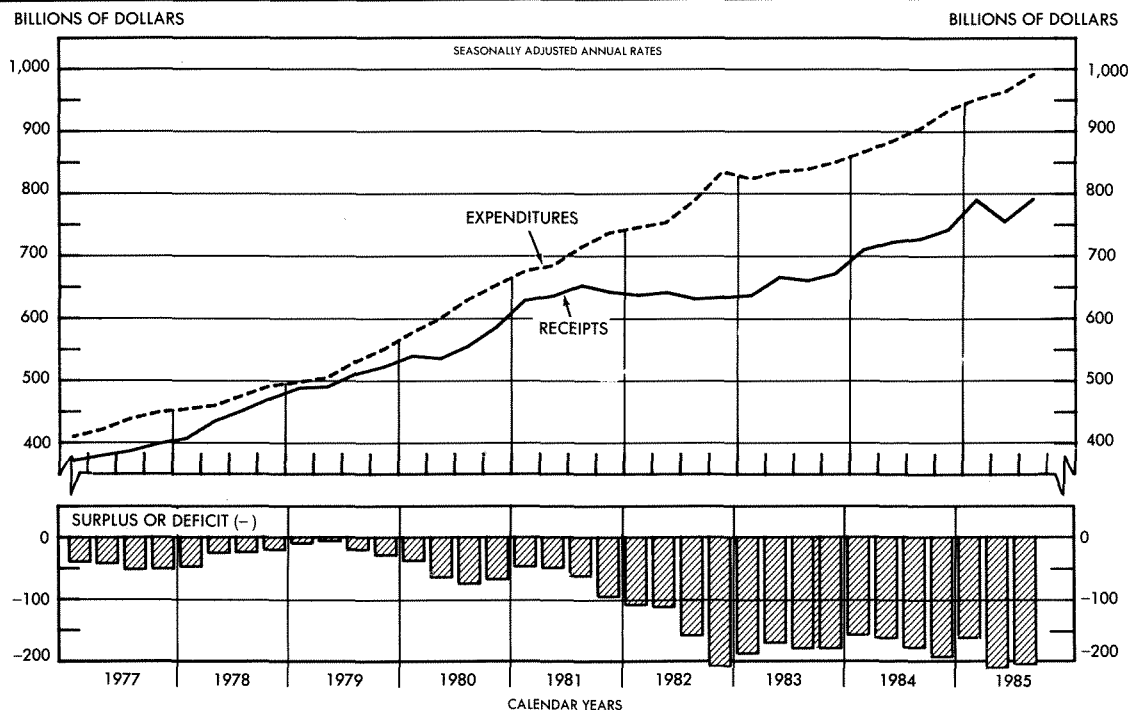

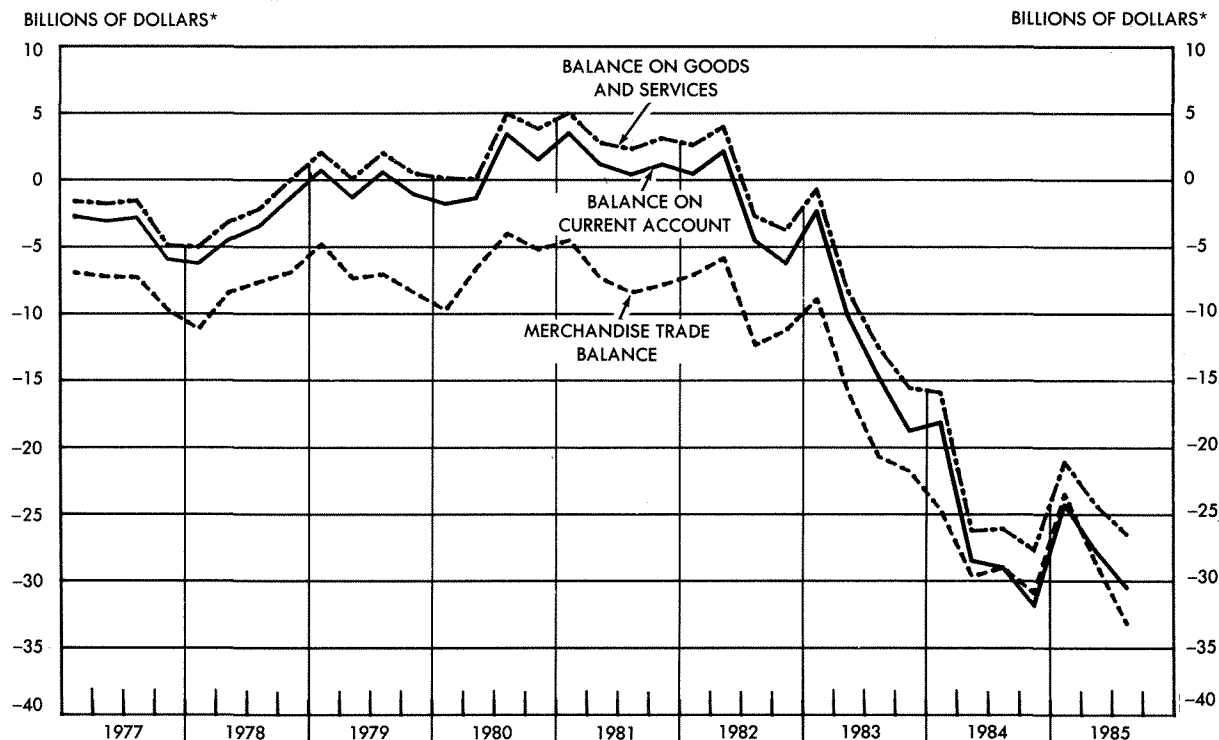

U.S. INTERNATIONAL TRANSACTIONS—Continued

In the capital accounts, claims on foreigners reported by U.S. banks increased \$1.4 billion in the third quarter of 1985 compared with a decrease of \$4.1 billion in the second quarter. Liabilities to private foreigners and international financial institutions reported by U.S. banks (excluding U.S. Treasury securities) increased \$6.5 billion, compared to an increase of \$0.2 billion in the second quarter.
