JOINT RESOLUTION [S.J. Res. 55]

To print the monthly publication entitled "Economic Indicators"

Resolved by the Senate and House of Representatives of the United States of America in Congress assembled, That the Joint Economic Committee be authorized to issue a monthly publication entitled "Economic Indicators," and that a sufficient quantity be printed to furnish one copy to each Member of Congress; the Secretary and the Sergeant at Arms of the Senate; the Clerk, Sergeant at Arms, and Doorkeeper of the House of Representatives; two copies to the libraries of the Senate and House, and the Congressional Library; seven hundred copies to the Joint Economic Committee; and the required numbers of copies to the Superintendent of Documents for distribution to depository libraries; and that the Superintendent of Documents be authorized to have copies printed for sale to the public.

Approved June 23, 1949.

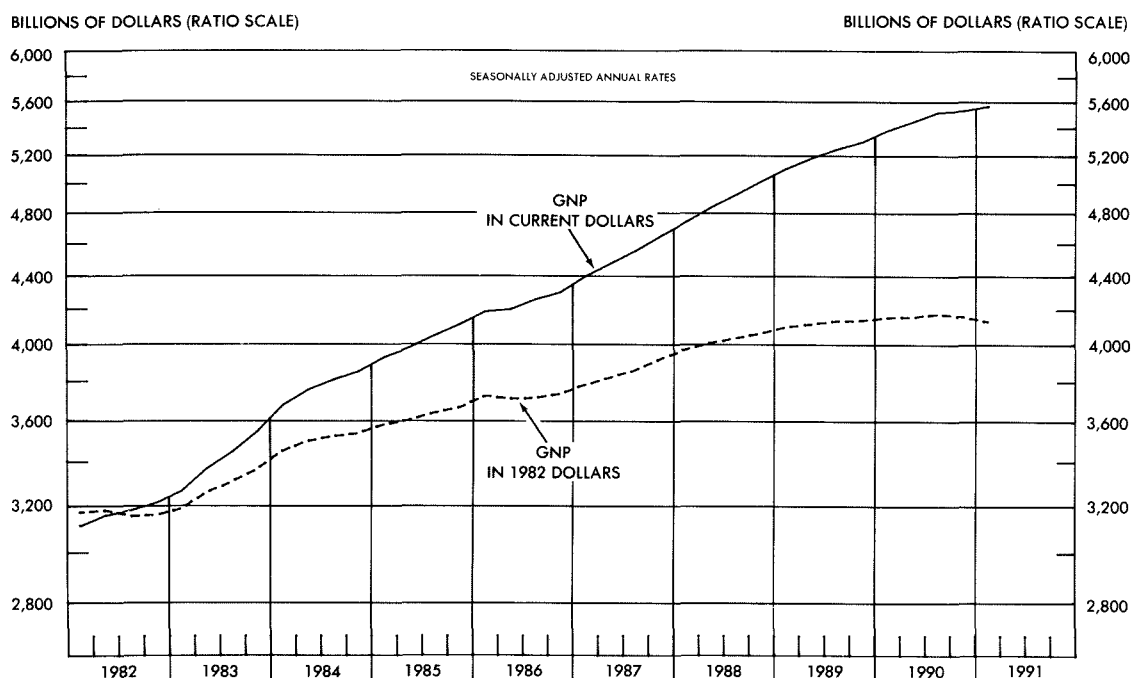

TOTAL OUTPUT, INCOME, AND SPENDING

GROSS NATIONAL PRODUCT

In the first quarter of 1991, according to revised estimates, current-dollar gross national product (GNP) rose 2.2 percent (annual rate) or \$30.4 billion. Real GNP (GNP adjusted for price changes) fell 2.8 percent and the implicit price deflator rose 5.2 percent.

GROSS PRIVATE DOMESTIC INVESTMENT

According to revised estimates for the first quarter of 1991, nonresidential fixed investment fell \$20.4 billion (annual rate) and residential investment fell \$14.7 billion. There was a \$34.2 billion decrease in inventories, following a decline of \$30.8 billion in the fourth quarter of 1990.



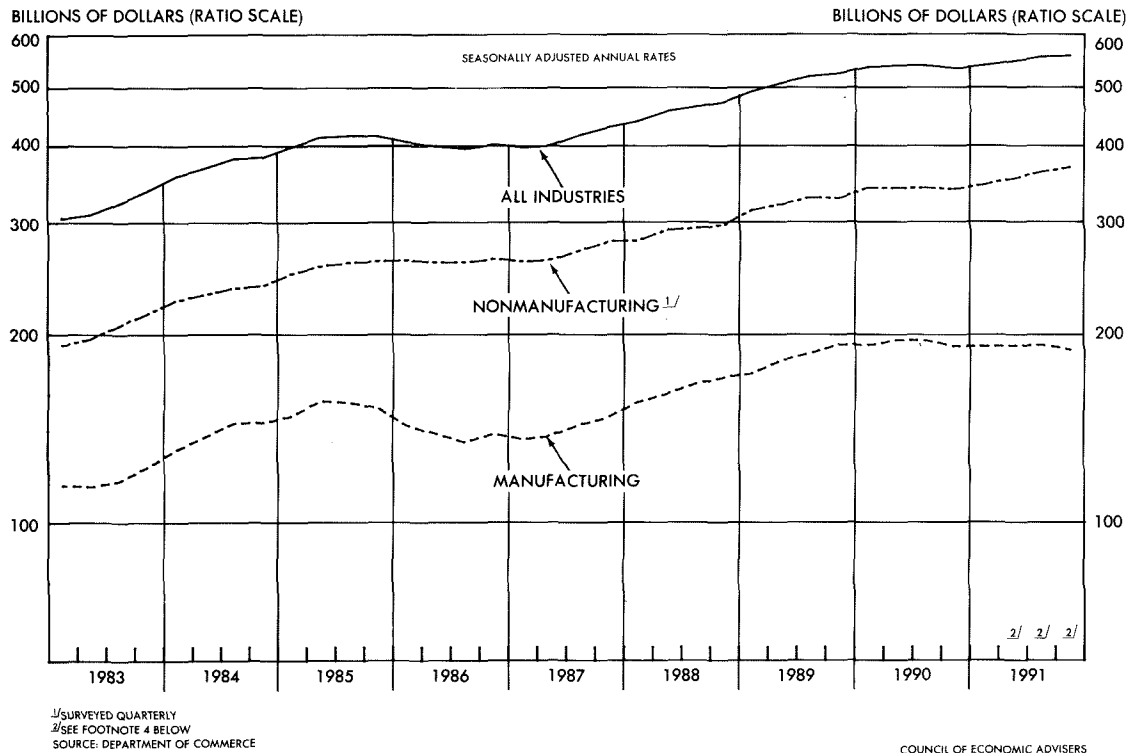

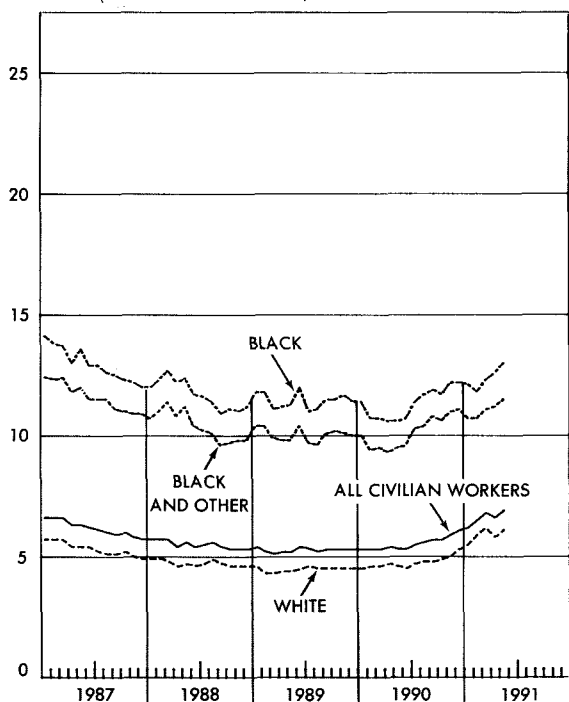

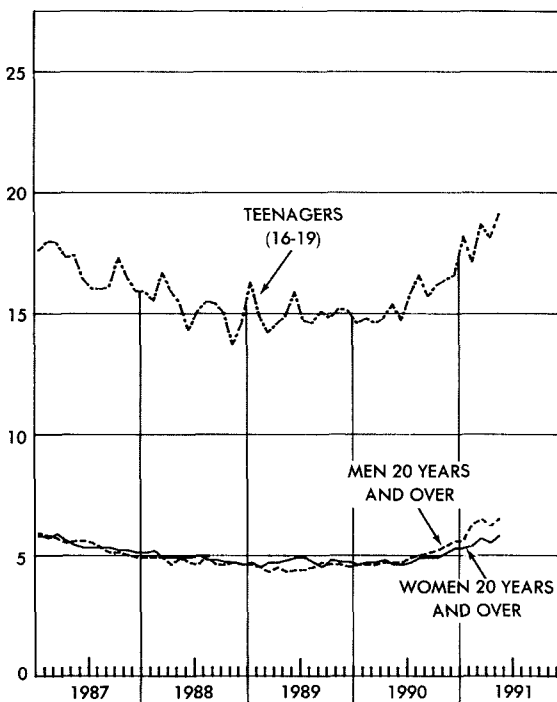

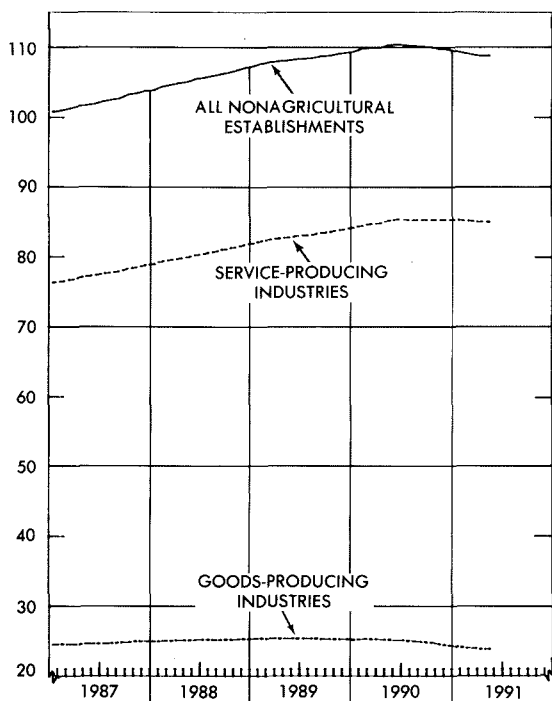

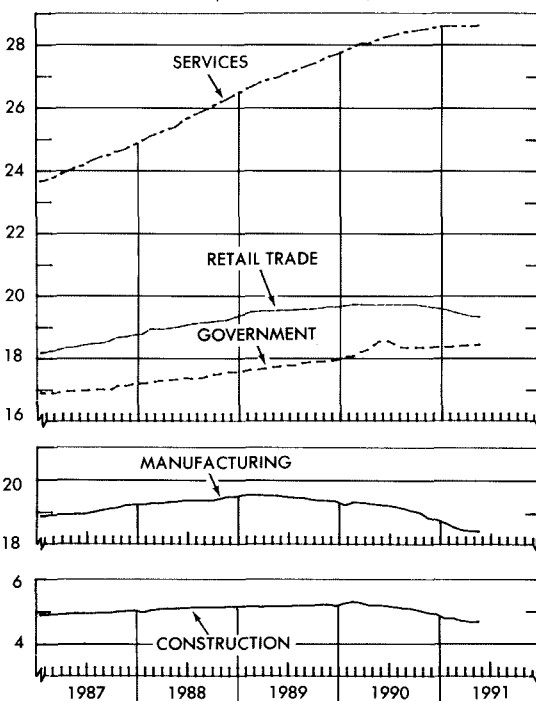

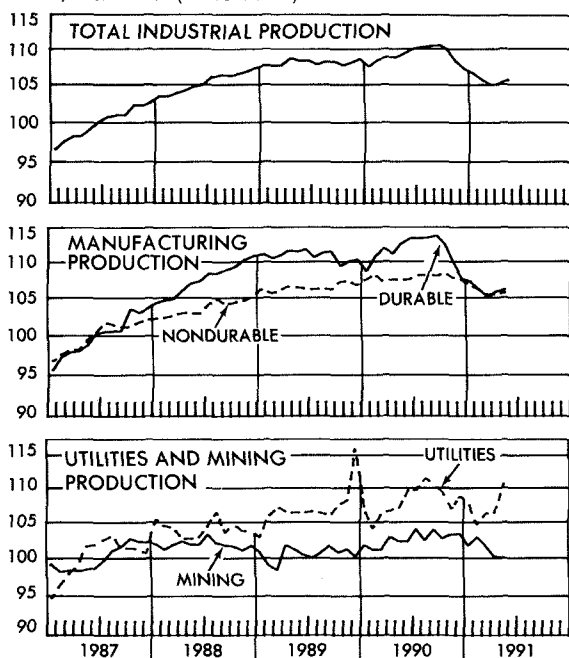

INDUSTRIAL PRODUCTION AND CAPACITY UTILIZATION

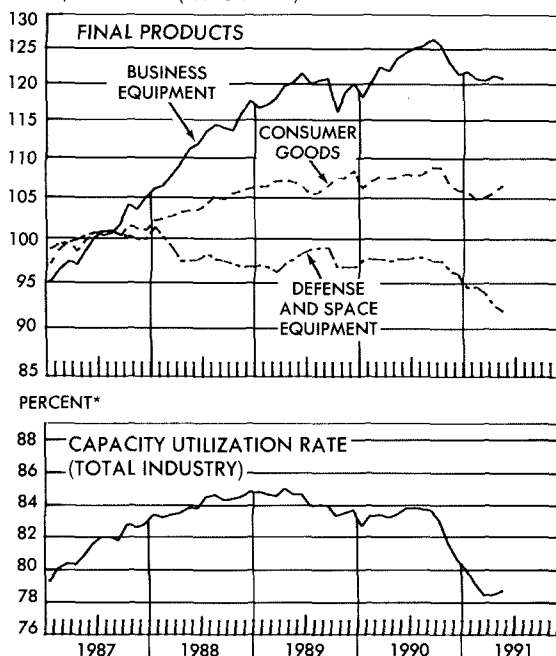
Industrial production and capacity utilization rose in May.

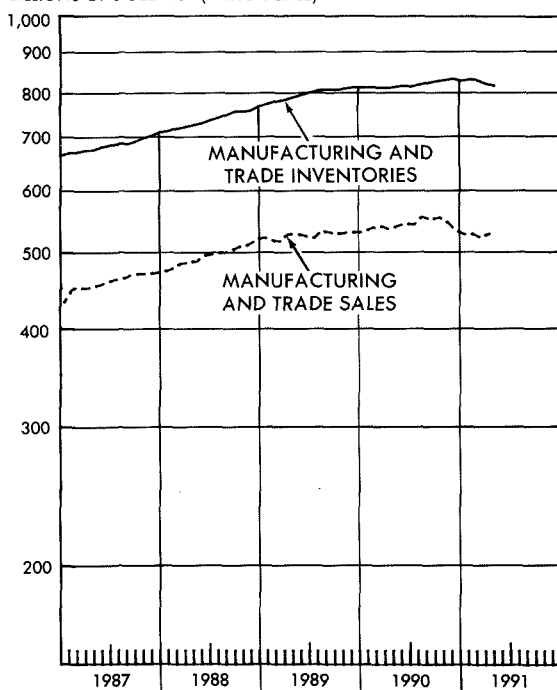

BUSINESS SALES AND INVENTORIES—Manufacturing and Trade

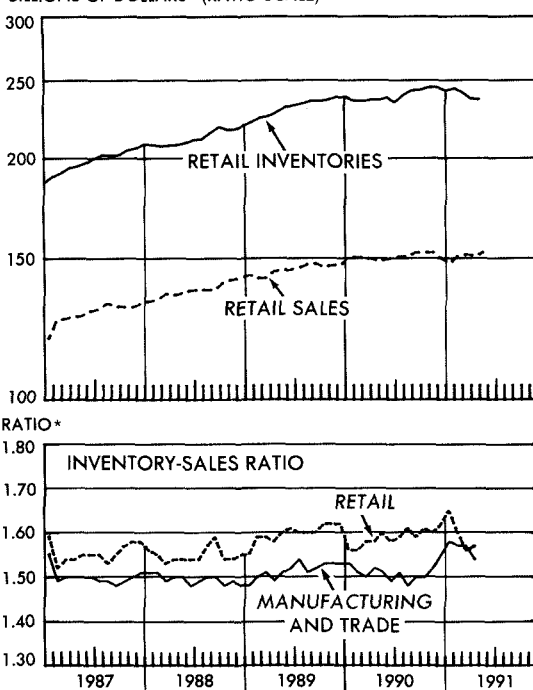

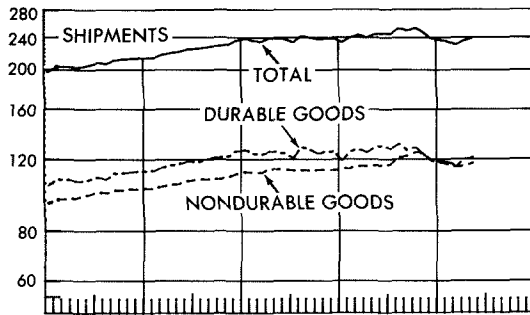

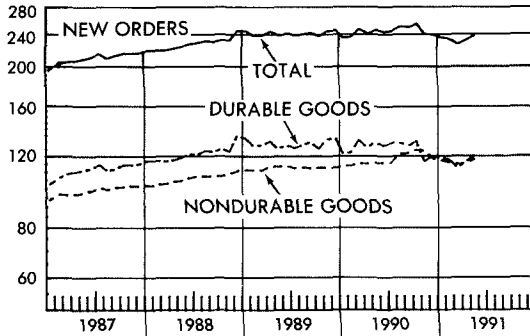

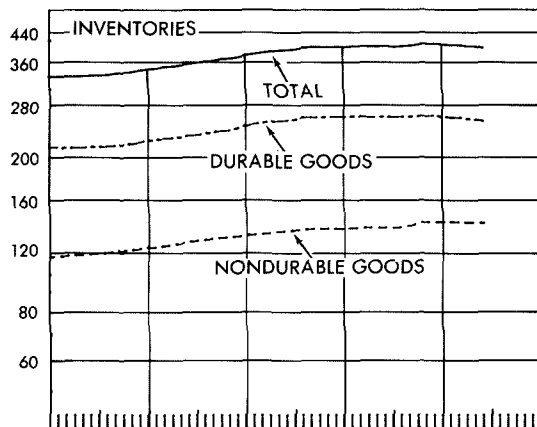
BILLIONS OF DOLLARS* (RATIO SCALE)



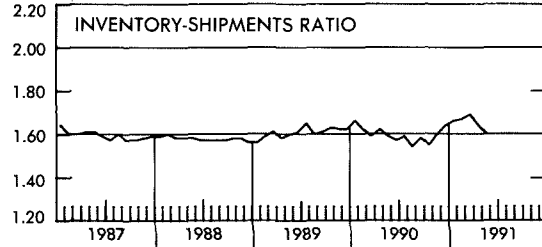
BILLIONS OF DOLLARS* (RATIO SCALE)

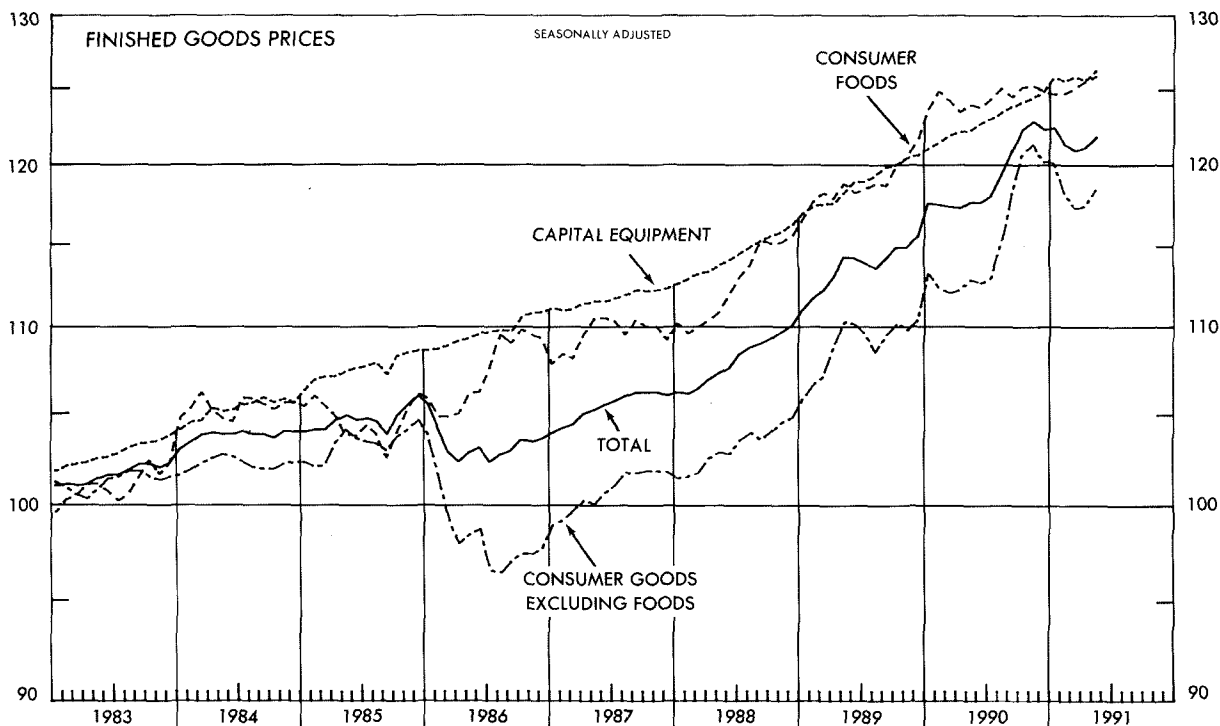

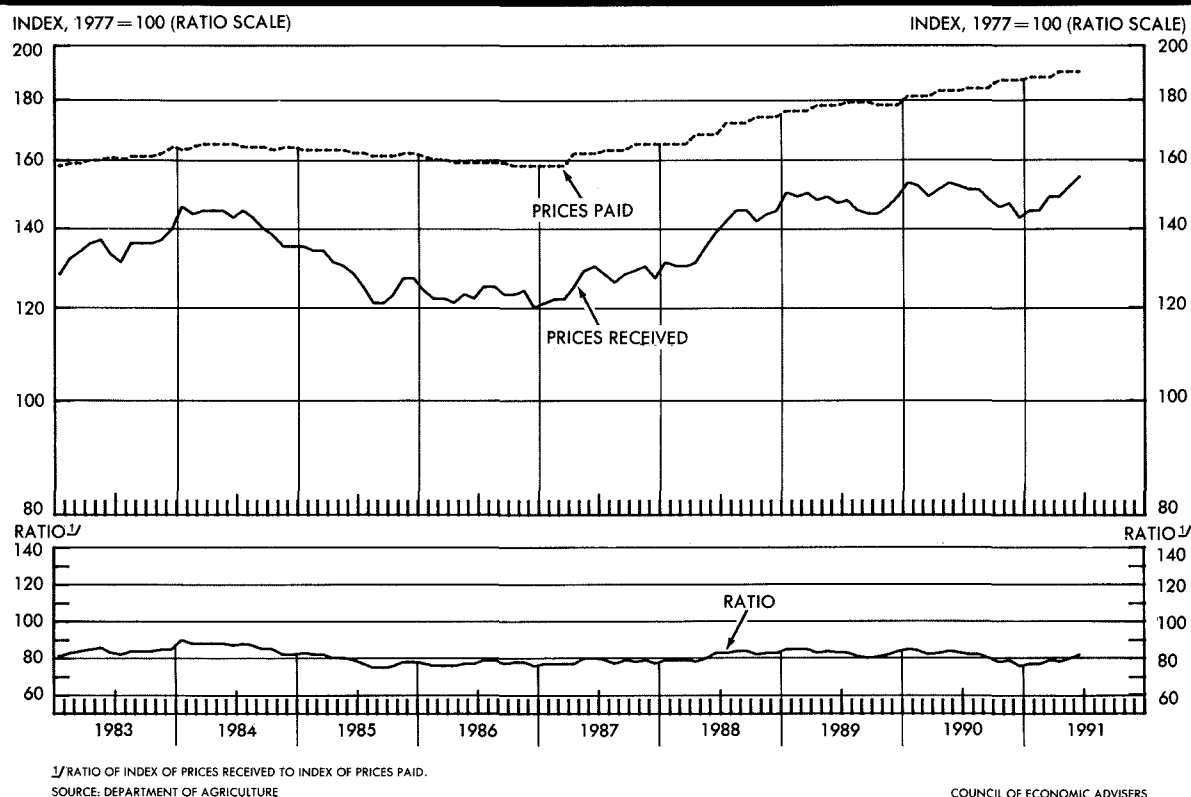

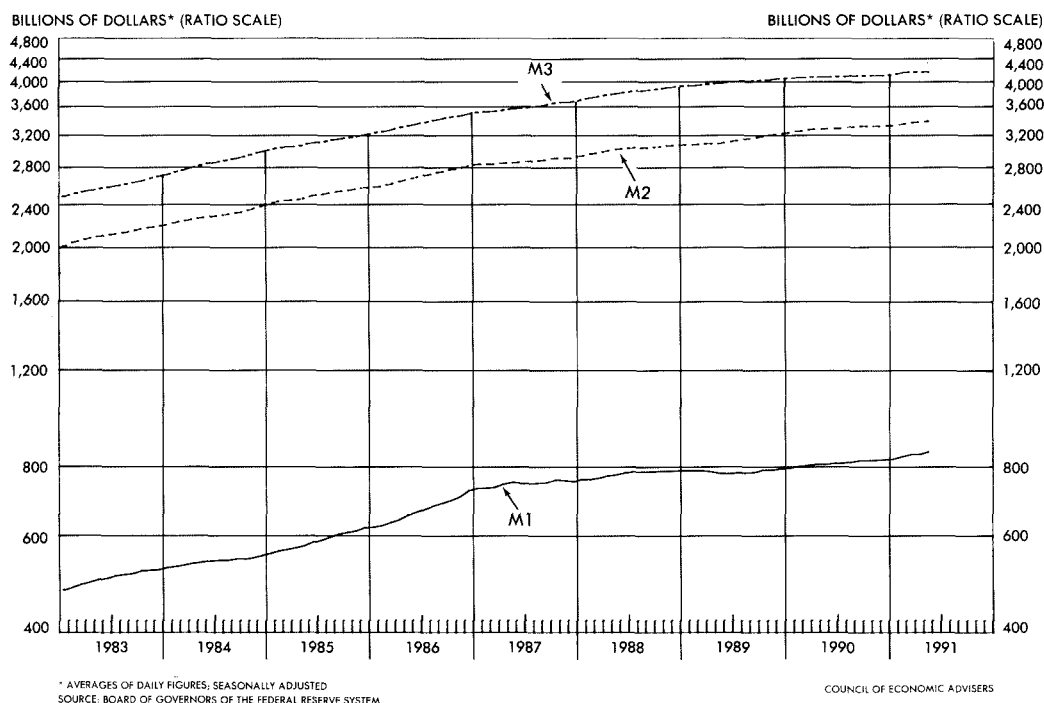

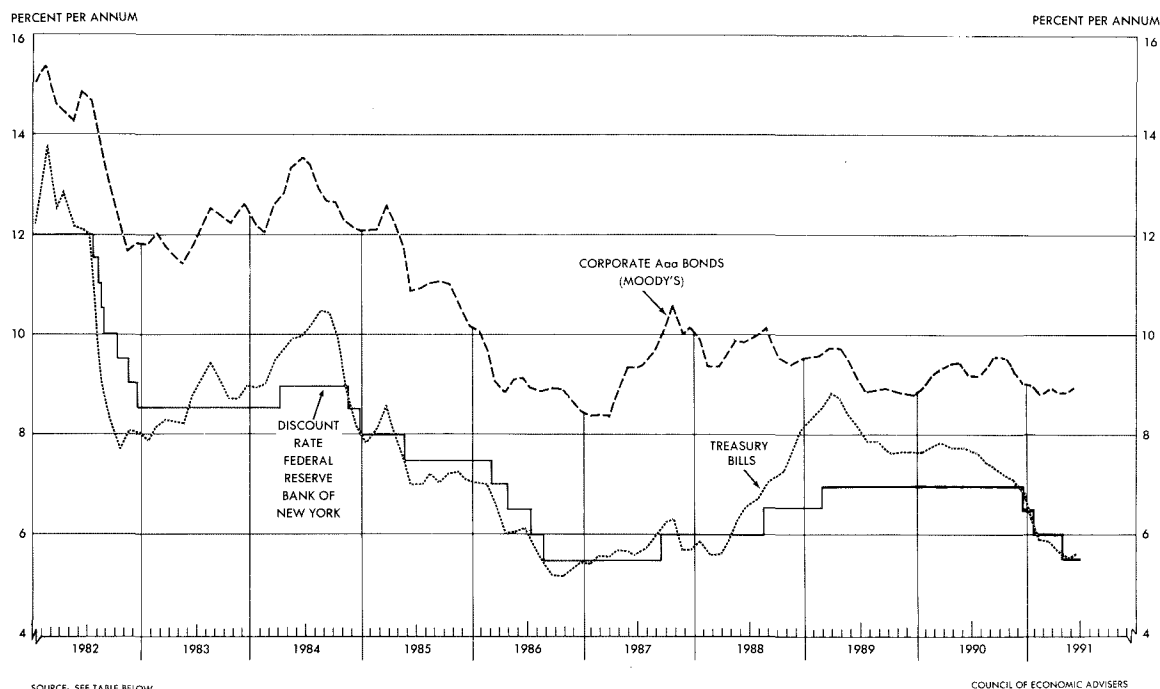

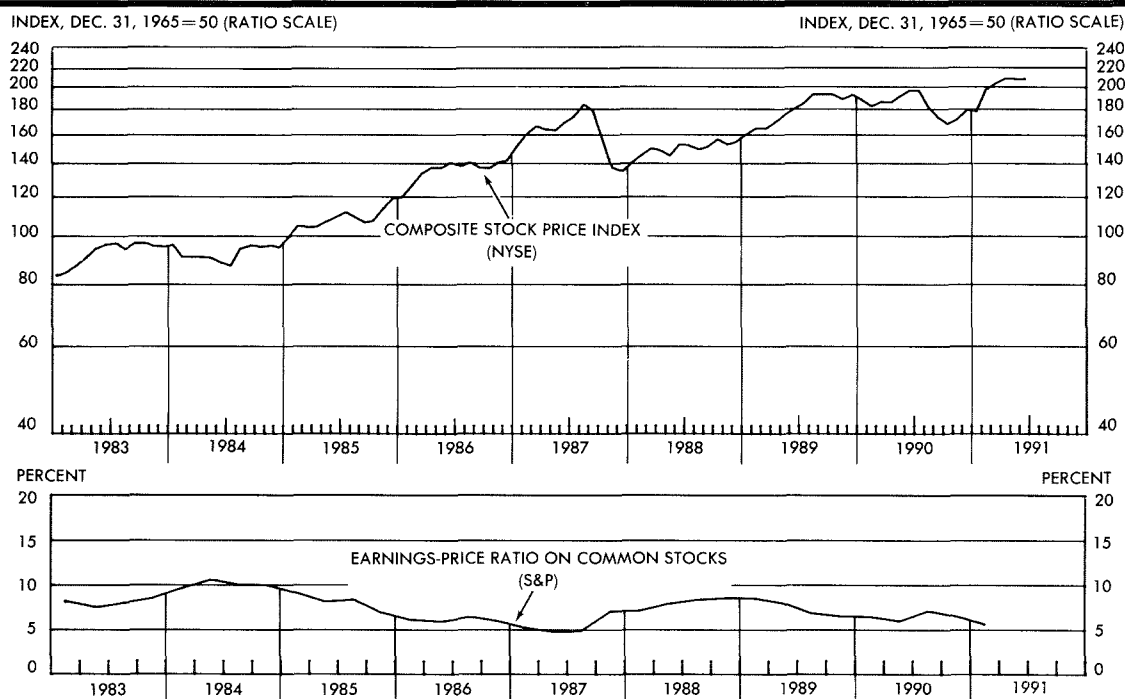

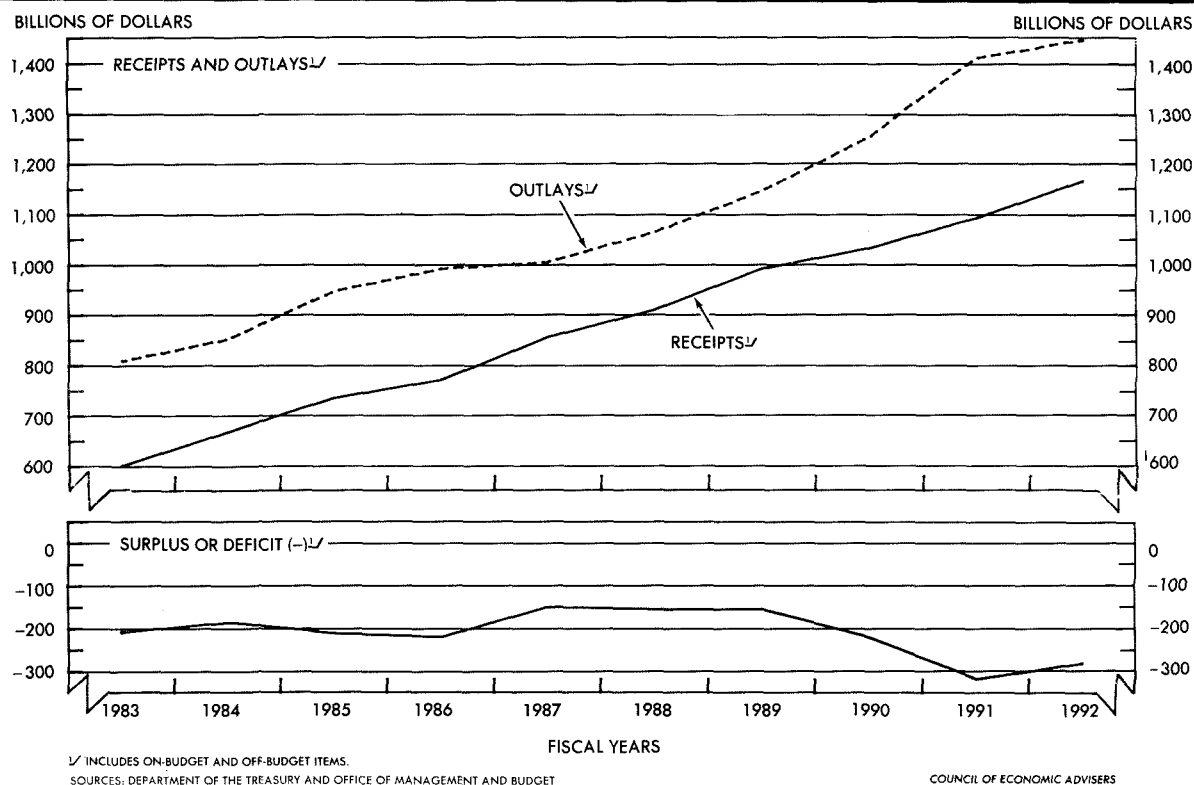

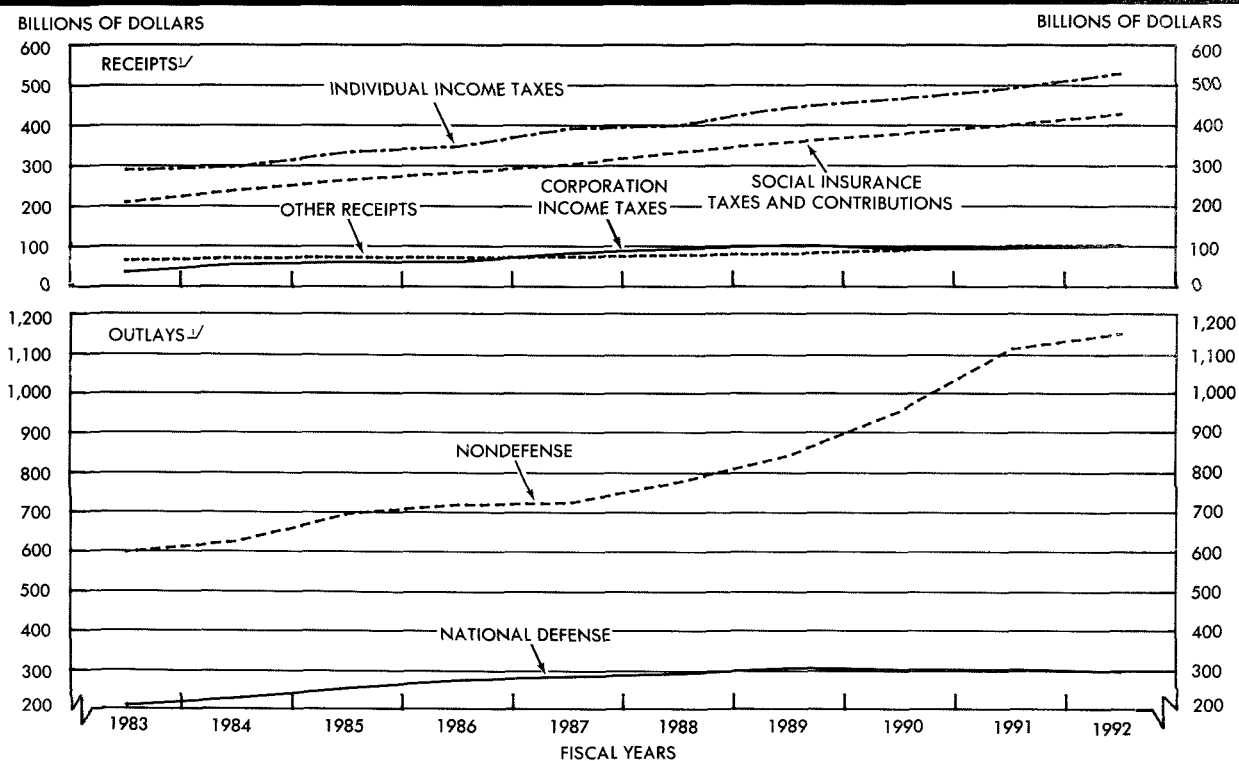

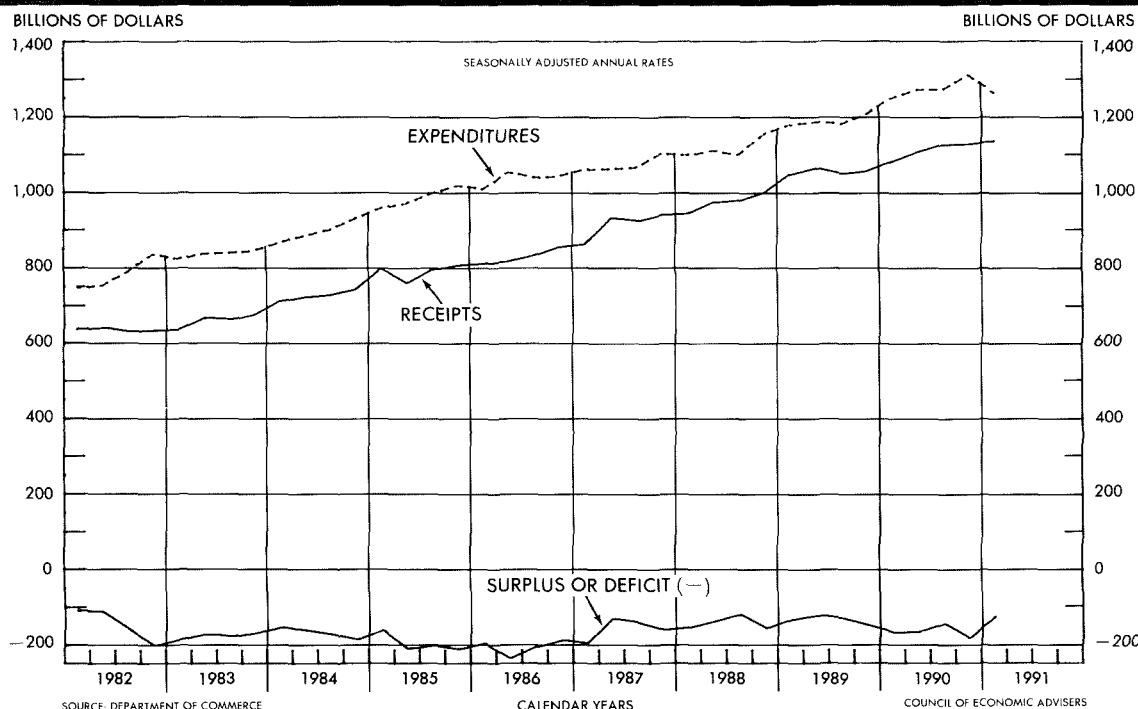

In the first quarter of 1991, there was a current account surplus of \$10.2 billion, the first surplus since early 1982. The surplus was largely due to cash contributions from coalition partners in Operation Desert Storm. (Series revised.)

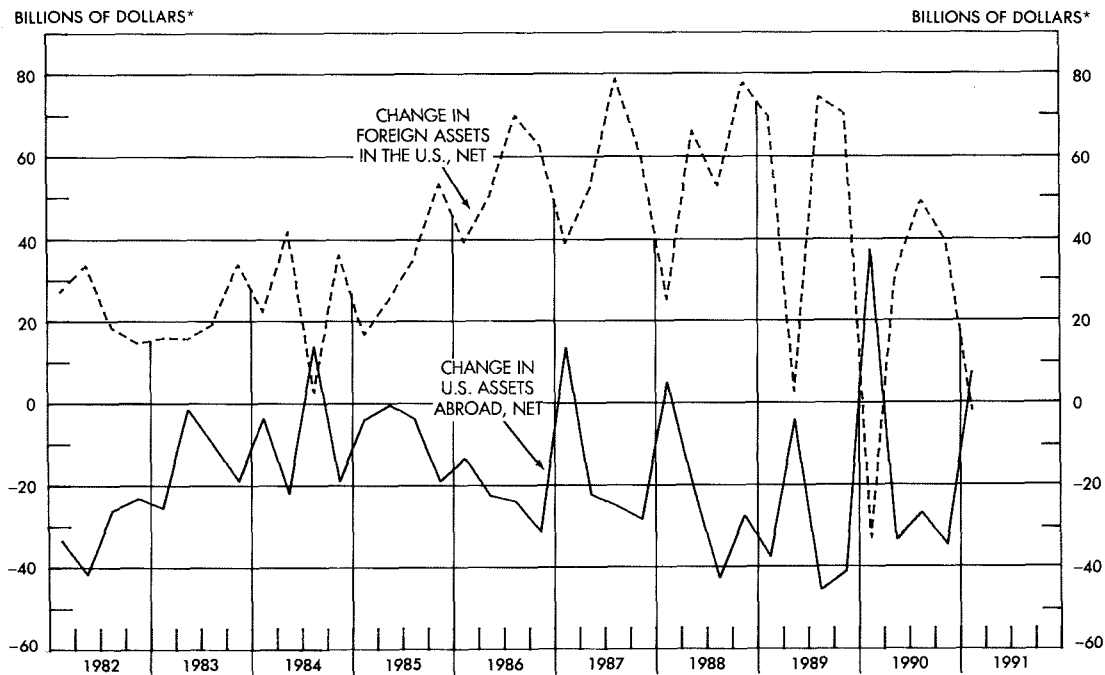

In the capital accounts, claims on foreigners reported by U.S. banks decreased \$23.9 billion in the first quarter of 1991, compared to an increase of \$24.5 billion in the fourth quarter of 1990. Liabilities to private foreigners reported by U.S. banks, excluding Treasury securities, decreased \$19.4 billion in the first quarter, compared to an increase of \$17.3 billion in the fourth quarter.
