BANK DEBITS

Debits to individual accounts, as reported to the Federal Reserve Board by banks in leading cities for the week ending May 20, aggregated \$11,446,000,000 or 14.6 per cent above the total of \$10,925,000,000 reported for the preceding week. New York City reported an increase of \$228,000,000, while other large increases were as follows: Boston \$55,000,000, Philadelphia \$41,000,000, Detroit \$31,000,000, Chicago \$29,000,000 and San Francisco \$17,000,000.

As compared with the week ending May 21, 1924, debits for the week under review show an increase of \$1,456,000,000 or 14.6 per cent. Substantial increases are shown for most of the more important centers, the largest increases being as follows: New York City \$890,000,000, Boston \$82,000,000, Chicago \$79,000,000, Philadelphia \$61,000,000, San Francisco \$22,000,000, and Baltimore, Cleveland and New Orleans \$20,000,000 each.

Aggregate debits for 141 centers for which figures have been published week after January, 1919, were \$10,778,613,000, as compared with \$10,278,648,000 for the preceding week and \$9,380,684,000 for the week ending May 21, 1924.

Debits to individual accounts were reported to the Federal Reserve Board for banks in 256 centers, of which 252 are included in the summary by Federal reserve districts.
