SUBJECT: Proposed transfer to National Archives of pre-1955

FOMC files

In 1974 the Board approved transferring custody to the National Archives of a large volume of pre-1955 subject files of historic value. Except for a limited number of restrictions, these files will be available for inspection by the public.

It is recommended that, as part of this transfer of records, the bulk of pre-1955 files of the FOMC (about 29 cubic feet of material) also be transferred to the National Archives. Since Archives is given custody of the official minutes of the Committee (with a five-year lag), it seems appropriate for related records to be transferred. The files proposed for transfer are listed in an attachment.

Staff at the Board have reviewed the pre-1955 Committee files. Copies of a number of items relating to the internal operations of individual Government securities dealers, some of which reflect unfavorably on the dealers, were sent for further review to Mr. Holmes, Manager of the System Open Market Account. It was his

judgment that making such material freely available to the public could diminish the future willingness of the firms involved to provide information regarding their operations. Governor Holland is in agreement with this position. Accordingly, we propose to specify that public access to the items in question relating to dealers shall be granted by Archives only upon authorization of the Secretary of the FOMC.

Members of the Committee are asked to indicate by September 19, 1975, whether they concur in the recommended transfer, subject to the indicated restriction.
