
Dear Chairman Burns:

As you know, I have for some time advocated that presidents of Federal Reserve banks be appointed by the President of the United States, with Senate confirmation, because of their substantial function in the formulation and execution of governmental policy.

The recent decision of the United States Supreme Court in *Buckley v. Valeo* seems to me to raise a serious question as to the constitutionality of their continued service as voting members of the Federal Open Market Committee under the present procedure for their selection.

Since this is a question which only the courts can answer, I have initiated a legal action to enjoin them from serving on the Committee. I trust you will assure the members of the Committee who are named as defendants that this action is in no way a reflection on them. Its sole purpose is to bring about a prompt, definitive resolution of a serious constitutional issue.
