Nith the resignation of Mr. Allan Sproul from the Presidency of the Federal Reserve Bank of New York, and his return to California, has come his decision that he can no longer carry on the active chairmanship of the Committee on the History of the Federal Reserve System.

Under those circumstances, and with great regret at losing so valuable a chairman, the Committee has decided to accept the offered hospitality of the Brookings Institution and to move its office and its research activities to Washington. A new chairmen has not yet been chosen, but the work will go forward there under the broad supervision of the President of the Brookings Institution, Br. Robert B. Calkins, who is also an active member of this Committee.

As my own home is in New York City, this move necessarily marks the severance of my connection with the Committee in the capacity of its Research Director. I think you know how much I have enjoyed this inquiry into the history of the System, and particularly that part which brought me into contact with the Federal Reserve Bank of Cleveland. It is good to know that we can continue to look forward with great interest to the result of future research to follow under the scholarly auspices of Brookings.

For much courtesy shown to me in Cleveland, I want to thank you most warmly. You and the limison officer appointed there, with other members of your staff, have been continuingly kind and cooperative. I am sure that that cooperation will be extended to my successor at Brookings.

In the process of completing our file on men who have served as Federal Reserve Bank officers, we would be most grateful for your further aid.

Our listings of Vice Presidents (and Deputy Governors) of the Federal Reserve Bank of Cleveland over the years still has holes in it. Thanks to your cooperation, we have information on many of them, but we need some way of checking those who are still missing. Would you, therefore, be kind enough to send us a list of all Vice Presidents (and Deputy Governors) who have served in the Cleveland Bank since the beginning? We would like to have with their names the dates of their service in the Bank, and also the dates of their various officerships. This will enable us to check off those for whom our information is already complete and to start the search for biographic data on those now missing in our records.

Dear Mr. Flinkers:

As liaison officer appointed by the Federal Reserve Bank of Cleveland to deal with this Committee, you probably know that one of our most difficult problems has been that of preparing a list of specific records which, chosen from the mass of material handled in the Reserve Bank, can be labelled as having historical value and therefore being worthy of long retention.

After a series of visits made to the twelve regional banks and of consultations kindly made possible during those visits, we realize that some of the valuable early material has already been discarded in some of the Federal Reserve Banks and is lost to us. The best we can hope is that what is still left will be retained, whether it is in general "uncurrent" files, or in departmental files, or in the private files of older officers.

In the above connection, the Subcommittee on Destruction of Records which, I understand, functions under the Committee on Miscellaneous Operations of the Conference of Presidents, was given the assignment of conferring with the staff of this Committee with a view of developing guides and standards for the preservation of historical material by the Federal Reserve Banks. As you know, Mr. P. Breidenbach represents the Federal Reserve Bank of Cleveland on that Subcommittee.

At the meeting of the Subcommittee held in New York on October 5-7, 1955, I conferred with the members of the Subcommittee and we then developed jointly the attached list of records and other papers which is suggestive of the types of material our Committee is seeking to preserve for historical purposes.

While the Subcommittee has informed me that the material here referred to will form a part of its next report to the Committee on Miscellaneous Operations, I am hopeful that, in the meantime, such material will prove helpful to you in deciding upon the propriety of the disposal of particular records.

I think you know, from a letter which Mr. Allan Sproul recently wrote to Mr. Fulton, that this Committee now has its five-year grant and is ready to embark on the definitive study of the Federal Reserve System for which the grant was made.

That phrase "carefully selected" refers, of course, to caliber of mind and skill - we have every desire to include men of many opinions, including those who have shown themselves critical.

What we aim at is a list of the top 150 to 200 men in the country who are actively interested in studying various phases of the System and we are most anxious to include a proper proportion of those in the Cleveland district. We will be very grateful for your cooperation in this.

Dear Mr. Fulton:

Several months have elapsed since you so kindly furnished this Committee with materials on the Cleveland Bank. In the interim Miss Adams has devoted much time to interviewing persons now or formerly with the Reserve System and in locating, listing, and to some extent acquiring collections of private papers and other materials which should be useful to the outside scholars who will undertake the writing of a series of historical studies under the guidance of this Committee.

The initial explorations and findings have been sufficiently promising so that the Rockefeller Foundation has now made a second and larger grant—to extend over a five-year term—to continue and enlarge the research project now well under way. Miss Adams is very anxious, at the outset of this second phase, to visit the Reserve Banks in the Middle West. Thus far, because of limitations of time and the burden of organizational details, her field trips have been confined to the East—including the Board in Washington, the Reserve Banks in Boston, Philadelphia, and Richmond, and to nearby universities. Her plans are still only tentative, but she hopes very much to leave for St. Louis around the middle of July, going on from there to Cleveland and to Chicago.

She has asked me to send you this note to inquire whether you expect to be in the Bank during that period and, if so, to ask whether it would be convenient for you to see her. She would also like to talk with some of your senior officers and with members of your research and library staffs. She would welcome any suggestions of others whom she should see in the neighborhood of Cleveland, such as former bank officials now retired, who might have valuable recollections of the earlier days of your Bank. In view of the many uncertainties caused by summer vacations, she would like, if you are agreeable, to

leave the arrangement of her schedule of appointments in Cleveland in your hands. She will let you know when the details and time schedule of her trip have been worked out with the St. Louis and Chicago Reserve Banks.

Dear Mr. Fulton:

On behalf of Miss Adams, I should like to thank you for your letter of March 15th. We shall be very pleased to have the biographical data which is being compiled in response to our request.

We are indeed glad to know of the existence of the volumes of clippings and exhibits you mention. At present, we are only in a preliminary mapping and survey phase and just beginning to work on the broad outlines of a much longer and more extensive research program. Our main focus now is on locating and listing materials at the Board, in the individual Reserve Banks, as well as collections of private papers reposing in university libraries to see how much useful material we can turn up as a basis for later historical studies. Miss Adams had been hoping to visit Cleveland and other Reserve Banks in the West during this exploratory period but finds she has to postpone longer trips until a later date. She is of course much interested in the ring binders you mention, and we are wondering whether you might not have available for our use a subject index of their contents and/or a chronology of the main events in the history of your Benk.

It would be helpful if we could call upon your research staff or library for a bibliography of source materials relating to the establishment and operations of the Cleveland Bank, and possibly also of important published studies or notable (unpublished) memoranda prepared by your economics staff. We have a real interest also in public speeches given by top Federal Reserve officials and economists and would be glad to know whether your library has a cumulative index of important addresses of persons now or formerly connected with the Cleveland Bank.

This seems like a formidable request, but I hope you will not try to go beyond providing us with whatever descriptive materials you already have on hand relevant to Reserve System history in general and that of the Cleveland Bank in particular which could be passed on to us for inventory purposes.
