With the resignation of Mr. Allan Sproul from the Presidency of the Federal Reserve Bank of New York, and his return to California, has come his decision that he can no longer carry on the active chairmanship of the Committee on the History of the Federal Reserve System.

Under those circumstances, and with great regret at losing so valuable a chairman, the Committee has decided to accept the offered hospitality of the Brookings Institution and to move its office and its research activities to Washington. A new chairman has not yet been chosen, but the work will go forward there under the broad supervision of the President of the Brookings Institution, Dr. Robert D. Calkins, who is also an active member of this Committee.

As my own home is in New York City, this move necessarily marks the severance of my connection with the Committee in the capacity of its Research Birector. I think you know how much I have enjoyed this inquiry into the history of the System, and particularly that part which brought me into contact with the Federal Reserve Bank of St. Louis. It is good to know that we can continue to look forward with great interest to the result of future research to follow under the scholarly auspices of Brookings.

For much courtesy shown to me in St. Louis, I went to thank you most warmly. You and the liaison officer appointed there, with other members of your staff, have been continuingly kind and cooperative. I am sure that that cooperation will be extended to my successor at Brookings.

Dear Mr. Deming:

In the process of completing our file on men who have served as Federal Reserve Bank officers, we would be most grateful for your further aid.

Our listing of Vice Presidents (and Deputy Governors) of the Federal Reserve Bank of St. Louis over the years still has holes in it. Thanks to your cooperation and that of Mr. Abbott, we have information on many of them, but we need some way of checking those who are still missing. Would you, therefore, be kind enough to send us a list of all Vice Presidents (and Deputy Governors) who have served in the St. Louis Bank since the beginning? We would like to have with their names the dates of their service in the Bank, and also the dates of their various officerships. This will enable us to check off those for whom our information is already complete and to start the search for biographic data on those now missing in our files.

One point that has given us trouble is the office of Cashier. We have found that in some Federal Reserve Banks the Cashier is a Vice President (in which case we want to include him as such); in other banks the office of Cashier ranks below a Vice Presidency. This practice may have varied with the years, but our present interest is in only those who have ranked or do rank as Vice Presidents (or Deputy Governors).

Dear Mr. Deming:

As liaison officer appointed by the Federal Reserve Bank of St. Louis to deal with this Committee, you probably know that one of our most difficult problems has been that of preparing a list of specific records which, chosen from the mass of material handled in the Reserve Bank, can be labelled as having historical value and therefore being worthy of long retention.

After a series of visits made to the twelve regional banks and of consultations kindly made possible during those visits, we realize that some of the valuable early material has already been discarded in some of the Federal Reserve Banks and is lost to us. The best we can hope is that what is still left will be retained, whether it is in general "uncurrent" files, or in departmental files, or in the private files of older officers.

In the above connection, the Subcommittee on Destruction of Records which, I understand, functions under the Committee on Miscellaneous Operations of the Conference of Presidents, was given the assignment of conferring with the staff of this Committee with a view of developing guides and standards for the preservation of historical material by the Federal Reserve Banks. As you know, Mr. J. J. Christ represents the Federal Reserve Bank of St. Louis on that Subcommittee.

At the meeting of the Subcommittee held in New York on October 5-7, 1955, I conferred with the members of the Subcommittee and we then developed jointly the attached list of records and other papers which is suggestive of the types of material our Committee is seeking to preserve for historical purposes.

While the Subcommittee has informed me that the material here referred to will form a part of its next report to the Committee on Miscellaneous Operations, I am hopeful that, in the meantime, such material will prove helpful to you in deciding upon the propriety of the disposal of particular records.

Thank you for your very pleasant letter of September 1. I believe our severe heat is gone for this year and certainly join you in the hope that autumn can repay us in part for the rather unpleasant days of August.

In connection with the money flows project carried on here, it is perhaps most accurate to say that it is both a "local project" and one "inspired by suggestion from the Board." We are one of very few banks that has attempted to apply the national accounting techniques to their district areas. In the case of the income and product analysis, the input-output measurements and the measurement of money flows we lean heavily upon the national results, modifying the conceptual techniques only where such modification is necessary to adapt the process to a segment of the national economy.

Our work in these areas we group under the heading of regional economic analysis. The Bank's research in this area has been fruitful and has provided us with better measures of the levels of economic activity in our 363 counties and, more particularly, in the inter-relationships between the strategic groups making up the district economy and the relationships of these groups with the rest of the nation and world.

I would be delighted to talk with you for as much time as you would care to listen on this subject when we next get together, wherever that may be.

Dear Mr. Abbott:

Your letter of July 15th has been on my desk too long, but we too are in the midst of personnel shortages (holidays hit a small office very hard).

You ask how long the Committee may be in the "sorting-out stage" so far as monographs and authors are concerned. That is a hard one to answer, as there may be various steps in this process. So far as I can tell, They would hope by October 1st to have the main pattern of the monographs laid down, but that does not mean that they would not accept a particularly interesting idea if it came later. The project presumably has a life of five years, and it is entirely possible that something might come along for the fourth or even for the fifth year which was particularly interesting and should not be refused merely because it came a bit late.

As for the amount of time that it would take an author to do a monograph of the type the Committee has in mind, that is harder because it depends both on the subject and on the author. In general, the assumption seems to be that these would probably average a year or so, but there again if the subject

were dowered with brevity and the author a quick worker, it might come under that. Both these considerations lead me to the further suggestion that if a monograph subject particularly interesting to Mr. Robertson is of the type that would make it part of the main pattern of monographs which the Committee has in mind, it probably should be suggested to them fairly early. If, on the other hand, it was of a more technical type, representing a piece of research in depth on a particular subject, they might likely entertain the idea for later performance.

All this is general and highly unofficial. I am sending it to you merely in an attempt to answer what I assume to be your own dilemmas.

I hope the heat is not too tough this year and that all goes well with you.

 $\,$  My apologies for the delay in replying to your letter of September 21.

We are enclosing a list of names of teachers of money and banking at colleges and universities in the Eighth Federal Reserve District who are actively interested in studying the Federal Reserve System.

While there are nine names on the list, I would like to point out that a considerable gap exists between the top three and the others. You are familiar, of course, with Dr. Wood's work at Harvard on English central banking; Dr. Hochwald, for the past seven years, has been closely associated with the research activities of this Bank; Dr. Bothwell's dissertation was on the history of the Federal Reserve Bank of St. Louis. Depending upon how close you meant the screening process to be, perhaps only these three names should be submitted to you. There is no question in my mind with respect to the ability of any of the remaining six to do a creditable research job or as to their interest in the Federal Reserve System, and they would, of course, be interested in knowing about the project on the history of the Federal Reserve System. I believe, however, that the last six named men have specialized less in the Federal Reserve System than the first three. Perhaps the lack of specialization in central banking history and problems that bothers me with reference to the other six merely reflects the fact that a great many of the institutions of higher learning located in

the Eighth Federal Reserve District are small and teachers in these institutions are called upon to cover more territory in a school year than is the case in the larger universities. Having made my reservations clear, I believe that it is in order to include the names of the nine men on the list for your Committee to contact.

Again, let me apologize for the tardiness of the reply and extend my kindest personal regards.



Dear Miss McKinstry:

Mr. Johns has handed me your letter of June 4, concerning the prospective visit of Miss Mildred Adams to the Federal Reserve Bank of St. Louis and her inquiry as to available material in connection with her study of the history of the Federal Reserve System.

We shall be glad to have Miss Adams visit the bank. There is a possibility that Mr. Johns may be away from the bank during the week of July 11, but I will be here during all of the first part of July, as will most of the other senior officers. Miss Adams will be able to talk with any of us, as well as with members of the Research and Library staffs.

I am having pulled together some of the material which you request in your letter and will send it to you as soon as we have it in form for transmission. The biographical data which we have available on directors and officers is rather skimpy, but we are running our records to give you what there is.

Miss Adams probably will find it helpful to go over a doctoral dissertation by Wilbur C. Bothwell, presently Professor of Economics at Drury College, Springfield, Missouri. Some twelve or fifteen years ago, Mr. Bothwell wrote his thesis on the Federal Reserve Bank of St. Louis, and it contains some material which should prove useful in the research study.

You mention that you have already communicated with Mr. William McC. Martin, Sr. and I assume he will be delighted to visit with Miss Adams. Mr. Chester Davis no longer lives in St. Louis, and if Miss Adams wishes to see him, she will have to catch him on one of his trips East or visit him in Southern California where he now lives. I think she may find it helpful to visit with Mr. Clarence M. Stewart,

As Mr. Sproul wrote you on February 13, Miss Mildred Adams, Research Director for the above Committee, has, under an initial short-term grant from the Rockefeller Foundation, been engaged in interviewing persons connected with the Reserve Board and various District Banks and in locating and listing source materials which may be of use to the scholars who will eventually be commissioned to undertake the actual historical studies.

Until now, her field trips have been confined to the Eastern seaboard—Board and Treasury officials in Washington, the Reserve Banks in Boston, Philadelphia, and Richmond, as well as a number of economists in nearby universities. Now that the Rockefeller Foundation has made a new and larger grant, to extend over a five-year period, she is in a position to carry her explorations farther afield. She is hoping to be able to work out, despite the obstacle of summer vacation schedules, a triangular trip in early July to include a visit to your Bank as well as to the Reserve Banks in Cleveland and Chicago.

She has asked me to send you this note to find out whether you expect to be in the Bank at that time, whether it would be convenient for you to see her during her stay, and to ask whether you, or someone whom you may designate, will be kind enough to set up appointments for her to talk with some of your senior officers as well as with members of your research and library staffs.

In advance of her trip, she would find it most helpful if you could have sent to us (1) whatever biographical data you may have available on Chairmen of your Board, Directors, Presidents (or earlier Governors), senior officers, and Federal Reserve Agents of your Bank; (2) suggestions of the names of persons in the vicinity with whom you think it would be worth while for her to talk, such as Mr. William McC. Martin, Sr. (with whom we have already communicated), Mr. Chester Davis, etc.; (3) an

inventory, if available, of the materials by subject headings contained in your permanent central archives; and (4) a bibliography of principal source materials on the St. Louis Reserve Bank.

All this may add up to an enormous request for assistance. We trust you will not take it too literally but regard it only as a rough guide to the sort of materials we are at present seeking, and that you will make available to us whatever you can conveniently provide without imposing an additional burden on your research staff.
