The pre-Federal Reserve period is covered by complete file of National Monetary Commission reports, the report of the Money Trust Investigation of 1912-13 and reports of the Secretary of the Treasury 1790 to date, and other long runs of government reports and of financial periodicals such as Merchants Magazine and Commercial Review 1839 to 1870, Commercial and Financial Chronicle 1866 to date, and others.


