Meyer, was appointed as Acting Asst. Cashier at the Los Angeles Branch and on Jan. 1, 1925 Assistant Cashier.

Resignation of Henry C. Breck as Assistant Federal Reserve Agent and Secretary of The Board of Directors, effective Nov. 30, 1924, to become Executive Assistant to Mr. S. Parker Gilbert, Agent General for Reparations under the Dawes Plan.
