An analysis of the extent to which a bank may increase its loans as a result of a given increase in its reserves, borrowed from a Federal Reserve Bank. Contrary to the opinion of Prof. Phillips on the same subject, the conclusion is reached that loans may be increased to a considerable extent in excess of borrowed reserves so that increases in the discount rates of Reserve Banks can have little effect in restricting credit extended by member banks.
