The increase of statistical data, the improvement of statistical technique, and the endowment of social research are enabling a larger use of quantitative analysis. Because of the difference between the conception of nature borrowed by qualitative theory from Newtonian mechanics and the statistical conception of nature quantitative theorists usually find it necessary to formulate problems in a way different from that adopted by qualitative theorists, making the treatment of behavior more objective, emphasizing the importance of institutions, and promoting the development of an experimental technique.
