German monetary troubles arise from the overissues of inconvertible paper, the emission of which must be halted before real progress can be made. The huge demand debt should then be funded into long-term bonds to be exchanged only for paper marks. The bonds might bear no interest for the first year or two, then 1 per cent and so on, gradually increasing. The exchange for marks could be offered at a rate slightly above their current value, the price to be raised as the mark rises in value.
