

The case of McDonald, Receiver, v. Dewey, 202 U.S. 510, did not involve a holding company. Instead, it involved the liability of a person who, with knowledge of the bank's insolvency, transferred national bank stock to insolvent persons, the court holding that the gist of the liability was the fraud implied in selling the stock with notice of the insolvency of the bank.
