

Dear Mr. President:

Confirming the oral statement which I made to you in behalf of Judge J. J. Thomas, who has been suggested for appointment as a member of the Board of Governors of the Federal Reserve System, I wish to express again my very deep interest in his selection.

Since I talked to you on the subject I have had occasion to sound the sentiment of leading citizens in all walks of life in Nebraska and other mid-western States. All who are acquainted with Judge Thomas are convinced that by training, education and experience he is qualified to render an increasingly valuable service in the position which he seeks. Those of us who live in Nebraska, and have known Judge Thomas intimately through the years, are very certain that his appointment would be a fitting one.

I know that you have been giving this matter your serious attention, and I merely want to reemphasize the very high respect in which I hold Judge Thomas and the strong belief that I entertain that he is exceptionally well qualified and deserving.

I am dictating this letter in your office because, since my arrival here, I find the President is planning to leave for Warm Springs tomorrow or the next day and, knowing as I do the many pressing matters that are upon him, I hesitate to ask for a conference, which I expected to do when I came to the city. So I am imposing upon you to see that this letter is placed in the hands of the President.

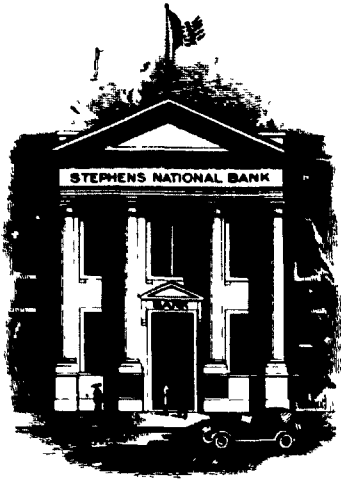
As you are aware, the banks in which I am interested are all in the Tenth Federal Reserve District. Because of this fact, I have had occasion to see a great deal of Judge J. J. Thomas, now a member of the Federal Reserve Board. The last few years I have been a member of the Federal Advisory Council and have had many contacts with both the full Board and particularly with Judge Thomas, who lives in the State Nebraska which is a part of the Tenth District.

As a banker and a farmer and as a member of the Federal Advisory Council from my District, opportunity has been offered me to judge the character and fitness of Judge Thomas for appointment as one of the Governors of the Federal Reserve Board. Aside from being one of the prominent lawyers of his state, he has been active in agricultural pursuits for thirty years. He is regarded as an authority on agricultural and livestock problems and I shall be sorely disappointed if the fine work he has done as a member of the present Federal Reserve Board is not recognized by the President with the reappointment of Judge Thomas.

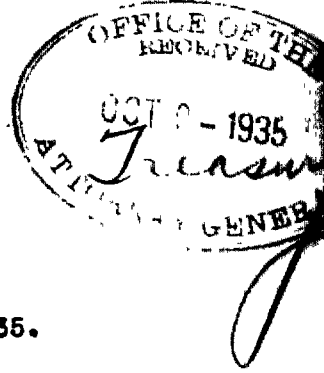
