(If Foster and Myers both out, Goss might be named from D.C., Dist.5-his home being in 12th District before he came to Washington---with Shaum named from 8th Dist.)

## LELAND EVERETT CALL

Republican; age 55; President, Federal Land Bank, Wichita, Kansas; Professor of Agronomy, Dean of Agriculture at Kansas State College; not a dirt farmer, but highly trained expert; "Roosevelt Republican." See separate memo.

#### FRANCIS W.PECK

Democrat; age 50; suggested by Gov. Myers; Professor at Univ. of Minnesota; Cooperative Bank Commissioner of Farm Credit Administration until Dec. 31, last, when his leave from his university expired. See separate memo.

#### GUINN WILLIAMS

Democrat; age 64; suggested by or through Sen. Glass; was in Congress lOyears; was in cattle and mule business.

## JOHN SHARY

Mission, Texas; real estate promotor -- not a dirt farmer. See attached letter from Gov. Myers.

Oklahoma City; also a promotor in Rio Grande real estate. See Gov.Myers letter. Also wire from Oklahoma City Branch of Fed.Res.Bank.

Although he had some mishaps, due to financial conditions, is making progress in reducing the mortgage indebtedness which is held by the Federal Land Bank of St. Louis.

"Mr. Shaum married the daughter of William M. Rankin, deceased, who was a very prominent man in northwestern Missouri. Shaum has a fine reputation and is considered one of the ablest farmers in that section. Probably is a director of a small bank in Tarkio, but is not thought to have other corporate connections. Has always been a leader in agricultural organizations in that section. Does not have an active interest in politics, but is probably Republican and is reported to be conservative in tendencies.

"This information was obtained through the Farm Credit Administration at St. Louis from a bank officer in that city who is a native of Tarkio and who has known Mr. Shaum for many years. It has also been checked against records in this office, since Mr. Shaum was considered for appointment as a director of the Federal Land Bank of St. Louis some time ago. Judging from his educational background and experience, Mr. Shaum would be a typical, intelligent, reasonably successful farmer, although his operations are much larger than average."

Secretary Wallace, in a telephone conversation, said:

Mr. Shaum is about 45; from a standpoint of economic reasoning is splendid; lives in town, but owns 1000 acres of farm land; dresses very well; man of strong personality; was a bank director at one time; has mortgage on farm, but if land sold would have some money left after clearing all debts; practical farmer and livestock man — feeder.
