Any reports circulated to the effect that the government is favorable to high interest rates is the exact contrary to the truth. So far as the Treasury is concerned and the Federal Reserve System, the declared policy is for orderly conditions in the money market and the maintenance of an adequate supply of funds at reasonable rates to call forth and facilitate production and distribution.
