It appearing further that by reason of said amendment there is no longer any issue with respect to the matters referred
to in sub-paragraphs (4) to (10) inclusive, of Section II of the Supplemental Amended Order for Hearing herein dated \#ovember 22, 1940;

It is therefore ordered that said sub-paragraphs (4) to (10) inclusive of Section II of said Supplemental Amended Order for Hearing be and the same are hereby dismissed from this proceeding by atriking said, sub-paragraphs from said Supplemental Amended Order for Hearing, and that said Supplemental Amended Order for Hearing be and the same hereby is amended accordingly.

## PROPOSED RPESS RELREASE

The Securities and Exchange Commission announced today that Transamerica Corporation had filed with it an amendment to the Application for Registration of its $\$ 2$ par value capital stock on the New York, San Francisco, and Los Angeles Stock Exchanges in the form of footnotes relating to the Reports of Condition and of Earnings and Dividends of the Bank.

The filing of these footnotes has resulted in the dismissal from the Commission's pending proceeding against Transamerica Corporation under Section 19 (a) (2) of the Securities Exchange Act of 1934 of Paragraphs 4 to 10 of Section II of the Supplemental Amended Order adopted by the Commission on Movember 22, 1940, relating to the Report of Condition of the Bank of America N. T. \& S. A. as of December 31, 1936, and the Report of Earnings and Dividends of that bank for the years 1934, 1935, and 1936. These are the only Reports of Condition and of Earnings and Dividends of the Bank filed with the Commission as part of Transameriea Corporation's Applieation for Registration.

The Commission further announced that the remaining issues in the proeeeding would be disposed of in regular course and that to that end conferences were being held between counsel with a view to determining whether the facts relative to some or all of the remaining issues can be stipulated by agreement between Transamerica Corporation and the Commission.
