Dear Marriner:

The best meeting of all of the meetings thus far held took place yesterday morning at eleven a.m. at the offices of the Wartime Civilian Control Agency at the Whitcomb Hotel, and those in attendance were: Colonel Bendetson; his aides, Mr. Miller of Social Security, Mr. Hewes of Farm Security, and Mr. Evans, assistant to Colonel Bendetson; Mr. Nicholson, of W. P. A. (he will manage the reception centers); Captain Moffitt; Tom Clark; President Day, Vice President Hale, and Mr. Armstrong, of the Federal Reserve Bank; Dr. Dedrick, statistician from Census; and others who came in from time to time.

The charts which I sent to you on Saturday were discussed in detail and the various phases of the evacuation program were explained. We are now in Phase One--the voluntary phase. We shall, however, shortly pass into Phase Two, the evacuation phase, in which the evacuees will be prepared by examination and otherwise for departure to reception centers.

It is contemplated that this second phase will begin shortly. A statement will be made by General DeWitt followed by specific explanations from Colonel Bendetson. Registrations of evacuees will begin in the various offices along the coast, principally in the Seattle and Los Angeles areas.

Each group represented at the conference yesterday will have a specific job to do, and each group will have representatives in each of the eighty or more offices that are now opening. Most of these offices are already operating under the United States Employment Service and some, as you know, under the Federal Reserve Bank. Those offices that are now operating will be implemented with the necessary representatives of the Social Security, Farm Security, and the other agencies, military and Federal Reserve, plus such other groups as may be required in the program. There has been a definite coordination established and forms have been adopted.

I am enclosing herewith a list of all of the offices. Men are being hired and sent to the offices this morning.

The War Department will have funds available for crop loan purposes and for other purposes that may be required to expedite the program.

To a question asked as to how long these offices will have to remain open, Colonel Bendetson answered at least three months and perhaps six.

It was also pointed out that as the evacuees are moved the offices may have to move with them wherever they go to handle matters of property. Some of the evacuees will be sent ahead to the camps. These will be mainly carpenters, cooks, etc., and they will aid in setting up the camps.

The conference began at eleven a.m. and ended about three-fifteen p.m.

Today I plan to see Dr. Woods, of the University of California, Mr. McIntosh, of The Bank of California N. A., Colonel Bendetson, and others. I also plan to talk with Mr. Grady on the telephone if he is still here.

One of the suggestions made at the conference yesterday was that there would be need for a bank at the reception centers. I suggested that in place of a bank the army establish a currency depot and offer such services to the evacuees as are required, and that the Federal Reserve Bank would cooperate. Mr. Day agreed with me. We shall work out all the details of this arrangement today and tomorrow. Plan to spend considerable time at the office in the Financial Center Building where the Federal Reserve organization has its general headquarters.

Mr. Hale is leaving with us for Los Angeles this evening. Most of the Treasury men are gone. The remainder will leave with me for Los Angeles and Washington.

We'll spend about three days in Los Angeles. We plan to leave there by plane about four-thirty Thursday and will be in Washington, unless grounded, about noon Friday.

We'll stop at the Biltmore in Los Angeles.

The whole job is going right ahead, and since we have been here many matters have been cleared up and rapid progress has been made. The Federal Reserve Bank is doing an excellent job.
