My dear Mr. Smith:

In your letter of March 18, 1944, you enclosed a copy of a report. "Recording and Reporting of Lend-Lease Transactions and Government Expenditures Abroad", prepared by an Interdepartmental Committee for transmission to the Senate Appropriations Committee. I much appreciate your thoughtfulness in sending me a copy of this report and I am informed that it reflects a very high quality of workmanship. We are very definitely interested in seeing some agency of the Government made responsible for the preparation of coordinated reports on government transactions having an international character. Such information would be immensely helpful to us in studying the present and future problems connected with international monetary stabilization, international investment, and other aspects of our foreign financial relationships. I am hopeful that the Committee's report will be acted upon favorably and that any reports compiled in the form suggested will be made available to us on a regular basis. In particular, we would hope that statements of government transactions with foreign countries, drawn according to the outline suggested on page 19 of the Committee's report, might be made available on a monthly or quarterly basis.

We have been much impressed by the great care and attention to detail which is manifested in the report and heve only one or two suggestions for further study which relate to additional matters not fully covered by the report. I refer to two special types of government expenditures abroad, i.e. the disbursement of occupation currency in territories occupied by our armed forces, and the sale of gold by the United States Treasury in the open markets of various countries, notably in the Middle East. It would appear that foreign disbursements of these two types find no place in the statement of government transactions as formulated by the Committee. They are nonetheless of considerable and growing importance and I believe that the Committee should give thorough consideration to their inclusion in the terms of reference of the proposed central clearinghouse.
