Analysis of above figures shows (1) that the per diem claimed by Mr. Vardaman in the last ten months exceeded by \$155 the per diem claimed by Mr. Eccles during the last ten years and (2) that the total travel expenses claimed by Mr. Vardaman in the last ten months is equivalent to 65% of the total expenses claimed by Mr. Eccles in the last ten years.
