This is to acknowledge your letter of July 15 enclosing the one from Mr. Kindig and your reply of July 15. I enclose additional copies of the two letters I sent you yesterday in case you feel like passing them on to this correspondent, but I agree with you that it is probably a waste of time. A few people here and there, deluded by Pather Coughlin and his kind, have become obsessed with this idea.
