BOARD OF GOVERNORS OF THE FEDERAL RESERVE SYSTEM

De Federal Credit Union is not controlled or governed by either the Federal Reserve Board or the Federal Reserve Banks. In fact the Union here is a mere branch or member through having applied for membership and paid the dues; and the Federal Resere Banks are not members — any credit union they have is what each bank may have organized for its own employees.

The Federal Credit Union was passed on by Congress and chartered under the Farm Credit, where the headquarters are and whose auditors make periodic examinations of the membership unions. I understand there are about 6,000 member unions comprised of government agencies, churches, civic and other groups. No doubt the Rev. Augustus Cook mentioned in Sen. Tydings' letter represents a church group member union.

This letter, therefore, should have gone to the Farm Credit for comment, instead of to the Rederal Reserve. Do you wish it returned to Senator Tydings with the suggestion he take the matter up with the Farm Credit?
