To debunk the distorted news, "framed" events, and editorials of the predatory press and news gathering agencies; supply suppressed news, expose hypocracy, and promote the intelligent discussion of truth;

To prove to millionaires that most of them will become paupers if they do not allow the unemployed to produce for themselves, or if they permit the half-billionaire or full-billionaire, to control all business unrestrictedly, etc.

There are 11 Trustees. Additional trustees, elected by the readers or members, when more than 1000 members in adjoining districts or counties.
