Dear Mr. Trimble:

I have your letter of December 9th and appreciate your comments on my recent address to the American Bankers Association at New Orleans.

I thoroughly agree with you that the friends of the President should begin broadcasting systematically to the country his side of the case since for considerable time we have been hearing chiefly only the other side. My office will be glad to furnish you at any time all the factual material accessible to us which might be of value to you. In this connection, I thought you might be interested in seeing a recent article by Stuart Chase, a copy of which I am enclosing.

I note that you forwarded a copy of your letter to Mr. McIntyre, Assistant Secretary to the President. I would suggest that you would have to take up direct with Mr. McIntyre the matter of the broadcast which you have in mind. Of course, I do not know that he could arrange for it, but in any case, I cannot do so.
