My dear Mr. Eccles:

The National Tax Association will hold its 34th annual conference at the Lowry Hotel, St. Paul, Minnesota, October 13-16, except that the second day of the conference (Tuesday, October 14) will be held at the University of Minnesota, Minneapolis. The main theme of the program on the second day is National Defense Financing, and the program committee would like very much to have you discuss this subject on that occasion.


