Dear Mr. Eccles:

I am writing to extend to you an invitation to address the National Association of Supervisors of State Banks at their annual convention to be held at the Netherlands Pleza Hotel in Cincinnati, Ohio, on September 17 and 18. If possible, we should like to have you on the program for the 17th, and we should like to have you discuss any subject which seems to you to be most appropriate for the occasion.

For your general information, let me say that I am trying to build the general program around the central theme "In the wartime and postwar eras, how far, and by what means, is it desirable or possible to preserve the dual system of banking?". My thought in proposing this central theme is that, while there are a great many other topics which are important, they are, many of them, matters completely beyond the control of our Association or its members, but this is a topic of vital importance and one which I think, to a considerable extent, lies within our control.

While doubtless other topics will be discussed, nevertheless, if some of the speakers from the federal agencies and some of the state supervisors should discuss this topic, from their respective points of view, it might well be that the net result would comprise a serious and rather exhaustive study of this subject which ought to clarify our combined thinking and perhaps set a few buoys along an important channel, for I think it is very important that we all think clearly and courageously on the degree to which it is desirable to preserve the dual system, and the means by which that degree of preservation can be attained.

This, however, is not intended to restrict you in any way as to the subject or treatment of your address. We shall be glad to hear any message you care to bring.

Dear Mr. Eccles:

I am delighted to receive your letter of July 15 and surely hope you will be able to be present in person.

Since my letter of the 12th we have found it necessary to change hotel arrangements so that our conference will be in the Hotel Gibson instead of the Netherlands Plaza, but the city and dates are unchanged.

It had been my thought to have the speakers representing the federal agencies appear on the first day and, if you have any preference as to the hour at which your address would come, I see no reason why you could not have your choice, but, in the absence of any expression of preference, I had thought of having the federal speakers appear in the order in which their respective organizations were created. In that event, I should suppose that the Secretary of the Treasury would come first, but he says he cannot be with us. That would then leave the Comptroller of the Currency, and I have not yet heard from him. Your agency, I believe, came next, which would give you the first or second place on the program if that order were followed. There is no magic or logic about that historical sequence, so if anyone has any preference, the program could probably be arranged accordingly, unless there should be some conflict.

The other federal speakers who have been invited are Mr. Crowley of the FDIC, from whom I have not yet heard, and James Twohy, Governor of the Federal Home Loan Bank System, who has accepted. I presume Governor Bricker will extend the greetings of the State or may possibly have some different place on the program, and Lee Wiggins, the prospective President of the American Bankers Association, has also accepted an invitation to speak. The other places on the program, as thus far contemplated, would be filled by bank commissioners from various States. One of them, Dr. Agger of New Jersey, I have asked to touch on "Comparisons and distinctions between American and
