

Our Department of Agriculture Graduate School has planned for this fall and early winter a program of lectures and discussions on major policy problems of American agriculture. The program provides that lecturers will first address junior professional and clerical personnel, and then will meet informally on a seminar basis with a small number of responsible Department members and advanced students for critical analysis and evaluation of the policy problem under consideration. Mr. T. Roy Reid, Director of Personnel, is in charge of the lectures for junior professional and clerical personnel, while Robert H. Shields, Administrator of the Production and Marketing Administration, and I are in charge of the seminar.

We should like to invite you to deliver the lecture on "Monetary Policy and Agricultural Problems" on October 7, 1946, and to meet with the seminar on the same topic. Attached is a brief outline of the series as a whole together with the names of those invited to handle each policy problem.

Dear Mr. Eccles:

This is in further reference to your correspondence with Secretary Anderson concerning your participation in the forthcoming National Outlook Conference to be held in the Department of Agriculture Auditorium on the first floor of the South Building during the week beginning Monday, October 7. On the enclosed copy of a preliminary draft of the program for the first day of this conference, we have circled your scheduled address in red pencil.

In the arrangement of the program it has been our purpose to provide the conferees during the first day with an authoritative discussion of the general international and domestic situation and outlook as a background for the rest of the conference, which will deal more directly with matters in the agricultural field.
