Dear Albert:

I just received your air mail letter of October 16th, relative to my visit to Boston next week. I was attending a meeting over at the Treasury yesterday when you telephoned.

I appreciate your suggestion regarding a dinner with the directors of our Boston Bank on Friday evening. It is agreeable with me and I, too, think it would be nice to include Walter Bucklin, Charlie Spencer, and some of the other bankers.

I had expected to leave Boston late Friday afternoon, but in view of the dinner I will plan to stay over that night, leaving there on Saturday morning. As it is less difficult to get plane reservations at the originating point, I will appreciate it if you will do what you can to get a non-stop flight reservation for me from Boston to New York, and one from Boston to Washington on Saturday morning so as to arrive at either destination by 12:00 noon. 
