Dear Mr. Case:

Confirming his night letter of January 27, Mr. Eccles wishes to emphasize again that he would not want to appear to be sponsor for or author of a special article for "The Rotarian" and if he were to prepare such an article he would wish to make it more complete and well rounded than these excerpts. However, this is a well done abbreviation so far as it goes.

He has made a rule not to attempt to write special articles for magazines or the press because to do so in one case requires that all such requests be met, if he is to be fair to all comers, and time limitations prevent preparation of so much material. For this reason, he authorises your use of the material you suggest, and which I am returning herewith, as if it were a report by you and not an article by him.

He asked me to say that your publication has a large influence and he appreciates your courtesy in submitting the material to him.
