# Eccles, Architect of Financial Policy in World War II, will Speak on Saturday

Marriner S. Eccles, member of the board of governors of the Federal Reserve System and one of the best-known spokesmen for banking in the nation, will address the Forum next Saturday on the subject, "Defense Preparedness and Inflation."

The subject is of personal concern to every American, for the manner in which the defense program is financed will determine to some degree the "take home" pay of everybody, and what all will pay for the necessities and luxuries of life with the money left over after taxes.

Eccles brings exceptional experience to the forum and radio audience, for he was appointed chairman of the Federal Reserve board by President Roosevelt in 1936 and served in that capacity until 1948. He was, therefore, the architect of American financial policy in the world war.

The Federal Reserve chairman is to banking what the chief justice is to law, and, therefore, his influence has been great. But he is better known than most banking leaders by virtue of the fact that he has a dynamic personality and is quite outspoken. He has displayed exceptional ability and has won the confidence by and large of the public. His ability is proven by the fact that during his war chairmanship he virtually ran the board single-handed.

Inflation has been a primary problem for Eccles throughout his public career, what with the "pump priming" projects of the later depression years and the involuntary inflation of the war period.

He was born in Utah and educated at Brigham Young College and the University of Utah. Mr. Eccles organized an investment company as a young man, and has held executive positions with various banks and other financial institutions in Utah, Idaho and Wyoming. He has been a director of many business enterprises.

As questions of taxes and inflation involve difficult technical problems in economics, the public does not have the opportunity often enough to obtain authoritative analysis. It is an exceptional privilege, therefore, that is provided at the Forum Saturday. Don't miss it.
