SEVENTH TRANCHE REPORT TO CONGRESS
June 3, 2009

I. INTRODUCTION

This *Seventh Tranche Report to Congress* meets the requirement for reporting at the \$400 billion commitment level under section 105(b) of the Emergency Economic Stabilization Act of 2008 (EESA) for the period of April 18, 2009 through May 27, 2009. Transactions during the reporting period include a number of measures under the Automotive Industry Financing Program and the Home Affordable Mortgage Program, as well as \$425.4 million of transactions under the Capital Purchase Program, bringing the total amount of transactions to \$404.4 billion. The Treasury Department (Treasury) will submit the next Tranche Report when total transactions reach the \$450 billion level.

Pursuant to section 105(b) of EESA, the Report addresses the following six areas:

- A description of all the transactions made during the reporting period.
- A description of the pricing mechanism for the transactions.
- A justification of the price paid for, and other financial terms associated with, the transactions.
- A description of the impact of the exercise of such authority on the financial system.
- A description of the challenges that remain in the financial system, including any benchmarks yet to be achieved.
- An estimate of additional actions under the authority provided pursuant to the EESA that may be necessary to address such challenges.

II. TRANSACTION INFORMATION BY PROGRAM

This *Seventh Tranche Report* describes transactions under three programs: the Automotive Industry Financing Program, the Home Affordable Modification Program, and the Capital Purchase Program. Since Treasury's *Sixth Tranche Report to Congress*, submitted to Congress on April 24, 2009, regarding \$376.7 billion in transactions, Treasury has closed \$27.6 billion in transactions under those programs. A report listing all transactions under the Troubled Assets Relief Program (TARP) closed during the reporting period is attached as the Appendix and is posted on Treasury's web site.

Automotive Industry Financing Program

The Automotive Industry Financing Program (AIFP) is designed to prevent a significant disruption of the American automotive industry, which would have a negative effect on the U.S. economy. The program requires participating institutions to implement plans that will achieve long-term viability. During this reporting period, Treasury undertook a number of transactions under the AIFP.

On April 22, 2009, Treasury announced the purchase of debt obligations from General Motors Corporation (GM) of \$2.0 billion as part of the AIFP, bringing Treasury's total loans to the

company to \$15.4 billion. Treasury increased its loan to GM by \$4 billion on May 20, 2009, bringing the total loan amount to \$19.4 billion.

Treasury has undertaken a series of transactions to support Chrysler. On April 29, 2009, Treasury committed to purchase debt obligations from Chrysler Holding LLC of approximately \$500 million to provide working capital. On April 30, 2009, the company announced the Chrysler-Fiat alliance, which will help position Chrysler for a viable future. Consistent with President Obama's commitment to provide adequate working capital to help Chrysler through its restructuring period and loan funds to the Chrysler-Fiat alliance, the U.S. government has committed to provide assistance sufficient to help give Chrysler a chance to achieve financial viability.

On May 1, 2009, Treasury and the Canadian government jointly agreed to make a loan in the total amount of \$4.1 billion to Chrysler LLC in its capacity as debtor-in-possession (DIP) in its bankruptcy case. Treasury's share of that loan is \$3.04 billion. The terms of the loan are set forth in a credit agreement executed on May 5, 2009. The bankruptcy court authorized interim borrowing of up to \$1.4 billion pending final approval of the loan. Treasury's share of that interim loan is \$1.04 billion. The balance of the \$4.1 billion was approved by the bankruptcy court on May 20, 2009. Treasury's commitment to lend constitutes the purchase of a debt obligation under Section 101 of EESA. Also on May 20, 2009, Treasury increased its loan commitment in the DIP credit agreement by \$756,857,000, bringing the maximum amount of Treasury's share available under the loan to a total of \$3.8 billion.

On May 21, 2009, Treasury invested \$7.5 billion in Mandatorily Convertible Preferred Interests in GMAC LLC (GMAC) to support GMAC's ability to originate new loans to Chrysler dealers and consumers and help address GMAC's capital needs as identified through the Supervisory Capital Assessment Program (SCAP).

On May 27, 2009, Treasury committed to invest in New CarCo Acquisition LLC, the company that will purchase the assets of Chrysler. Treasury executed a binding term sheet for a loan of up to \$7.943 billion, which consists of new debt obligations of approximately \$6.9 billion, debt of approximately \$500 million to be transferred in connection with Treasury's May 21, 2009 agreement with GMAC, and assumed debt of \$500 million from Treasury's January 2, 2009 credit agreement with Chrysler Holding LLC. The debt obligations will be secured by a first priority lien on the assets of New CarCo Acquisition LLC (the new Chrysler). In addition, Treasury will obtain other consideration, including an equity interest in New CarCo Acquisition LLC and an additional note. The final amount spent out of our DIP commitment and resulting exit financing combined will be resolved when the 363 sales transaction closes, but is expected to be about \$8.1 billion.

Separately, Treasury also completed two transactions under the Warranty Commitment Program during the reporting period. The Warranty Commitment Program, announced March 30, 2009, is a component of the AIFP and provides government-funded protection for warranties issued by Chrysler and GM during the restructuring process. The program covers warranties on new vehicles purchased from Chrysler and GM dealers during the restructuring period, and applies if, during the restructuring period, Chrysler and/or GM fail to honor the subject warranties on their

vehicles. On April 29, 2009, Treasury purchased debt obligations from Chrysler of \$280 million to capitalize Chrysler Warranty SPV LLC, a special purpose vehicle created by Chrysler LLC to finance Chrysler's participation in the Warranty Commitment Program. On May 27, 2009, Treasury purchased debt obligations from GM of \$360.6 million to capitalize GM Warranty LLC, a special purpose vehicle created by GM to finance GM's participation in the Warranty Commitment Program.

During the reporting period, Treasury also received \$107.5 million in dividend payments from participants in the AIFP. As of May 27, 2009, Treasury had received a total of \$359.7 million in interest and dividend payments from participants in the AIFP since the inception of the program.

Capital Purchase Program

Treasury established the Capital Purchase Program (CPP) in October 2008 to stabilize the financial system by building the capital base of viable U.S. financial institutions, enabling them to continue lending to businesses and consumers during this unprecedented financial crisis and economic downturn. Under the CPP, Treasury has purchased senior preferred shares from qualifying U.S. controlled banks, savings associations, and certain bank and savings and loan holding companies. Treasury also has purchased subordinated debentures from Subchapter S corporations. Since Treasury's *Sixth Tranche Report to Congress* dated April 24, 2009, Treasury has purchased \$425.4 million in senior preferred shares and subordinated debentures from 52 institutions, bringing the total amount of funds invested under the CPP to \$199.3 billion. Treasury has completed CPP transactions with 605 U.S. financial institutions and Community Development Financial Institutions in 48 states, Puerto Rico, and the District of Columbia.

Treasury receives dividend payments from its investments under the CPP and has received a total of \$4.50 billion in dividend payments received since launching CPP in October 2008. During this reporting period, Treasury received \$1.86 billion in dividend payments from institutions participating in the CPP.

In addition, Treasury has received payments in connection with the repurchase of preferred shares, preferred shares associated with the exercise of warrants, and warrants associated with CPP investments. During this reporting period, Treasury received \$1.30 billion in principal plus an additional \$8.71 million in accrued and unpaid dividends from the repurchase of senior preferred shares (excluding preferred shares associated with the exercise of the warrants) by 13 institutions that participated in the CPP. In total since October 2008, Treasury has received \$1.77 billion plus an additional \$11.83 million in accrued and unpaid dividends from the repurchase of senior preferred shares by 20 financial institutions that participated in the CPP. As of May 27, 2009, Treasury has received \$1.60 million plus an additional \$17,153 in accrued and unpaid dividends in connection with the repurchase of preferred shares associated with the exercise of warrants from three private institutions, and \$11.73 million from the repurchase of

warrants from five public institutions that participated in the CPP. Treasury will continue to work with federal banking regulators to evaluate requests from CPP participants interested in repaying Treasury.

Home Affordable Modification Program

Making Home Affordable, a comprehensive program to stabilize the U.S. housing market, was first announced by the Administration on February 18, 2009 as part of its Homeowner Affordability and Stability Plan.

From April 13, 2009, when servicer funding for the Home Affordable Modification Program (a component of Making Home Affordable) began, through the end of this reporting period, 14 servicers have executed Servicer Participation Agreements (five during this reporting period) and more than \$15 billion (of a total potential allocation of \$50 billion) have been allocated to implement the program. Between loans serviced by the participants and loans owned or securitized by the GSEs, more than 75 percent of all mortgage loans are now covered by the Making Home Affordable Program.

III. IMPACT, REMAINING CHALLENGES, AND ADDITIONAL ACTIONS

Impact of the Programs

Automotive Industry Financing Program

Treasury remains committed to assisting the nation's automotive industry as it undergoes restructuring. The General Motors Dealer Consolidation announcement is part of the company's larger effort to restructure to achieve financial viability. The President's Auto Task Force (Task Force) is continuing to work with GM and its stakeholders and the Administration will stand behind GM during this process to help it emerge as a more competitive, viable business in the long-term.

Treasury and the Administration recognize the difficulties facing the dealers that sell GM and Chrysler cars and the communities they serve. To this effect, Treasury and the Administration believe that the actions under the AIFP were critical to supporting the GM and Chrysler dealer networks and will enable the continued efforts to restructure the companies. A restructuring process that is supported by efficient and effective dealer networks will provide more stability and certainty for current employees and the prospect for future employment growth.

In addition, the Administration is committed to continuing its significant efforts to help ensure that financing is available to creditworthy dealers and to pursuing efforts to help boost domestic demand for cars. These steps will help auto dealers, the auto industry, and the American economy.

The Chrysler-Fiat alliance requires a number of tough measures by all stakeholders and includes the following components:

- The alliance will retain Chrysler's existing factory footprint and continue producing Chrysler cars in U.S. factories. The alliance will create the sixth-largest global automaker, spreading R&D and design development costs over higher volumes, making it more competitive in an increasingly global and consolidating industry.
- Fiat is contributing billions of dollars in advanced technology and intellectual property, and offering Chrysler access to a global distribution network. Fiat's technology will allow Chrysler to build new fuel-efficient cars and engines in U.S. factories.
- The International Union, United Automobile, Aerospace and Agricultural Implement Workers of America (UAW) has made important concessions on wages, benefits, and retiree health care that, while difficult, will help save jobs for active employees, pensions and health care for retirees and make Chrysler more competitive.
- Chrysler's largest secured creditors have agreed to exchange their portion of the Company's \$6.9 billion secured claim for their pro-rata share of \$2 billion in cash at closing. The bankruptcy court process will be used to bind those lenders that failed to accept the offer that was accepted by a majority of the lenders.
- Daimler, Chrysler's current minority shareholder, has agreed to waive its share of Chrysler's \$2 billion of second lien debt, release its 19 percent equity interest in Chrysler's ultimate parent, and settle its guaranty obligation to the Pension Benefit Guaranty Corporation (PBGC) by agreeing to pay \$600 million to Chrysler's pension funds.
- Cerberus has agreed to waive its share of Chrysler's \$2 billion of second lien debt and forfeit its entire equity stake in Chrysler. Cerberus has also agreed to transfer its ownership of the Chrysler headquarters in Auburn Hills, Michigan to the new Chrysler alliance. Lastly, Cerberus will contribute a claim it had against Daimler to assist in the Daimler settlement with the PBGC.

In April, Chrysler faced the real prospect of liquidation, which would have eliminated all 3,200 of the company's dealers. As a result of the successful Chrysler-Fiat partnership and the backing of the United States government, Chrysler is now positioned to move forward with a plan that retains 75 percent of its dealers – representing 87 percent of Chrysler sales.

Capital Purchase Program- Lending Survey Activity

On May 15, 2009, Treasury published the Third Monthly Intermediation Survey and Snapshot, providing information from Treasury's monthly survey of lending and intermediation activities of the top 21 recipients of government investment through the Capital Purchase Program (CPP) in March 2009. Survey results illustrated that outstanding loan balances dropped one percent in March, as many institutions indicated that borrowers paid down outstanding debt. Despite the declines in loans held on banks' balance sheets, originations of new loans accelerated. All banks

reported an increase in total new lending of 27 percent from February to March (approximately \$63 billion). Lending rose across all types of loans. Two factors contributed for the increased volume in originations. One, there were three additional business days in the March survey period (22 days) versus the February period (19 days). Two, loan volume typically rises at quarter end, a normal seasonal demand pattern.

Making Home Affordable Program

Since the launch of Making Home Affordable on March 4, 2009, more than one million Americans have refinanced their mortgages, due to historically low interest rates, including thousands of underwater borrowers who have refinanced under the Home Affordable Refinance Program. More than 105,000 Home Affordable Modification offers have been extended to qualifying borrowers. The refinance application volumes and modifications underway are indicative of homeowners' desire to take advantage of these programs.

Remaining Challenges

Treasury will continue to develop, launch, and implement programs under the (TARP) and the Financial Stability Plan (FSP) pursuant to the goals of the Emergency Economic Stabilization Act of 2008 (EESA). Every program established by Treasury under the TARP and FSP is aimed at stabilizing the financial system and restoring liquidity, enabling the flow of credit to consumers and businesses and restoring economic growth. These measures include actions to stabilize systemically important financial institutions, promote the availability of credit to consumers and small businesses, reduce preventable foreclosures, and promote the transparency of programs under the TARP. Given the critical role played by financial institutions and markets in the U.S. economy, financial stability is a necessary precondition to the resumption of normal economic activity.

While there is no single action the Federal Government can take to end the financial market turmoil and the economic downturn, the authorities Congress provided to Treasury under the EESA dramatically expanded the tools available to Treasury to stabilize the financial system. Moving forward, Treasury is committed to ensuring that a financial crisis of this magnitude does not happen again. In that regard, the current crisis has exposed critical gaps and weaknesses in the nation's financial regulatory framework, including the lack of resolution authority. Treasury is working with the Federal regulators, Congress, and the Administration to lay out a new framework for a modern regulatory structure that will better enable the Federal Government to address future crises. Treasury is confident that its efforts to restore financial stability will lay a strong foundation for economic recovery and market stability.

Additional Actions

On May 13, 2009, Treasury announced the re-opening of the CPP with new terms aimed at encouraging participation by small community banks that are qualified financial institutions

(QFIs) as defined under any published term sheet. The new program terms include the following: (i) Treasury has re-opened the application window for all term sheets and established an application deadline of November 21, 2009; (ii) viable banks with less than \$500 million of total assets are eligible to apply for up to five percent of their risk weighted assets (RWA). For holding companies with more than one bank, all bank assets will be aggregated and only holding companies with total assets of less than \$500 million are eligible; (iii) the window to form a bank holding company for the purposes of CPP was re-opened with a deadline of November 21, 2009.

On May 14, 2009, Treasury notified a number of insurance companies that they had received preliminary approval to participate in the CPP. Insurance company pre-approvals do not constitute a new program under TARP. Rather, all pre-approved companies complied with the requirements to participate in the CPP under existing term sheets as they are organized as bank or thrift holding companies and filed a CPP application within the initial application window deadline. To process these applications, Treasury worked with the insurance and federal banking regulators to develop a robust analytical framework to assess the particular characteristics of insurance companies.

On May 6, 2009, Treasury and the Federal banking regulators issued a Joint Statement about the Capital Assistance Program (CAP) and the Supervisory Capital Assessment Program (SCAP), followed by the regulators' release of the results of the SCAP exercise on May 7, 2009. The forward looking SCAP exercise was conducted on 19 U.S. financial institutions most of which are also participants in the CPP. Treasury also issued updated guidelines for repayment of CPP investments reflecting the terms established by the federal banking regulators under the SCAP. On April 28, 2009, Treasury released details on the Second Lien Program for the Making Home Affordable program. The Second Lien Program will complement the first lien modification program by automatically lowering monthly payments on qualified second liens when the first mortgage is modified through the Home Affordable Modification Program. The Second Lien Program is intended to provide additional relief to more than a million struggling homeowners by offering incentives to servicers and investors who agree to modify or extinguish second lien debts. Servicers of subordinate liens must execute a Second Lien Servicer Participation Agreement in order to be eligible for these incentives.

Also on April 28, 2009, Treasury proposed to integrate the Hope for Homeowners Program (H4H), which offers an important avenue for struggling borrowers to refinance into a sustainable mortgage, with the Making Home Affordable program. An H4H refinance requires the current first mortgage holder to write down the amount due on the mortgage to below 100 percent loan

to value and requires all subordinate lien holders to extinguish their liens in exchange for an incentive payment. This provides borrowers with increased equity and an affordable monthly payment. On May 20, 2009, President Obama signed into law the Helping Families Save Their Homes Act of 2009, which made several important changes to H4H and should permit the integration of H4H with the Making Home Affordable program.

On May 14, 2009, Treasury announced additional details on the Making Home Affordable Program, including:

- Foreclosure alternatives to provide incentives for servicers and borrowers to pursue short sales and deeds-in-lieu (DIL) of foreclosure in cases where the borrower is generally eligible for a MHA modification but does not qualify or is unable to complete the process, which helps prevent costly foreclosures and minimizes the damage that foreclosures impose on borrowers, financial institutions and communities. The new details will simplify and streamline the process of pursuing short sales and deeds-in-lieu, which will facilitate the ability of more servicers and borrowers to utilize the program. The program provides a standard process flow, minimum performance timeframes, and standard documentation, and it offers financial incentives to servicers and borrowers to pursue these alternatives to foreclosure.
- Home Price Decline Protection (HPDP) Incentives will provide lenders additional incentives for modifications where home price declines have been most severe and lenders fear these declines may persist. To encourage the modification of more mortgages and enable more families to keep their homes, the Administration, building on insights pioneered by FDIC Chair Bair and the FDIC, has developed an innovative payment that provides compensation based on recent home price declines. Together the incentive payments on all modified homes will help cover the incremental collateral loss on those modifications that do not succeed. HPDP payments will be linked to the rate of recent home price decline in a local housing market, as well as the average cost of a home in that market.
