NOMINATIONS FOR DIRECTORS

To the Member Bank Addressed:

In accordance with the provisions of Section 4 of the Federal Reserve Act and my circular dated September 22, 1930, in regard to election of directors of this bank to succeed J. H. Frost, Class A director, and J. R. Milam, Class B director, whose terms expire December 31, 1930, there is given on the back hereof a list of the candidates nominated for such directors, indicating by whom nominated.

There is sent herewith to each bank in Group 1 a preferential ballot for use in voting on the candidates for Class A director and to each bank in Group 2 a preferential ballot for use in voting on the candidates for Class B director. There is also enclosed an envelope bearing on its face the certificate in regard to the vote; also a colored envelope marked "Ballot," in which the ballot is to be sealed.

The ballot and certificate on the envelope must be executed by the officer who has been authorized to cast the vote. A list of the designated officers was attached to my circular above mentioned. In order that the ballot may be secret, the name of the bank and of the voting officer should not be written on the ballot, but only on the certificate envelope.

- (1) After the preferential ballot has been marked,
- (2) It should be placed in the colored envelope marked "Ballot" and the envelope sealed.
- (3) Then after the certificate on the certificate envelope is executed, the colored sealed envelope should be placed within and the certificate envelope sealed.
- (4) Then this certificate envelope containing the sealed ballot envelope should be returned to me in the enclosed self-addressed envelope.

Under the law, the ballot must be returned so as to reach me within 15 days after its receipt. The polls will open on November 1 and close at 3:00 P. M. on November 15, 1930. At that time the ballot box will be opened in the Board Room of this bank. All of the sealed colored envelopes containing the ballots will first be removed and segregated from the certificate envelopes before any of the colored envelopes are opened, thus insuring the secrecy of the ballot. Then the colored envelopes will be opened, the votes counted and results of the election announced. Any of the candidates are invited to be present or represented on this occasion.

While the banks in Group 3 will not vote in this election, this circular is sent to them without forms for their information.

Names of Candidates

J. H. FROST, President Frost National Bank San Antonio, Texas

Mr. Frost was born in San Antonio, Texas, August 1, 1881, the son of Thomas C. Frost and Josephine Houston Frost. He attended the San Antonio Academy, graduating in 1898. He entered Princeton in the Fall of 1899, graduating there with a Bachelor of Science degree in the Spring of 1902. After graduating at Princeton, Mr. Frost began work for the Frost National Bank of San Antonio, and has continued with that institution since, being president of it at this time.

Mr. Frost has no other affiliations of consequence or honorary offices than his present connection as Director of the Federal Reserve Bank of Dallas.

R. E. HARDING, President Fort Worth National Bank Fort Worth, Texas

Mr. Harding was born March 7, 1883, in Paris, Tennessee, son of the late Noah Harding, one of the organizers of the Fort Worth National Bank. Moved to Fort Worth, November, 1883. Received his primary schooling at the old Fort Worth University. Attended the University of Texas 1900-1903. First entered the employ of the Fort Worth National Bank in the summer of 1897 and worked every vacation until 1903, when he came in permanently as a clerk. Occupied various positions in the bank and in 1906 was made assistant cashier. Was elected vice president in 1914, which position he occupied until March 27, 1930, when he was elected president, to succeed the late Major Van Zandt.

Married Merle Reynolds, daughter of Mr. and Mrs. W. D. Reynolds, in January, 1911. Has two children, Robert E., Jr. and Sue.

Mr. Johnson is president of the Commercial National Bank, Shreveport, La., the Commercial Bank and Trust Company, Springhill, La., Bank of Commerce and Trust Company, Mansfield, La., vice president of the DeSoto Foundry and Machine Company, Mansfield, La., director of the Mansfield Hardwood Lumber Company, Shreveport, La. Graduate of Louisiana State Normal College 1899; taught school for four years after graduation, when he entered the Bank of DeSoto, Mansfield, La. in 1903. Effected consolidation of two small banks and was active in the organization of the Bank of Commerce and Trust Company in 1909. His connections there have been continuous. He came to Shreveport in 1921 as president of the Commercial National Bank. Has served on various commissions and committees, including the American Bankers Association for a number of years. Has been active in the affairs of the Louisiana Bankers Association; was president of that body in 1921.

W. R. KING, President

City-Central Bank and Trust Company

San Antonio, Texas

Mr. King has been identified with the banking business in San Antonio since 1907, when he became vice president of the City National Bank. In December, 1921, the City National, the State National and the Central Trust Company merged, the City National taking over the commercial, and the Central Trust Company the trust business of the three institutions, of which banks Mr. King became president.

In September, 1929 the Central Trust Company, affiliated with the City National Bank but operating as an independent unit, and the Guaranty State Bank and the City National Bank consolidated, which consolidated institution is operating under the name of the City-Central Bank and Trust Company, of which institution Mr. King is president. He was president of the San Antonio Clearing House Association 1922-1923.
