**SUPPLEMENTS TO REGULATIONS T AND U**

**To All Banks and Others Concerned**  
**in the Eleventh Federal Reserve District:**

The Board of Governors of the Federal Reserve System has amended the supplements to Regulations T and U by decreasing margin requirements to 50 per cent, effective January 16, 1958. The press statement issued in connection with such action is quoted below.

“The Board of Governors of the Federal Reserve System today amended Regulations T and U, relating respectively to margin requirements of brokers and banks, by reducing margin requirements from 70 per cent to 50 per cent, effective January 16, 1958.

“The reduced requirements apply to both purchases and short sales. No other change was made in the Regulations.”

A copy of each of the amended supplements is enclosed. Member banks are requested to insert these new supplements in their ring binders containing the Regulations of the Board of Governors and the Bulletins of this bank.

## SUPPLEMENT TO REGULATION T

ISSUED BY THE BOARD OF GOVERNORS OF THE FEDERAL RESERVE SYSTEM

**Effective January 16, 1958**

**Maximum Loan Value for General Accounts.** — The maximum loan value of a registered security (other than an exempted security) in a general account, subject to Section 3 of Regulation T, shall be 50 per cent of its current market value.

**Margin Required for Short Sales in General Accounts.** — The amount to be included in the adjusted debit balance of a general account, pursuant to Section 3(d)(3) of Regulation T, as margin required for short sales of securities (other than exempted securities) shall be 50 per cent of the current market value of each such security.

## **SUPPLEMENT TO REGULATION U**

ISSUED BY THE BOARD OF GOVERNORS OF THE FEDERAL RESERVE SYSTEM

**Effective January 16, 1958**

For the purpose of Section 1 of Regulation U, the maximum loan value of any stock, whether or not registered on a national securities exchange, shall be 50 per cent of its current market value, as determined by any reasonable method.
