To All Member and Par Nonmember Banks in the San Antonio Branch Territory:

On August 16, this office will begin processing checks for all banks in our territory and forwarding cash letters from a high-speed check-handling system. The cash letter will be in the form of a tape and will reflect one total of the high-speed machined checks and also a total or totals of non-machinable items not processed on the high-speed system. You will receive two copies of the letter. One copy should be retained by you and the other returned to this office with your remittance, unpaid items, missent items, etc.

It will be very helpful if you will fully explain all differences to the total of the cash letter on the reverse of the copy you return. If possible, please return the tapes with position of errors marked and a photocopy of any improperly listed item.

At a later date, we will send you sample copies of the new style cash letter and proof tapes which we feel will assist you in reconciling the cash letters.

Your cooperation will be of great assistance in this new procedure.

HIGH SPEED CHECK HANDLING

Effective August 16, cash letters you receive from us will be processed on the high-speed check handling system. Shown below are samples of the cash letter, proof tapes and a facsimile of our endorsement.

In wiring or telephoning non-payment of items of \$1,000. and over, please furnish the number appearing within our endorsement in addition to the information you are now supplying.

Please return to this office all unpaid items and items not drawn on your bank listed in our cash letters. DO NOT RETURN THESE ITEMS TO YOUR CORRESPONDENT.

One copy of the cash letter form should be returned with your remittance. It would be helpful if you would explain all differences on this copy. If possible, please return the tapes with position of the errors marked and a photocopy of the improperly listed item. If not, please advise the item sequence number that appears on the left of the tape opposite the check amount, location of the check on the tape and the bundle number appearing beside the bundle total.

Your cooperation will be of great assistance in making proper adjustment of differences and notifying endorsers of non-payment of large items.
