### REGULATION Z ANNUAL PERCENTAGE RATE TABLES

To All Banks, Other Creditors, and Others Concerned in the Eleventh Federal Reserve District:

Volume I of the Regulation Z Annual Percentage Rate Tables is now available from the Federal Reserve Bank of Dallas. The tables have been prepared by the Board of Governors of the Federal Reserve System for use in connection with the Truth in Lending Act, which is effective July 1, 1969.

Volume I permits determination of the annual percentage rate in regular payment transactions, and in a limited number of irregular payment transactions, in which the payment period is a month or a week, or a multiple or fraction of a month or a week. It contains the following tables:

FRB-100-M, one to 60 monthly payments, 2% to 61-3/4% FRB-200-M, 61 to 120 monthly payments, 2% to 41-3/4% FRB-300-M, 121 to 480 monthly payments, 2% to 21-3/4% FRB-100-W, one to 104 weekly payments, 2% to 61-3/4%

The price of Volume I is \$1, or  $85\phi$  in orders of 10 or more. Orders should include remittance, payable to the Federal Reserve Bank of Dallas, and should be forwarded to Z Tables, Federal Reserve Bank of Dallas, Station K, Dallas, Texas 75222.

Volume II will contain factor tables for use in all types of irregular transactions, and is to be used in connection with Volume I. The price for Volume II will be the same as for Volume I.

Volume II is not presently available. Orders will be accepted at this time, however, and filled as soon as possible.

Creditors having inquiries with respect to Truth in Lending, or requesting additional copies of the Regulation Z pamphlet, should contact their respective supervisory agencies in accordance with the table on the reverse.
