The revised list contains 390 issues. No issues have been removed except for 15 companies that have merged or whose stocks have become exchange listed.

A copy of the revised list is enclosed. All such lists and changes dated prior to July 20, 1970, should be destroyed.

The list is published from time to time by the Board as a guide for lenders subject to the regulations and the general public. Stocks will be added to the list, or deleted, in the interim between publications as deemed appropriate by the Board.
