To All Banks in the Eleventh Federal Reserve District:

On September 20, 1972, the Gulf Coast Regional Check Processing Center will begin operations, initially serving all banks located in Brazoria, Chambers, Fort Bend, Galveston, Liberty, Montgomery, and Waller Counties. A list of the banks which will participate under this first phase is attached.

All Center participating banks, both member and nonmember, as well as Eleventh District member banks located outside the Center area may deposit items drawn on Center banks in a separate cash letter up to 12:01 a.m. daily, Monday through Friday, for credit that business day.

Phase II, the expansion of the Center to include the remaining banks in the Houston Branch territory, will be implemented on October 17, 1972. At that time, all banks in the Houston Branch territory, both member and nonmember, as well as member banks located in the other three territories of the Eleventh District, will be permitted to deposit with the Center all items bearing the routing symbol 1131. These items, when deposited in a separate cash letter, will be accepted by the Center up to 12:01 a.m. daily, Monday through Friday, for credit that business day.

A revised Bulletin 13, governing Regional Check Processing Center operations in the Eleventh District, together with an availability schedule covering the Gulf Coast Regional Check Processing Center, will be forwarded in the near future.
