## OFFICIAL ANNOUNCEMENT

To All Banks in the  
Eleventh Federal Reserve District:

It is a pleasure to announce that the Board of Directors of the Federal Reserve Bank of Dallas has made the following changes in the official staff of the Head Office, effective August 6, 1973:

William H. Kelly, Director of Research, has been designated Assistant Vice President and assigned direct supervision of the Regulations Department.
