To All Banks in the
Eleventh Federal Reserve District:

It is a pleasure to announce that the Board of Directors of the Federal Reserve Bank of Dallas has made the following changes in the official staff of the Head Office, effective January 1, 1975:

Ralph T. Green, Vice President, has been designated Vice President and Senior Economic Advisor, and will be attached to the office of the President. Mr. Green was employed by the Bank in 1949 as Financial Economist. In 1956, he was made Director of the Texas Commission on Higher Education, Austin, Texas, and served in that capacity until 1962, when he became Vice President of the Federal Reserve Bank of Dallas. Mr. Green received his B.A. and M.S. degrees from Texas A&M University and his Ph.D. in economics from Duke University.

Joseph E. Burns, Director of Research, has been elected to the official position of Vice President, and will assume general supervision of the Research Department. After serving three years as an Economist with the Board of Governors of the Federal Reserve System, Mr. Burns was employed from 1970–1972 by the Federal Reserve Bank of Dallas as Senior Financial Economist. Leaving the Bank in 1972, he returned in mid–1973 as Director of Research, the position he currently holds. Mr. Burns received his B.S., M.A., and Ph.D. degrees from the University of Oregon.

The Board of Directors at its meeting on December 12, 1974, re-elected all of the officers of the Federal Reserve Bank of Dallas and its Branches at El Paso, Houston, and San Antonio, Texas.
