OFFICIAL ANNOUNCEMENT

TO ALL BANKS IN THE
ELEVENTH FEDERAL RESERVE DISTRICT:

It is a pleasure to announce that the Board of Directors of the Federal Reserve Bank of Dallas has made the following changes in the official staff of the Head Office, effective October 16, 1975:

C. J. Pickering, Planning Officer, has been promoted to Vice President and will have general supervision of the Checks, Mailing, Planning, and RCPC Departments. Mr. Pickering was employed by the Bank in 1970 as Planning Administrator and was elected Planning Officer in 1973. A Registered Professional Engineer, he holds B.S. and M.S. degrees from Oklahoma State University with majors in industrial engineering and management.

J. A. Clymer, Operations Officer, has been promoted to Assistant Vice President and will have direct supervision of the Checks and RCPC Departments. Reck, Data Processing Officer, has been designated Assistant Vice President and will have direct supervision of Data Systems (Applications Systems and Data Base Systems Divisions) of the Data Services Department. Mr. Reck was employed by the Bank in 1970 and was elected Data Processing Officer effective September 16, 1975. He holds B.S. and M.S. degrees from East Texas State University. He has also completed various courses offered by the American Institute of Banking and IBM.

Neil B. Ryan, Communications Systems and Operations Administrator in the Data Services Department, has been promoted to Assistant Vice President and will have direct supervision of Data Operations (Communications Systems and Operations and Computer Systems Divisions) of the Data Services Department. Mr. Ryan was employed by the Bank in April 1974. In 1972 he retired with the rank of Colonel from the U.S. Air Force, where most of his service was in the fields of data processing and financial management. Mr. Ryan holds a B.S. degree in industrial economics from Iowa State University and an M.B.A. in management from Indiana University.
