To be in compliance with the provisions of Regulation B, "Equal Credit Opportunity," we have revised Form C-8 in regard to certain inquiries on the statement. A copy of the revised form is enclosed. The old form should not be used after June 30, 1976, and any remaining stock should be destroyed.

Supplies of the revised financial statement are available to member banks and will be supplied upon request to this Bank's Services and Building Maintenance Department or its Branches in El Paso, Houston, and San Antonio.
