## REGULATION C--LIST OF COUNTIES INCLUDED IN STANDARD METROPOLITAN STATISTICAL AREAS

### TO ALL BANKS IN THE ELEVENTH FEDERAL RESERVE DISTRICT:

As we stated in our Circular No. 76-88, dated June 23, 1976, Regulation C applies to banks only if they (1) have assets of \$10 million or more, (2) make first lien mortgage loans on one-to-four family residences, (3) are Federally insured or regulated, and (4) have a home or branch office in a Standard Metropolitan Statistical Area (SMSA).

For the convenience of all banks in the Eleventh District, we have compiled a list of all counties in the District that are included in an SMSA. A bank that does not have a home or branch office in one of the following counties is not subject to Regulation C and does not have to compile the information requested. Also in the table, we have indicated, where available, the numbers of the PHC(1) series reports which contain the census tract maps for the specific SMSAs.
