FEDERAL RESERVE'S NEW CONSUMER ADVISORY COUNCIL

TO ALL BANKS
AND OTHERS CONCERNED IN THE
ELEVENTH FEDERAL RESERVE DISTRICT:

On April 9, 1976, we solicited your views on prospective members of the new Consumer Advisory Council. The Council will assist the Board of Governors of the Federal Reserve System in implementing the Consumer Credit Protection Act and will advise and consult with the Board on consumer-related matters.

On September 20, 1976, the Board announced the names of those individuals who will serve on the Council. The Council will be chaired by Mrs. Leonor K. Sullivan of Missouri. Mrs. Sullivan is presently a member of the United States House of Representatives and has served in that capacity for 24 years. She headed the Consumer Affairs Subcommittee of the House Banking and Currency Committee from 1963 to 1975, and has had a major hand in the development of most of the legislation the Consumer Advisory Council will help the Board implement.

Mrs. Sullivan has announced her retirement from Congress effective January 1977. Until then, the Council will be headed by Dr. William D. Warren, Dean of the School of Law, University of California at Los Angeles. Dr. Warren has accepted appointment as Vice Chairman of the Council.
