OFFICIAL ANNOUNCEMENT

TO ALL BANKS
IN THE ELEVENTH FEDERAL RESERVE DISTRICT:

It is a pleasure to announce that the Board of Directors of the Federal Reserve Bank of Dallas has made the following changes in the official staff of the Head Office and the Houston and San Antonio Branches, effective January 1, 1978:

Adrian W. Throop, Research Officer, has been designated Assistant Vice President and Associate Director of Research at the Head Office. Mr. Throop was employed by the Bank in 1973 and was elected Research Officer in 1976.
