## NEW DESIGN OF DOMESTIC AND MILITARY MONEY ORDERS

### TO ALL BANKS IN THE ELEVENTH FEDERAL RESERVE DISTRICT:

The United States Postal Service has asked this Bank to inform all banks in the Eleventh District of a change that is being made in the design of both domestic and military money orders. The changes, which are described below, are being made for security and processing reasons.

Although some of the new style military Postal Money Orders are already in circulation, the new style domestic money orders will not be issued initially until November or December of this year. The current style of Postal Money Orders will continue to be issued until existing supplies are exhausted; consequently, through at least a part of 1980, your bank can expect to receive both the current version and the new style of Postal Money Orders.

The United States Postal Service has indicated that the new style Postal Money Orders differ from the current version in the following ways:

#### Front

- The eagle is in outline to improve the legibility of address information when photocopies are made. There is a registered trademark symbol on the right of the claw.
- By encouraging the customer to provide complete information in the address area, identification of the person cashing the money order will be more positive and greater difficulties will be presented to persons contemplating an improper payment.
- 3. In the limitation plate area the word "dollars" has been modified so that after imprinting it will be partially covered with the limitation plate value. This has been done to hinder changing the amounts of money orders. The words "maximum value" have been printed beneath "dollars."

- 4. The color brown, used for printing "money order" on the left and "USA" on the right, has been substituted with black to reduce costs. Also, a yellow tint, printed over the background design, has been eliminated so that a person changing the amounts of money orders has to restore the background design rather than the yellow tint.
- The Postal Service banking code number on the bottom left corner has been changed to 000 000 204.

#### Back

- 1. The instructions have been simplified and placed at the serial number end in order to conform with Treasury and banking requirements.
- The thick yellow line has been eliminated. Testing has shown that an overlap of the endorsement signature into the read band area is not a problem.
- The paragraph "To the Cashier" has been changed so that future increases in the maximum value of any order will not present cashing problems.

A sample of the new style domestic money order is enclosed for your review. If you have any questions regarding this matter, it is suggested that you contact postal officials in your local community.
