ADDITIONAL TELEPHONE LINES IN THE CHECK PROCESSING DIVISION

TO ALL BANKS IN THE DALLAS TERRITORY
OF THE ELEVENTH FEDERAL RESERVE DISTRICT:

We are pleased to announce that two additional telephone lines have been installed in the Check Processing Division, (214) 651-6138 and 651-6139. They are for your use in reporting discrepancies relating to our cash letters such as missing bundles, extra bundles, nonreceipt of cash letters, and missent cash letters. Also, a TOLL FREE number, (800) 442-7278, has been installed in our Adjustment Division for Texas banks outside of Dallas to utilize when reporting all other check processing discrepancies. Banks in the Dallas area should continue to place calls direct, and banks in Louisiana and Oklahoma should call TOLL FREE to the main bank number (800) 527-9200. These steps were taken to improve telephone service relating to check processing discrepancies.

To help provide better service on large dollar amount adjustments, please refrain from calling unless discrepancies are for \$250 or more. Discrepancies for lesser amounts will continue to be handled by correspondence. Banks should continue timely reporting of discrepancies located in proving our cash letters, such as encoding errors, missing items, etc., on form TR-418, Return Items and Adjustments.

For convenient reference, two Telephone Information Cards are enclosed which provide telephone numbers to use when reporting check processing discrepancies. For best results in utilizing the attached cards, they should be kept near the telephone as a convenient reference to your bank's check processing personnel.
